Never investigated. Claims put in by Arthur Willis and G. Graham, derivative Claimants from Cornack. Mr. Graham made a survey of 12,100 acres at Piako, but it was rejected, because it contained only Crown Land, and Webster's Claim. Afterwards he made another survey of 30,350 acres, but the greater part was disallowed. The Claims at Waipa and Waikato have not been investigated.

Compensation of £897 granted upon arbitration, 12th November, 1851.

Never investigated. Investigation not yet made.

Disallowed. Lapsed.

Lapsed. Claim preferred by R. Dacre in connection with 408A and 408B, Section No. 980 and 981 *post*.

Compensation awarded by first Commissioners. Governor Fitzroy awarded a Grant for 1448 acres in addition to the Scrip issued in 77B, but Grant never issued. Scrip awarded for £514, the land having been originally reserved by the Crown, and sold in the Waikato Township.

Scrip issued by Governor Fitzroy for £2,560.

Grant issued for 320 acres, 24th June, 1844. Grant called in and cancelled. New Grant issued 10th February, 1862, for 466 acres. N.B. The settlement of this Claim was the means of getting the Mangatete Block for the Crown.

general meeting of the various tribes concerned in the Mangakahia land (the chiefs on both sides being Matiu and Tirarau) and an agreement between all parties as to the boundaries of the claim, a survey was commenced under Matiu's direction, but was stopped by a peremptory message from Tirarau. The Chief Land Purchase Commissioner and I, seeing that a risk would be run by allowing the survey to proceed, directed it to be stopped. A special case was then laid before the Governor by me, and an award of 2,560 acres made, to be selected by Mr. Baker when the Native disputes should be settled between the contending chiefs.
