#### No. 1.

The Superintendent of Auckland to the Hon. Colonial Secretary.

Superintendent's Office, SIR,-Auckland, 19th June, 1872. My attention has just been called to the fact that the Under-Secretary for Gold Fields has been ordering reports, returns, &c., to a very considerable extent, to be made direct to him by the officers on the Gold Fields. Permit me to direct your attention to the inconvenience which arises from this course. I order a report from one officer; a similar report is ordered, without my knowledge, from another officer, involving double labour. Masses of returns are ordered, which interfere materially with the performance of their duties by officers already fully employed; which returns could be obtained by me through officers whose duties would not be interfered with. Other inconveniences will, no doubt, suggest themselves to your own mind. I would, therefore, respectfully request that all instructions to Gold Fields officers be sent through me, so long as I have the honor to hold the delegated powers of administration of Gold Fields.

#### No. 2.

The Hon. Colonial Secretary to the Superintendent of Auckland.

Colonial Secretary's Office, SIR, I have to acknowledge the receipt of your Honor's letter, of the 19th ultimo, calling attention to the inconvenience which may arise from the supply by Wardens of Gold Fields, of returns direct to the Under-Secretary for Public Works in Gold Fields; and, in reply, to state that it has always been usual in case of information required respecting the Gold Fields by the Wellington, 8th July, 1872. Houses of Assembly, for the Government, through an Under-Secretary, to give instructions direct to the Wardens to supply it. This course has been followed in the instance to which you have referred, and whilst I regret any inconvenience which it may have occasionally caused, I believe that the general result has been to obviate the delay and misapprehension which commonly attend the demand and supply through circuitous channels of statistical information.

Upon enquiry I learn that the only return which may be considered at all laborious, is the list of mining Companies, and this return was required by a Circular to Wardens, dated so far back as 15th February, 1870, to be furnished in obedience to an order of the House of Representatives. I am not aware that any return called for had been previously furnished to your Honor, or to the Provincial Council; but, if so, it would be easy for the Warden to send a copy thereof, if printed, and if not printed to ask, if necessary, authority to engage clerical aid for copying it. I shall be ready, however, if you wish it, whenever a Warden is called on to furnish any special return, to inform

### Enclosure in Circular A.

ORDER of the House of Representatives, dated 3rd August, 1869.

That it is desirable that the Government should cause to be laid upon the table of this House, during each session, a Report embodying a general account of the present condition of the Gold Fields of the Colony, their advancement or otherwise during the preceding year, and their probable prospects; together with particulars showing the average price of provisions during the year on each Gold Field, the rate of wages, estimated population, and such other information as would afford a comprehensive idea of the general condition of the mining interest in the Colony; and that His Excellency be requested to forward a copy of such Report to Her Majesty's Secretary of State for the Colonies.

#### No. 7.

CIRCULAR to RESIDENT MAGISTRATES.

Colonial Secretary's Office (Judicial Branch),

Wellington, 15th February, 1870.

The House of Representatives having ordered "that there be laid on the table a return of the number of Mining Companies incorporated under the provisions of the 'Mining Companies Limited Liability Act, 1865,' in the various Provinces of New Zealand, and also the number of shareholders in the said Companies," I have the honor to request you to be good enough to furnish me with the required information for your district, up to the 31st March next.
