# REPORT OF REPRESENTATION COMMISSION.

Presented to both Houses in pursuance of Section 5 of "The Representation Act, 1887."

To His Excellency the Right Honourable William Hillier, Earl of Onslow, of Onslow in the County of Salop; Viscount Cranley, of Cranley in the County of Surrey; Baron Onslow, of Onslow in the County of Salop, and of West Clandon in the County of Surrey; Baron Cranley, of Imbercourt; Baronet; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same.

MAY IT PLEASE YOUR EXCELLENCY,-

We the undersigned, appointed by a Commission bearing date the 8th day of June, 1887, issued under the hand of the Governor, and sealed with the seal of the colony, for the purpose of "The Representation Act, 1887," having received from the Registrar-General a report of the results of the periodical census of the colony, taken on the 5th day of April, 1891, have, in accordance with clause 3 of the above-named Act, redivided the colony into electoral districts for the apportionment of the representation of the people of New Zealand in the House of Representatives, and respectfully submit for your Excellency's consideration the following report of our proceedings:—

The report of the Registrar-General contained a statement showing the population of each

present electoral district, and printed tables showing the population of the several boroughs, town districts, counties, and ridings, and was received by the Commission on the 25th day of September, 1891. The total population of the colony was 626,658, of which 228,127 were comprised in thirty-five boroughs and one town district, each containing a population of over 2;000. Excluding the residents of the Chatham and the Kermadec Islands—numbering 290 persons—there remained residents of the Chatham and the Kermades Islands—numbering 290 persons—there remained 398,241 as country population, to which 28 per cent. having been added, the total nominal population for the purposes of the Representation Acts became 738,165. Dividing this number by 70, we obtained 10,545 as "the quota," which represents, in country districts, an actual population of 8,240. The maximum number therefore to be included in any electoral district is 11,295 nominal, or 8,825 actual population. The minimum numbers are 9,795 and 7,653 respectively. 'In a city district

the quota is 31,635, with a margin of 100 over or under that number.

The census showed that the increase of population since the year 1886 had been greater in the North than in the South Island. The nominal population of the former was found to be 330,052, and that of the latter 407,823, entitling the first to 31 members, and the other to 39.

This is taking one member from the South to add to the North Island.

The descriptions of the proposed boundaries were published in the Government Gazette of the 14th October, and plans showing the several districts were circulated throughout the colony, and notice was given that objections to the new electorates would be received up to the 16th November inclusive. The Commission reassembled on that day, and found that thirty-seven communications had been sent in from different parts of the colony. About one-third of these were merely proposals for changes in the names of the electorates, which were in many cases agreed to, the remainder contained suggestions for certain alterations of boundaries, some of which were adopted; but several, when considered in relation to the adjoining districts, proved either to be impracticable, or would have been objectionable to other and larger bodies of electors.

Authenticated maps and descriptions of the boundaries of the electoral districts, together with a schedule showing the objections that have been raised to the preliminary divisions proposed by the

Commission, accompany this report.

# NORTH ISLAND ELECTORAL DISTRICTS.

# Bay of Islands.

This district is bounded towards the north-east generally by the ocean from the North Cape to Helena Bay; thence towards the south-east generally by Township Reserve and Sections Nos. 2 and 1, Block I., Opuawhanga Survey District, to the north-western corner of the latter section; thence by

the Whakapara River to the confluence of the last-mentioned river with the Wairua River; thence by the said Wairua River to its confluence with the Wairoa River; and thence by the said Wairoa River to Section No. 8, Block V., Tokatoka Survey District; thence by the said Section No. 8, the crossing of a road, by Section No. 22, the crossing of a road, by Sections Nos. 39 and 47, all of the said Block V., to the road at the south-eastern boundary of the last-mentioned section; thence by the road fronting Sections Nos. 106, 107, 119, and Section No. 95 of the said Block V., and through Section No. 95 of the said Block V., and through Section No. 94, Block V., Kopuru Survey District, and along the north-western boundary-line of Section No. 93; thence by a right line through the production of the north-western boundary-line of the said Section No. 93 to the ocean; towards the south-west by the ocean; and towards the north by the ocean: including Cavalli and all adjacent islands.

#### Marsden.

This district is bounded towards the north-east generally by the ocean from the northernmost corner of a township reserve, situate at Helena Bay, in Block I., Opuawhanga Survey District, to the north-eastern corner of Section No. 91, Parish of Waipu, Mangawai Survey District, at Bream Tail; thence towards the south-east by the south-eastern boundary-line of that section to its south-eastern corner; thence towards the south by a right line to the Kapawhiti Range at the point where the road from Mangawai to McKenzie's Cove crosses it; thence by a right line to Trig. Station H., Mangawai Survey District; thence by a right line to Trig. Station B., Waipu Survey District; thence by Section No. 235, Block XII., of the said Waipu Survey District, and the Marunui Block to the Piroa Stream; thence towards the south-west generally by the left bank of the said Piroa Stream to the north-eastern boundary-line of Section No. 137, Parish of Wairau; thence by that section and Section No. 136 to the Great North Road; thence by the south side of that road to the north-western boundary-line of Section No. 105, Parish of Wairau; thence again towards the south-east generally by the said Section No. 105, and Sections Nos. 106 and 100, and the north-western boundary-line of the last-mentioned section produced across the road which forms the north-eastern boundary of Section No. 152, Parish of Paparoa; thence by that road and its continuation to the south-eastern boundary-line of Section No. 151, Parish of Paparoa; thence by that boundary-line to the road at the northern boundary of Section No. 91, Parish of Wairau; thence by that road and by the said Section No. 91, and by Section No. 93, the crossing of a road, by Sections Nos. 78, 79, and 80, Parish of Wairau, the crossing of a road, and by Section No. 84, Parish of Wairau, to its western corner; thence by the Pahi River, the Arapaoa River, and the Otamatea River respectively to the Wairoa River; thence again towards the south-west by the said Wairoa River to a point in line with the northern boundary-line of Nos. 106 and 100, and the north-western boundary-line of the thence again towards the south-west by the said Wairoa River to a point in line with the northern boundary-line of Te Kuri Parish; thence again towards the south-east by a right line across the said Wairoa River to the northernmost corner of the said Te Kuri Parish; thence again towards the north-east by the Wairoa River aforesaid to the Kaipara Entrance; thence again towards the south by the said Kaipara Entrance; thence again towards the south was the said Kaipara Entrance. para Entrance; again towards the south-west by the ocean; and towards the north-west by the Bay of Islands Electoral District, hereinbefore described, to Helena Bay, the place of commencement: including Mokohinau Lighthouse.

# Waitemata.

This district is bounded towords the north-west and north generally by the Marsden Electoral District, hereinbefore described, from the Kaipara Entrance on the west coast to Bream Tail; thence towards the north-east and east generally by the ocean to the Okura River; thence towards the south-east by that river to the road at the eastern boundary of Section No. 56, Parish of Okura; thence towards the south-west by the crossing of a road, by the said Section No. 56, and Sections Nos. 55, 54, 53, 52, and 80 of the said Parish of Okura; thence again towards the east generally by the last-mentioned section and Sections Nos. 79 and 78 of the Parish of Okura aforesaid, and by the east side of the road which forms the eastern boundaries of Sections Nos. 325, 210, and 212, Parish of Pukeatua, to the road which forms the northern boundary of Section Nos. 292 of the last-named parish; thence by the north side of that road to a point in line with the by the north side of that road to a point in line with the south-western boundary-line of Section No. 3, Parish of Okura; thence by a right line to the north-western corner of that section; thence by the said Section No. 3 and Section No. 304, the crossing of a road, and by Section No. 305, and the road which forms the eastern boundaries of Sections Nos. 301, 300, and 299, Parish of Pukeatu, to Lucas's Creek; thence by Lucas's Creek to the Waitemata River, at the to the north-western corner of the latter section; thence by southernmost point of Section No. 125, Parish of Paremothe boundary-line between Native land and Crown land (the said boundary-line being part of the north-west boundary-line of Whangarei County) to the Taparahaia River; thence by the said Taparahaia River, the Kaimamaku River, and due south to the mainland; thence by the Waitemata Harbour and the Whau Estuary to Section No. 90, Parish of Waikomiti; thence by the said Section No. 90 to the Oratia Stream; thence by that stream to a point in line with the northern side of William Street, in the Township of Henderson; thence by a right line to the northern side of the said William Street; and thence by that street to the Helensville Railway-line; thence again towards the south-west and west by the said Helensville Railway-line to the eastern portion of the Taupaki Block; thence again towards the south-east generally by the southern boundary of the said eastern portion of the Taupaki Block and the southern boundary of the western portion of the said Taupaki Block to the ocean; thence again towards the south-west by the ocean; towards the north by the Kaipara Entrance; and again towards the north-east and west by the Kaipara River and the Wairoa River to the place of commencement: including the Islands of Great and Little Barrier, Kawau, Motuhora, and Tiritiri, and other islands adjacent thereto.

#### Eden

This district is bounded towards the north and north-west generally by the Waitemata Electoral District, hereinbefore described, from the southernmost corner of the western portion of the Taupaki Block, on the west coast, to the mouth of the Okura River, on the east coast; thence towards the north-east by the Hauraki Gulf to the North Head of Waitemata Harbour; thence towards the south by Waitemata Harbour to the Victoria Wharf at Devonport; thence towards the south-east yretoria whan at Devonport; thence towards the south-east by a right line across the said Waitemata Harbour to the north-eastern corner of the City of Auckland; thence again towards the south generally by lines 1800, 1059, 1171, 852, 758, 250, 82, 1735, 4800, 270, 700, 1225, 300, and 50 links to the original high-water mark of Freeman's Bay, at the middle of Franklin Street, City of Auckland (the said lines being the northern boundary-lines of the said City of Auckland), and by the southern shore of the Waitemata Harbour to Motion's Creek; thence again towards the north-east generally by the right bank of Motion's Creek to the north-western boundarythe net No. 12 of the said Allotment No. 12 to the north-western boundary-line of Allotment No. 12 of the said Section No. 9; thence by the said Allotment No. 12 to the north-rest corner of Allotment No. 17 of the said Section No. 9; thence by the north-eastern boundary-line of the last-mentioned allotment and by that boundary-line produced to the south-eastern side of the Old Great North Road; thence again towards the north generally by the Old Great North Road to its junction with Cracroft Street, Arch Hill; thence again towards the north-east by the said Cracroft Street to Niger Street; thence again towards the south-east by Niger Street to Alexander Street, Eden Terrace; thence again towards the north-east by the said Alexander Street to Aitken Terrace; thence by a right line across Aitken Terrace; thence again towards the north-west by Aitken Terrace aforesaid to Greenwood Street; thence again towards the north-east by the said Greenwood Street to the New North Road; thence again towards the south-east by the said New North Road to Mount Roskill Road, and by Mount Roskill Road to the Main North Railway-line; thence by the Main North Railway-line to Kingsland Road; thence by Kingsland Road to Mount Albert Road; thence again towards the north-east by the said Mount Albert Road to a point in line with the eastern boundary-line of original Allotment No. 3 of Section No. 13 of the Suburbs of Auckland; thence towards the east by a right line to the said boundary-line; thence by the eastern boundary-line of the said Allotment No. 3 and the eastern boundary-line of Allotment No. 2 of the said Section No. 13 to Manakau Harbour; thence again towards the south and south-east generally by the said Manukau Harbour to the ocean; and again towards the south-west by the ocean to the place of commencement.

# City of Auckland.

This district is bounded towards the north-west and northeast generally by the Eden Electoral District, hereinbefore described, from Motion's Creek to the north-eastern corner of the City of Auckland; thence towards the south-east generally by a line, 1500 links, to The Strand; thence by The Strand, 50 links; thence to and by Suburban Section No. 96; thence by a line at right angles to the western boundary-line of that section to and along the east side of Stanley Street to the Government Domain; thence by the said Government Domain and the Hospital Reserve to the road known as Park Road; thence by the northern side of the said Park Road to a point in line with the eastern boundary-line of Allotment No. 22 of Section No. 3 of the Suburbs of Auckland; thence by a right line to, and thence by the said eastern boundary-line and its production to, the south side of Carleton Gore Road; thence by the south side of that road to the western boundary-line of Subdivisional Lot No. 37 of original Allotment No. 4 of Section No. 3 of the Suburbs of Auckland; thence by the said Lot No. 37, and by Lots Nos. 55, 56, 65, 66, 75, 76, 85, 86, 95, 96, 105, 106,

115, 116, and 13, all of original Allotment No. 4 of the said Section No. 3, and by the western boundary-line of the said Lot No. 13 produced to the southern side of the Kyber Pass Road; thence by that road to the eastern side of the road eading to the Mount Eden Stockade; thence by the eastern side of the last-mentioned road to the Main North Railway-line; thence towards the south-east and south by the said Main North Railway-line to Shaddock Street, Eden Terrace; thence again towards the north-west by Shaddock Street to Mount Eden Road, at the easternmost corner of Allotment No. 2 of Section No. 10, Suburbs of Auckland; thence again towards the south-west by the said Section No. 2 to its northernmost corner; thence by a right line across the New North Road to the north side of Basque Road at its intersection with the said New North Road; thence by the said Basque Road and by original Allotments Nos. 1, 3, and 4 of Section No. 5, Suburbs of Auckland; thence again towards the south-east by the last-mentioned allotment and original Allotments Nos. 7, 8, and 9 of the said Section No. 5 to Niger Street, Arch Hill; thence again towards the south generally by the Eden Electoral District aforesaid to the place of commencement.

#### Parnell.

This district is bounded towards the north generally by the Waitemata Harbour, from the easternmost corner of the City of Auckland to Resolution Point; towards the east generally by Hobson Bay to Slaughterhouse Creek; thence towards the south-west generally by Slaughterhouse Creek to the Grammar-school Road; thence by that road to Manukau Road; thence towards the south-east by the south-eastern side of the said Manukau Road to the westernmost corner of Allotment No. 20 of Section No. 4, Suburbs of Auckland; thence towards the north-east by the said Allotment No. 20 and Allotments Nos. 18 and 19 of the said Section No. 4 to Slaughterhouse Creek; thence again towards the south-east by the said Slaughterhouse Creek to the south-eastern corner of Allotment No. 23 of the said Section No. 4; thence towards the south generally by the southern boundary-line of the said Allotment No. 23 to the north-eastern corner of the Public Hall site; thence by the eastern and southern boundary-lines of that site to Epsom Road; thence again towards the east by the eastern side of that road to a point in line with the northern boundary-line of Allotment No. 23A (educational endowment), opposite the Junction Hotel; thence again towards the south-west by a right line to the north-eastern corner of the said Allotment No. 23A; thence by that allotment to Gillies Avenue; thence again towards the south-east by the eastern side of the said Gillies Avenue to a point in line with the northern side of Owen's Road; thence by a right line across Gillies Avenue aforesaid to the said Owen's Road; and thence by that road to the south-eastern corner of Subdivision No. 1 of Allotment No. 57; thence again towards the south by the southern boundary-line of the said Subdivision No. 1 to original Allotment No. 11 of Section No. 10, Suburbs of Auckland; thence again towards the south-west by the said Allotment No. 11 again towards the south-west by the said Allotment No. 11 to Oaklands Road; thence again towards the south by that road to Mount Eden Road; thence by a line across the latter road to Valley Road; thence again towards the south-west generally by the said Valley Road to Mount Roskill Road; thence towards the west by the said Mount Roskill Road; thence towards the west by the said Mount Roskill Road to the road which forms the south-western boundary of Subdivision No. 8 of Allotment No. 11 of Section No. 10, Suburbs of Auckland; thence again towards the south-west by the last-mentioned road to Subdivision No. 7 of the said Allotment No. 11: thence again towards the west generally by the last-mentioned road to Subdivision No. 7 of the said Allotment No. 11; thence again towards the west generally by the said Subdivision No. 7 and Subdivisions Nos. 141, 142, and 143 to George Street West; thence by a right line across that street to the south-eastern corner of Subdivision No. 68 of the said Allotment No. 11; thence by the said Subdivision No. 68 and Subdivision No. 78 to Norman Street; thence by a right line across that street to the south-eastern corner of Subdivision No. 79 of the said Allotment No. 11; thence by the said Subdivision No. 79 and Subdivision No. 85 to Charles Street; thence by a right line across the said Charles Street to the south-western corner of Subdivision No. 19 of the said Allotment No. 11; and thence by the western boundary-line of the last-mentioned subdivision, and the western boundary-lines of Subdivisions Nos. 18, 17, 16, 15, 14, 13, and 12 of the said Allotment No. 11, and the western boundaryline of the last-mentioned subdivision produced to the Main North Railway-line; thence again towards the north-west and south-west generally by the Eden Electoral District, hereinbefore described; and again towards the north and north-west by the City of Auckland Electoral District, hereinbefore described, to the place of commencement.

### Manukau.

This district is bounded towards the north generally by Hobson Bay, Waitemata Harbour, and the Hauraki Gulf respectively; towards the east generally by the Tamaki River to Otahuhu Creek; thence by that creek to Portage Road; thence towards the south generally by the said Port-

age Road to Manukau Harbour; thence by the said Manukau Harbour to the Eden Electoral District, hereinbefore described; thence towards the south-west and north-west generally by the said Eden Electoral District; and again towards the north and the north-west generally by the Parnell Electoral District, hereinbefore described.

#### Franklin.

This district is bounded towards the north-west generally by Manukau Entrance, Manukau Harbour, and by the Manukau Electoral District, hereinbefore described; towards the north generally by the Hauraki Gulf; towards the south-east generally by the south-western boundary-lines of the Papepape and Kiripaki Blocks; thence by the south-eastern boundary-line of Section No. 46, Parish of Maraetai; thence by the south-western boundary-line of that section to Section No. 72 of the said parish; thence by the south-eastern boundary-line of the said Section No. 72 and the south-eastern boundary-lines of Sections Nos. 71, 64, 61, and 63, the crossing of a road, and the south-eastern boundary-lines of Sections Nos. 68 and 66 of the said parish to Section No. 47; thence by Sections Nos. 48, 57, and 77, and Sections Nos. 26, 41, and 27 of Wairoa Parish to the westernmost corner of the last-mentioned section; thence by Sections Nos. 58 and 65, Papakura Parish, to the road intersecting the said Section No. 65; thence by that road and the road intersecting Sections Nos. 62 and 37 and by the road which forms the north-western boundaries of Sections Nos. 36, 19, 18, 17, 16, 15, 14, 13, and 12, all of Papakura Parish, to the Great South Road near Manurewa Railway-station; thence towards the east generally by the eastern side of the Great South Road to the road which forms the north-western boundary of Allotment No. 13 of the Town of Papakura; thence by the south-eastern side of that road and its continuation to the south-eastern side of that road and its continuation to the road which forms the south-western boundary of Allotment No. 12 of the said Town of Papakura; thence by the north side of the last-mentioned road to the road which forms the western boundaries of Allotments Nos. 2, 1, 18, 17, 16, 15, and 14 of Section No. 6, Town of Papakura, and by the eastern side of that road to Pahurehure Estuary; thence by the eastern shores of that estuary and the right bank of the Hingaia Creek and the right bank of Slippery Creek to the Great South Road; thence by the said Great South Road to the southern boundary-line of Section No. 51, Parish of Opaheke; thence by the southern boundary-line of that section to the southern boundary-line of Section No. 51, Farish of Opaneke; thence by the southern boundary-line of that section to the south-western boundary-line of Section No. 1, Parish of Maunga-tawhiri; thence by that section and Sections Nos. 2, 3, 4, and 6, the crossing of a road, Sections Nos. 29 and 30, the crossing of a road, and Section Nos. 38, 41, and 40, the crossing of a road, and Section No. 10, the crossing of a road, Sections Nos. 67, 66, and 65, and the presture boundary line of the last mentioned section was western boundary-line of the last-mentioned section produced to the left bank of the Waikato River; towards the south and again towards the south-east generally by the left bank of the said Waikato River to the ocean; and towards the west by the ocean to Manukau Entrance, the place of commencement: including the islands of Waiheke, Motutapu, Ponui, Rakino, Rangitoto, and adjacent islands, and islands in Manukau Harbour.

# Waipa.

This district is bounded towards the north-west generally by the Franklin Electoral District, hereinbefore described, from the mouth of the Waikato River to the Hauraki Gulf; towards the north by the said Hauraki Gulf; towards the north by the said Hauraki Gulf; towards the east by the Frith of Thames to Pukorokoro; thence towards the south-east by the high road and telegraph-line from Pukorokoro to Mercer to the Maramarua Stream; thence by that stream to its confluence with the Waikato River; thence again towards the east and towards the north-east by the said Waikato River to the Waikato confiscation boundary line; thence again towards the south-east by that boundary-line to the Puniu River; thence again towards the east generally by the said Puniu River to its source near Ranginui Trig. Station; thence by a right line to the said trig. station; thence by a right line to the source of the Mokau River; thence towards the south generally by the said Mokau River to its intersection by the parallel of 38° 30′ south latitude; and thence by the said parallel of 38° 30′ to the ocean; and towards the west by the ocean to the place of commencement.

# Waik ato.

This district is bounded towards the north-west by the Waipa Electoral District, hereinbefore described, from the confluence of the Maramarua Stream with the Waikato River to the Frith of Thames; towards the north by the said Frith of Thames to the mouth of the Thames River; thence towards the north-east by the right bank of the said Thames River to a point due west of Te Aroha Trig. Station; thence again towards the north by a right line to the said trig. station; thence by a right line in the direction of the mouth of the Waihi Itiver on the east coast as far as the summit of

the range forming the western boundary of the Tauranga confiscated district; thence again towards the north-east by lines from hill to hill along the summit of the said range to the Whakamarama No. 2 Block; thence by that block, the Mangatctara Blocks Nos. 1a, 1, and 3 to Weraiti Trig. # Grey.

# Kaiapoi.
