"NAVAL AND MILITARY SETTLERS" AND VOLUNTEERS LAND ACT, 1892"

(RETURN RELATIVE TO DEALINGS WITH CLAIMS SENT INMUNDER).

Return to an Order of the House of Representatives dated the 13th day of September, 1893.

Ordered, "That there be laid before this House a nominal return, alphabetically arranged, of all claimants under "The Naval and Military Settlers' and Volunteers' Land Act, 1892," whose claims have not been favourably reported upon, the return to show opposite the name of each such claimant the reasons why each claim has not been favourably reported upon; also of all claimants whose claims have been favourably reported upon, the return to show opposite the name of each such claimant whether or not his claim has been finally approved, and whether or not the certificate has been issued in his favour.—(Mr. Palmer.)
