Extracts from the Journals of the House of Representatives

THURSDAY, THE 4TH DAY OF MARCH, 1943

Ordered, "That a Select Committee be appointed, consisting, by leave, of twelve members, to consider all matters in connection with defence which may be referred to it: the Committee to consist of Mr. Anderton, Mr. P. Carr, the Right Hon. Mr. Coates, Mr. Cullen, Mr. Dickie, Mr. Frost, Mr. Lee, Mr. Lowry, Mr. Osborne, Mr. Roy, Mr. Schramm, and the Mover."—(Right Hon. Mr. Fraser, for the Hon. Mr. Jones.)

FRIDAY, THE 5TH DAY OF MARCH, 1943

Ordered, "That all petitions not finally dealt with during the session of 1941-42 be again referred to the same Committees as they were referred to during the said session."—(Right Hon. Mr. FRASER.)

THURSDAY, THE 20TH DAY OF MAY, 1943

Ordered, "That Select Committees have leave to sit for the remainder of the session on days on which the House does not meet."—(Right Hon. Mr. Fraser.)

No. 2.—Petition of Edith M. Bailey, of Napier

Praying for the restoration of certain maintenance payments.
