ORDERS OF REFERENCE

Extracts from the Journals of the House of Representatives

WEDNESDAY, THE 18TH DAY OF JULY, 1945

Ordered, "That a Select Committee be appointed, consisting of ten members, to consider all matters relating to school-teachers, education, and public instruction generally, training of public-school teachers, higher education, technical education, manual instruction, and such other matters affecting education as may be referred to it: the Committee to consist of Mr. Algie, Mr. Atmore, Mr. Bodkin, the Rev. Clyde Carr, Mr. Combs, Mr. Doidge, Mr. McCombs, Mr. Oram, Mr. Petrie, and the Mover."—(Hon. Mr. MASON.)

Ordered, "That all petitions not finally dealt with during the session of 1944 be again referred to the same Committees as they were referred to during the said session."—(Hon. Mr. NASIL.)

WEDNESDAY, THE 14TH DAY OF NOVEMBER, 1945

Ordered, "That the New Zealand Council for Educational Research Bill be referred to the Education Committee."—(Hon. Mr. MASON.)

REPORTS

No. 118/1944.—Petition of J. E. LOWE, of Kaikohe, North Auckland

PRAYING for compensation on account of a disability allegedly contracted while in the employ of the Education Department.

I am directed to report that in the opinion of the Committee the petition should be referred to the Government for most favourable consideration.

That in the opinion of the Committee the Government should introduce regulations providing as follows:—

- (1) All teachers, nurses, and dental nurses appointed to Maori schools should, before entering upon employment, be medically examined and x-rayed.
- (2) That during the course of such employment should also be weighed, and, if necessary, x-rayed at intervals of one month.
- (3) Instructions in writing be issued to all such teachers and nurses as to the precautions necessary to safeguard them from infection, and to advance the health of pupils.

No. 14.—Petition of W. H. GOULD, of Victoria University, Wellington

PRAYING for the restitution of superannuation rights.

I am directed to report that in the opinion of the Committee the petition should be referred to the Government for most favourable consideration.

No. 52.—Petition of ALMA B. DAVIES, of Hamilton

PRAYING for compensation on account of termination of services as a teacher.

NEW ZEALAND COUNCIL FOR EDUCATIONAL RESEARCH BILL

I HAVE the honour to report that the Education Committee has carefully considered the New Zealand Council for Educational Research Bill, and recommends that it be allowed to proceed with amendments as shown on the copy attached hereto.

No. 92.—Petition of J. B. OLIPHANT, of Auckland, and 7 Others. No. 105.—Petition of R. E. SMITH, Accountant, of Christchurch, and 3 Others

PRAYING for academic recognition commensurate with their term of military service.

I have the honour to report that in the opinion of the Committee the petition should be referred to the Government for favourable consideration.

In submitting its report the Committee is fully alive to the following matters:—

Firstly, that the detailed requests of the petitioners, with one exception (No. 5), are matters for the University of New Zealand rather than the Government:

Secondly, that, in its handling of the cases of the members of our Forces, the University has shown a fine appreciation of the just and reasonable claims of the men, a proper regard for their real interests, and a correct interpretation of its duty to safeguard the interests of the people and to maintain the prestige of its own degrees:

Thirdly, that, in the circumstances, the Government would be reluctant to do more than express the view that, within such limits as the University regards as binding upon itself, it do its utmost to see that the members of our Forces are placed, as far as possible, in the position they might well have reached if they had not enlisted for active service.

The Committee expresses most strongly the hope that the Government urge the University, if possible, to provide two examinations a year for those students for the profession who by reason of their service overseas have lost time in the prosecution of their studies and who desire to qualify for admission to their professions as soon as is reasonably possible.

The Committee express the hope that the Government will accede to the prayer in paragraph 5 on page 3 of the petition and extend financial assistance by way of rehabilitation to cover the whole year in the case of those students who seek to pass University examinations and are not earning a sufficient wage.
