

*Auroa*, at Auroa, 168 acres. Acquired: October, 1948. Objective: One dairy and sheep unit for allotment July, 1950. Development Programme: 51 acres cultivation and new grass, 22 acres renovating existing grass, five gates, 90 chains internal fencing, repairs to 30 chains existing fencing, one implement-shed, renovate cow-shed, one well, pump-house, and six troughs.
