

*Moeraki*, at Hampden, 4,634 acres. Acquired: March, 1947. Objective: Twelve sheep units—five for allotment August, 1950, and seven for allotment May, 1951. Development Programme: 1,666 acres grass, 850 chains fences, 200 chains repairs to fences, eight dwellings, one wool-implement shed, nine barn-implement sheds, repairs to two dwellings, shift one dwelling, eleven water-supplies. Progress: 979 acres grass, 67 chains fences, 135 chains repairs to fences, five dwellings, one wool-implement shed, four barn-implement sheds, one water-supply installed. Eight ex-servicemen with promises of sections.

*Moyola*, at Heriot, 966 acres. Acquired: May, 1946. Objective: Two sheep units for allotment May, 1949. Development Programme: 188 acres grass, 70 chains fences, 60 chains repairs to fences, one barn-implement shed, conversion of house into two dwellings, repairs to men's hut. Progress: Completed. Two ex-servicemen on fixed charges from June, 1949.

*Papanui*, at Cape Saunders, 1,092 acres. Acquired: March, 1934. Objective: Four sheep units—one for allotment January, 1940, three for allotment May, 1946—after setting aside 33½ acres as reserve and school site. 199 acres to be retained pending decision on future utilization. Development Programme: Was fully developed prior to May, 1946. Progress: Two civilians on fixed charges—one from January, 1940, one from May, 1946. Two ex-servicemen on fixed charges from May, 1946. 199 acres apportioned between the above four settlers June, 1949.

*Rippleburn*, at Balclutha, 733 acres. Acquired: July, 1945. Objective: Two sheep units for allotment May, 1949. Development Programme: 266 acres grass, 80 chains fencing, one dwelling, one barn-implement shed, metal 20 chains access track. Progress: Completed. Two ex-servicemen on fixed charges from June, 1949.

*Silver Peak*, at Waikouaiti, 10,744 acres. Acquired: 10,584 acres April, 1948, and 160 acres March, 1950. Objective: Three sheep units for allotment May, 1950. Development Programme: 800 chains fences and repairs, two dwellings, one wool-shed, shearers' quarters, chaff-house. Progress: 34 chains fences, 120 chains repairs to fences, one chaff-house erected. Ex-serviceman manager and two ex-servicemen on wages with promises of sections.

*Spyllaw*, at Moa Flat, 7,389 acres. Acquired: 5,955 acres September, 1948, and 1,434 acres March, 1949. Objective: Five sheep units—four for allotment May, 1951, and one for allotment May, 1953. Development Programme: 700 acres grass, 860 chains fences, 760 chains repairs to fences, three dwellings, one wool-shed, shearers' quarters, four barn-implement sheds, repairs to one house, wool-shed, and stable, shift one dwelling on to block and renovate. Progress: 561 acres grass, 210 chains fences, two barn-implement sheds, one dwelling shifted on to block and renovated. Ex-serviceman manager with promise of section.

*Taipo Hill*, at Kakanui, 462 acres. Acquired: March, 1944. Objective: Two sheep units for allotment July, 1948. Development Programme: 175 acres grass, 176 chains fences, one dwelling one barn-implement shed, two water-supplies. Progress: Completed. Two ex-servicemen on fixed charges from August, 1948.

*Te Houka*, at Waiwera, 1,427 acres. Acquired: 1941. Objective: Two sheep units for allotment May, 1949. Development Programme: 253 acres grass, 400 chains repairs to fences, renovations to two houses, concrete tank. Progress: Completed. Two ex-servicemen on fixed charges from June, 1949.

*Thorndale*, at Edievale, 1,766 acres. Acquired: April, 1946. Objective: Three sheep units for allotment May, 1949. Development Programme: 224 acres grass, 50 chains fences, 600 chains repairs to fences, one wool-implement shed, shift and renovate one house, one house and stable treated for borer, 2,000 trees to be planted, and dip and yards rebuilt. Progress: With exception of wool-implement shed, development completed. Three ex-servicemen on fixed charges from June, 1949.

*Waihemo*, at Dunback, 11,860 acres. Acquired: March, 1949. Objective: Three sheep units for allotment July, 1950. Development Programme: 61 acres grass, 520 chains fences, 10 chains repairs to fences, two dwellings, one wool-shed, two barn-implement sheds, repairs to one dwelling and outbuildings, water-supply for one section. Progress: 61 acres grass, 45 chains fences, 10 chains repairs to fences, one dwelling renovated, water-supply installed. Ex-serviceman manager with promise of section.

*Waipori*, at Henley, 772 acres. Acquired: 441 acres acquired August, 1948, and 331 acres acquired May, 1949. Objective: Three dairy units—two for allotment July, 1952, and one for allotment July, 1953. Development Programme: 390 chains drains, 320 acres grass, 234 chains fences, 350 chains repairs to fences, two dwellings, three cow-sheds, three barn-implement sheds, one dwelling repaired, three water-supplies. Progress: 122 acres grass, 25 chains fences partly erected, 55 chains repairs to fences, two dwellings under construction, three cow-sheds, three barn-implement sheds, dwelling repaired, three water-supplies partially completed.

*Waitepeka*, at Balclutha, 1,829 acres. Acquired: March, 1949. Objective: Ten dairy and one sheep unit for allotment 1958–59. Development Programme: 1,420 acres draining, 880 acres clearing, 1,380 acres grass, 3,050 chains fences, 250 chains repairs to fences, ten dwellings, ten cow-sheds, ten barn-implement sheds, one wool-implement shed, repairs to one dwelling, water-supply. Progress: 130 acres grass, 50 chains fences, 100 chains repairs to fences, repairs to one dwelling.

*Waiwera*, at Waiwera, 1,763 acres. Acquired: 869 acres March, 1948, 605 acres June, 1948, and 281 acres December, 1948. Objective: Three sheep units for allotment March, 1951. Development Programme: 343 acres grass, 303 chains fences, 725 chains repairs to fences, one dwelling, one
