The fixed deposit of £163 3s. 5d., which matured on the 22nd December last (and is only available for the purchase of land), has been renewed for one year. During the year twenty-two farms were relet; of these, fifteen of moderate area were renewed by arbitration, under clause 244 of "The Land Act, 1892," to the old tenants who were satisfactory ones, and the remainder were let by public tender.
