ORDERS OF REFERENCE.

Extracts from the Journals of the House of Representatives. FRIDAY, THE 24TH DAY OF AUGUST, 1906.

Ordered, "That a Committee be appointed, consisting of ten members, to whom shall stand referred, after their first reading, all Bills affecting or in any way relating to the lands of the Crown or educational or other public reserves. The Committee shall have power to make such amendments therein as they think proper, and to report generally when necessary upon the principles and provisions of the Bill. The Committee to have power to call for persons, papers, and records; three to be a quorum. The Committee to consist of Mr. Bennet, Mr. Duncan, Mr. W. Fraser, Mr. Flatman, Mr. Hall, Mr. Jennings, Mr. Laurenson, Mr. Malcolm, Mr. Witty, and the mover."—(Hon. Mr. McNab.)

I am directed to report that the Committee recommends that the petition be forwarded to the Government for favourable consideration, and that the attention of the Government be drawn to the fact that cattle are now running in the domain.

No. 79.—Petition of T. E. T. GALE, of Palmerston North.

PETITIONER prays for compensation for loss of a certain sum of money.

I am directed to report that your Committee has given careful consideration to the above petition, has examined a large number of witnesses, and has come to the conclusion that Mr. Gale, the petitioner, was a simple-minded man who came to this country with the object of becoming a settler; and it appears from the evidence submitted that he obtained a sum of £691 from England for this purpose, and, further, that the evidence shows that £400 of this money was received from

him by the brothers Andrewartha on no security whatever, on a verbal assurance being given that they would recoup the money by work done on his allotment. From the evidence given, the work done on the section was inadequate to pay more than one-half of the sum lent—£200. That Mr. Gale then took legal proceedings to recover this balance, but, owing to the fact that he could be easily induced by counsel to make admissions, judgment was given with costs against him without the five witnesses who, we believe, might have established his case being called on to give evidence. The petitioner was afterwards imprisoned through failure to pay the other side's costs. The Committee is satisfied that advantage has been taken of the petitioner's simplicity, and that he has suffered much hardship thereby. The Committee has been unable to devise any means of relief, but recommends his case to the Government for consideration.
