Presented to the House of Representatives pursuant to "The Electoral Act, 1905."

REPORT OF THE NORTH ISLAND AND SOUTH ISLAND REPRESENTA. TION COMMISSIONS SITTING AS A JOINT COMMISSION.

To His Excellency the Right Honourable William Lee, Baron Plunket, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Governor and Commander-in-Chief in and over His Majesty's Colony of New Zealand and its Dependencies.

MAY IT PLEASE YOUR EXCELLENCY,-

We, the undersigned, appointed by Commission bearing date the 26th October, 1906, issued under the hand of Your Excellency and sealed under the seal of the colony, sitting as a Joint Commission for the purposes of "The Electoral Act, 1905," having received a report from the Registrar-General showing the results of a census of the population of the colony taken on the 29th day of April, 1906, proceeded to ascertain the quota of the population required for each electoral district of the colony as defined in the Act referred to above, and now respectfully submit for Your Excellency's consideration the results of our proceedings.

The report of the Registrar-General showing the total population of the colony was received and read by the Commission on the 15th day of November, 1906. From the said report it was ascertained that the total population of the colony amounted to 888,376 (exclusive of Maoris and the inhabitants of the Chatham and Kermadec Islands), distributed as follows: The population in forty-seven cities and boroughs of over two thousand inhabitants, including those on shipboard, amounted to 376,177, and the urban population within five miles limit of the Chief Post-offices of Auckland, Wellington, Christchurch, and Dunedin cities, exclusive of the population in cities and boroughs of over two thousand inhabitants within that limit, amounted to 47,895, a total urban population of 424,072, leaving a rural population of 464,304. Having added 28 per cent. to the latter figures, the total nominal population of the colony amounted to 1,018,381. This, divided by seventy-six, the total number of members, fixed the quota at 13,400.

It was further ascertained that the total actual population of the North Island amounted to 476,732, equivalent to a nominal population of 544,019. Likewise, it was ascertained that the total actual population of the South Island, including Stewart Island, was 411,644, equivalent to a nominal population of 474,362.

A consideration of these figures showed that the number of members to which the North Island was entitled was represented by the figures 40.6, and the South Island 35.4. As the fractional part was greater in the first case than in the second, the number of members for the North Island was fixed at 41, and that of the South Island at 35. This result added three members to the North Island, and reduced those of the South Island by a corresponding number.

The joint Commission having fulfilled the functions devolving upon it in terms of the above Act, resolved itself into the separate Commissions, which respectively proceeded to apportion and define the electoral districts for each Island.

[Extracts from the Minutes of the Proceedings of the Joint Representation Commission, dated the 15th November, 1906.]

PROTEST.

The members of the South Island Representation Commission enter their protest against the decision of the Joint Commission, carried by the casting-vote of the Chairman, on the following grounds: That by giving the North Island a representation of forty-one members there is a deficiency in nominal population of 5,500, and by giving the South Island a representation of only thirty-five members there will be 5,500 of the nominal population unrepresented; that we do not consider the division fair or equitable, and believe it to be neither in accordance with the spirit or intention of "The Electoral Act, 1905."

REJOINDER BY NORTH ISLAND COMMISSION.

That by giving the South Island a representation of thirty-six members there would be an increase in nominal population of that Island of 7,896, which would mean the allotment of forty members to the North Island, thereby leaving 7,896 of the nominal population of that Island unrepresented.

Note.—By the final adjustment of the figures of the population, the 5,500 and 7,896 mentioned in the above should be 5,373 and 8,027 respectively.—Thos. Humphries, Chairman, North Island Representation Commission.

REPORT.

To His Excellency the Right Honourable William Lee, Baron Plunket, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Governor and Commander-in-Chief in and over His Majesty's Colony of New Zealand and its Dependencies.

MAY IT PLEASE YOUR EXCELLENCY,—
We, the members of the North Island Representation Commission appointed by Your Excellency on the 26th day of October, 1906, have the honour to report that we commenced our sittings on the 16th day of November last for the purpose of dividing the North Island into electoral districts.

Notice of the boundaries as provisionally fixed by us under the authority of our Commission was duly published in the New Zealand Gazette, and the objections and suggestions that were received were duly considered and dealt with by the Commissioners in the manner set forth in the attached schedule. The Commission subsequently finally approved and confirmed the boundaries of the electoral districts, and now respectfully submit for Your Excellency's consideration the names and descriptions of the same, together with a map showing the actual and nominal populations respectively agreeing with the totals as allotted by the Joint Commission.

Attached is also a resolution by the Commission naming the particular electoral districts that are to be substituted for the three electoral districts in each of the Cities of Auckland and Wellington as constituted under "The City Single Electorates Act, 1903," for the purpose of section 4 of the said Act as to licensing districts.

NORTH ISLAND ELECTORAL DISTRICTS.

BAY OF ISLANDS.

This district also includes all wharves and extensions seaward.

AUCKLAND CENTRAL.

EDEN.

THAMES.

This district is bounded towards the north-east and east generally by the sea from Cape Colville to the mouth of the Otahu River; thence towards the south generally by the said Otahu River to a point due east of Trig. Station Pokohuku; thence by a right line to Trig. Station No. 94 in Block XIII, Karioi Survey District; thence by a right line to Matau (old pa) on the Pakoka Creek, and by that creek to the Aotea Harbour; thence by the said Aotea Harbour to the ocean: and towards the west by the ocean to Whaingaroa Harbour, the place of commencement.

TAURANGA.

Station Puketapu; thence by a right line to the most northerly point of

Wellington Suburbs.

This district is bounded towards the north generally by the Otaki Electoral District, hereinbefore described, from the sea at the south-western corner Wairere No. 1 Block to the north-western corner of Section No. 7, Block VIII, Belmont Survey District: thence towards the east generally by the Hutt Electoral District, hereinbefore described, to Port Nicholson; thence by Port Nicholson to the City of Wellington; thence by the Wellington North, Wellington Central, and Wellington South Electoral Districts, hereinbefore described, to the north-western corner of original Section No. 14, Block X, Port Nicholson Survey District: thence again towards the north generally by the said Wellington South Electoral District and the Wellington East Electoral District, hereinbefore described, to Evans Bay; thence by Evans Bay and Port Nicholson: and towards the south and west by the sea to the place of commencement.

SOUTH ISLAND REPRESENTATION COMMISSION.

REPORT.

To His Excellency the Governor of New Zealand, Government House, Wellington.

MAY IT PLEASE YOUR EXCELLENCY,-

We, the several members of the South Island Representation Commission, have the honour to report to Your Excellency that, in pursuance of Your Excellency's instructions, we met on the 15th day of November, 1906, and following days, when, in terms of "The Electoral Act, 1905," we divided the South Island of New Zealand, including Stewart Island, into thirty-five electoral districts, being the number allotted to it by the Joint Commission.

Following upon a notice published in pursuance of the 10th section of the said Act, several objections in writing to our proposed divisions of the said South Island were lodged and received. We met at Christchurch this day, and gave careful consideration to the objections referred to.

We now do ourselves the honour of attaching hereto, for Your Excellency's information, a description and plans of the several new electoral districts, with the names we have given thereto, such being and showing the "final determination" of Your Excellency's Commissioners, as provided by the 11th section of the above-mentioned Act.

We have the further honour of advising Your Excellency that in terms of "The City Single Electorates Act, 1903," section 4, we have resolved and decided that the Electoral Districts of Dunedin North, Dunedin West, and Dunedin Central, as now constituted by us, shall be and they are substituted for the present Electoral Districts of Dunedin North, Dunedin Central, and Dunedin South; again, we have resolved and decided, in terms of section 4 of the last-mentioned Act, that the Electoral Districts of Christchurch North, Christchurch East, and Christchurch South as now constituted by us shall be and they are substituted for the present Electoral Districts of Christchurch North, Christchurch South.

Given under our respective hands and seals, at the City of Christchurch, in the Colony of New Zealand, this seventeenth day of January, one thousand nine hundred and seven.

This district is bounded towards the north by the Dunedin Central Electoral District from the eastern boundary of Lower Kaikorai District to Otago Harbour; thence towards the northeast generally by the Chalmers Electoral District, hereinbefore described, to the south-eastern corner of Section No. 27, Tahuna Park; thence towards the south generally by the said Chalmers Electoral District to the sea at the southern end of Forbury Road, and thence by the sea to a point in line with the north-eastern boundary-line of Section No. 33, Ocean Beach District; thence towards the southwest by a right line to the south-eastern corner of the said Section No. 33; thence by Sections Nos. 33, 34, 35, 36, 40, 77, and 78, to Corstorphine Road, by Corstorphine Road and the road intersecting Section No. 1, Block XV, Dunedin and East Taieri Survey District, and intersecting Sections Nos. 36 and 39, Block VI, Town District, to the Main South Road; thence by the Main South Road to the south-eastern corner of Section No. 45 to the eastern boundary of Lower Kaikorai District, the place of commencement.

TAIERI.

This district is bounded towards the north-west generally by Tuapeka Electoral District, hereinafter described, from a point on the Waipori River due east of Trig. Station HH, in Block XV, Tuapeka East Survey District, to where the Cap Burn joins the Taieri River; thence towards the east generally by the said Tuapeka Electoral District and the Chalmers Electoral District, hereinbefore described, to Swampy Hill; thence by the Dunedin North, Dunedin West, Dunedin Central, and Dunedin South Electoral Districts to the sea; thence by the sea to the Akatore River; thence towards the south generally by the Akatore River and the road forming the northern boundary of the Akatore Survey District to the road forming the eastern boundary of Section No. 22, Block II, Akatore Survey District; thence by that road to the south-eastern corner of the said Section No. 22; thence by Sections Nos. 20, 2 of 19, 1 of 19, 18, 17, and 24, said Block II, and Section No. 73, Block VIII, Tokomairiro Survey District, to its northernmost corner; thence towards the south-west generally by Sections Nos. 6, 5, and 4, Block I, 9 and 16, Block II, 22, 23, and 24, Block III, Tokomairiro Survey District, Sections Nos. 12, 11, 10, 3, and 2, Block I, Waihola District, and Sections Nos. 34, 22, 36, 23, 24, 43, 25, 26, 45, 47, 1 of 1, and 33, Block I, Table Hill District, to the Tokomairiro River; thence by the Tokomairiro River to the northern boundary of Section No. 1, Block X, Table Hill District; thence by the said Section No. 1 and Sections Nos. 8, 7, 1, and 10, Block VIII, to Trig. Station G, at the north-western corner of the last-mentioned section; thence by the summit of the range to Waitahuna Hill; thence by Section No. 1, Block XII, Tuapeka East Survey District, and the north-eastern boundary-line of that section produced to the Waipori River; and thence by that river to the place of commencement.

BRUCE.

This district is bounded towards the north-west generally by the Tuapeka Electoral District, hereinafter described, from where the Blackcleugh Creek joins the Clutha River to the Waipori River; thence towards the north-cast by the Taieri Electoral District, hereinbefore described, to the sea; thence towards the south-east by the sea to the mouth of the Clutha River; thence towards the south-west by the Koau Branch of the Clutha River to the Borough of Balclutha; thence by that borough to the Clutha River; and thence by the Clutha River to the place of commencement.

TUAPEKA.

This district is bounded towards the north-east generally by the Waitaki Electoral District, hereinbefore described, from Mount St. Bathan's to the summit of the Horse Range at the road forming the north-western boundary of Section No. 2, Block V, Waihemo Survey District; thence towards the east generally by the Oamaru Electoral District, herein-

before described, to the north branch of the Waikouaiti thence towards the south generally by the said River; thence towards the south generally by the said north branch to Run No. 121g; thence by Runs Nos. 121g and 121H to Deighton Creek, by Deighton Creek to its confluence with Nenthorn Creek; thence by Nenthorn Creek to Section No. 8, Block VI, Budle Survey District; thence by Sections Nos. 8, 18, and 19, said Block VI, Sections Nos. 8 and 1, Block VII, Strath Taieri Survey District, and Section No. 2, Block VI, to the Taieri River; thence by the Taieri River to where it is joined by the Can Runn; thence by the River to where it is joined by the Cap Burn; thence by the Cap Burn to the western boundary of Run No. 205B; thence again towards the east generally by Runs Nos. 205B, 205H, 205D, 205E, and the summit of the range to Trig. H, Summit Rock (Rock and Pillar); thence by a right line to Soutra Hill; thence by the summit of the Lammermoor Ranges to the summit of the Lammerlaw Range; thence by the summit of the Lammerlaw Range; thence by the summit of the Lammerlaw Range to the source of the east branch of the Waipori River; thence by the said east branch to a point due east of Trig. Station HH, in Block XVI, Tuapeka East Survey District; thence towards the south generally by a right line to Trig. Station HH; thence by Gardiner's Track to Young's Creek or west branch of the Tuapeka Biron. thence by Gardiner's Track to Young's Creek or west branch of the Tuapeka River; thence by the said west branch of the Tuapeka River to where it is joined by Bowler's Creek; thence by Bowler's Creek to Section No. 48, Block III, Tuapeka West Survey District; thence by Sections Nos. 48, 49, 66, 57, 56, 68, 52, 53, 54, and 58, Block III, and Sections Nos. 1, 4, 13, 16, 17, Block II, Sections Nos. 11, 12, and 15, Block XII, and the production of the northern boundary of the lastmentioned section to the right bank of the Clutha River; thence by the Clutha River to the Blackeleugh Creek: thence thence by the Clutha River to the Blackcleugh Creek; thence by the said Blackcleugh Creek and the south-western boundary of Run No. 179 to the summit of the Tapanui Mountains; thence by part of the south-eastern boundary and by the southern boundary of Run No. 163A to the southernmost corner of Section No. 4, Block IX, Rankleburn Survey District; thence by the road fronting Sections Nos. 4 and 6, Block IX aforesaid, and fronting Section No. 19, Block IV, Glenkenich Survey District; thence by the southern boundary-lines of Sections Nos. 17 and 16, said Block IV, and by the road intersecting Sections Nos. 15, 12, 11, and 10, Block XIII, and fronting Section No. 3 to the Pomahaka River, across that river and by its western bank to the south-western corner of the Township of Kelso; thence by the western boundary of that township to the Pomahaka River, by the western bank of that river to the road on the northern boundary of Section No. 34, Block III, Greenvale Survey District; thence by the road fronting Sections Nos. 34, 23, 24, 35, 25, and 26, Block III aforesaid; and thence by Blocks II and I, Glenkenich Survey District, to the north-western corner of the latter block; thence towards the west by a right line running due north to the Leithen Burn; thence by the Leithen Burn and its courtborn branch to the graph of the survey of the Leithen Burn and its southern branch to the summit of the Umbrella Mountains; thence by the summit of the Umbrella Mountains over the Black Umbrella and Whitecoomb to the northern boundary of the Whitecoomb Survey District; thence by that survey district to Rocky Mount; thence by the summit of the Garvie Mountains and Carrick Range the summit of the Garvie Mountains and Carrick Range to Run No. 330A; thence by Runs Nos. 330A and 325A to the Clutha River, by the right bank of that river to a point due west of the confluence of Leaning Rock Creek with the Clutha River, by a line to that confluence, and by Leaning Rock Creek to its source; thence by a right line to the Leaning Rock; thence by the summit of the Dunstan Mountains to Cloudy Peak; thence by a line running south 45° east to the Lauder Creek; thence by Lauder Creek to its source, and by the summit of the Dunstan Mountains to Trig. G; and thence by a right line to Mount St. Bathan's, the place of commencement. commencement.

CLUTHA.

This district is bounded towards the north by the Tuapeka Electoral District, hereinbefore described, from the northwestern corner of Block I, Glenkenich Survey District, to the Clutha River, at the mouth of the Blackcleugh Creek; thence towards the north-east by the Bruce Electoral District, hereinbefore described, to the sea; thence towards the south-east and south by the sea to the mouth of the Mataura River; thence towards the west generally by the Mataura River; thence towards the west generally by the Mataura River to its confluence with the Mokoreta River; thence by the Mokoreta River to where the Oware Stream joins that river; thence by the Oware Stream to the road forming the northwestern boundary of Section No. 29, Block II, Wyndham Survey District; thence by that road and the road intersecting Sections Nos. 52, 53, 11, 54, of said Block II, 36 and 30, Block III, and 101, 65, 34, and 89, Block VII, Tuturau Survey District, to the Mimihau Stream; thence by the Mimihau Stream to a point in line with the eastern boundary of Section No. 16, Block X, Tuturau District; thence to the said eastern boundary and by Sections Nos. 16, 15, and 14 to the south-eastern corner of the last-mentioned

section; thence by the southern boundary of Block X aforesaid to its south-eastern corner; thence by Blocks X, IX, and VIII, and the eastern boundary of the last-mentioned block produced to the south-eastern corner of Block XII, Waikaka Survey District; thence by Blocks XII, V, and II, Waikaka Survey District, and Blocks II, VIII, and IX, Chatton Survey District, to the north-western corner of Block I, Glenkenich Survey District, the place of commencement.

WAKATIPU.

This district is bounded towards the north generally by the Westland Electoral District, hereinbefore described, from the sea at Big Bay to a point on the summit of the Southern Alps, near the source of the Hunter River; thence towards the east generally by the Waitaki, Tuapeka, and Clutha Electoral Districts, hereinbefore described, to the road at the southernmost corner of Section No. 2, Block VIII, Chatton Survey District; thence towards the south generally by the road running past the north of Maitland Village to Chatton Village, and by that road continued past the north of Chatton Village, and by that road continued past the north of Chatton Village to the Okapua Stream; thence by the Okapua Stream to the Mataura River; thence by the Mataura River to where the Otamita Stream joins that river; thence by the Otamita Stream to Section No. 267, Hokonui District; thence by Sections Nos. 267 and 449 to Section No. 798 (known as Small Grazing-run No. 21), Hokonui District; thence towards the south-west generally by Sections Nos. 798, 354, and 179 to Cowan's Creek; thence by Cowan's Creek to the road intersecting Section No. 178; thence by that road and its continuation through Sections Nos. 91, 108, and 92, and fronting Sections Nos. 121, 93, 28, 109, 110, 94, 27, 111, 95, 26, 96, 222, and 29 to the Oreti River; thence by the Oreti River to a point due west of Hummock Peak; thence by a right line to Hummock Peak; thence by a right line to Mount Lookup and the Thompson Mountains to a line drawn between Round Peak and Moffat Peak; thence towards the south by a right line to Montains to a point in line with the Castle Mountain and Cloudy Pass; thence again towards the south by a right line over the said Castle Mountain and Cloudy Pass to Bligh Sound; and thence by the said Bligh Sound to the ocean; and thence forommencement.

MATAURA.

This district is bounded towards the north by the Wakatipu Electoral District from Section No. 798, Hokonui Survey District, to the western boundary of Glenkenich Survey District; thence towards the east by the Clutha Electoral District to the sea, at the mouth of the Mataura River; thence towards the south by the sea to a point in line with the western boundary-line of Block XXIII, Invercargill Hundred; thence towards the west by a right line to the said western boundary-line of Block XXIII, by that boundary-line, and the road forming the western boundary of Block VII, and that road continued northward to the Mabel Bush Road in Section No. 2, Block XI, Invercargill Hundred; thence by the Mabel Bush Road to the north-western boundary of the said Block XI; thence by Blocks XI, XII, and XVIII, Invercargill Hundred; to the Makarewa River; thence by that river to the north-western corner of Section No. 190, Forest Hill Hundred; thence by a line running due east for a distance of 174 chains; thence by a line bearing north 45° east to the eastern boundary-line of Forest Hill Hundred; thence by Forest Hill Hundred; thence by Forest Hill Hundred; thence by Forest Hill Hundred;

(known as Small Grazing-run No. 21), Hokonui Survey District; and thence by the said Section No. 798 to the place of commencement.

WALLACE.

This district is bounded towards the north-east generally by the Wakatipu Electoral District, hereinbefore described, from the sea at Bligh Sound to Section No. 449, Hokonui Survey District; thence by the Mataura Electoral District, hereinbefore described, to the intersection of the northern boundary of Forest Hill Hundred by Lora Stream: thence towards the south by the northern boundary-line of Forest Hill Hundred, the northern boundary-line of Winton Hundred, and the northern boundary-line of Oreti Hundred to the road which forms the north-eastern boundary of Section No. 53, Oreti Hundred; thence by Section No. 63 and the road which forms the south-eastern boundary of Section No. 53, and that road continued through Section No. 62 of the said Oreti Hundred to the road which forms the western boundary of the said Section No. 62; thence by the eastern side of that road to Section No. 108: thence again towards the south by the said Section No. 108 and Sections Nos. 107 and 44 to the north-western corner of the lastmentioned section: thence again towards the east by the said Section No. 44 and Sections Nos. 43, 80, 86, 89, 90, 91, 94, 183, and 182, all of the said Oreti Hundred, to the south-western corner of the last-mentioned section: thence again towards the south by the New River Hundred to the Waimatuku Stream: thence again towards the east by the left bank of that stream to the ocean: and thence again towards the south and towards the west by the ocean to Bligh Sound aforesaid, at the Wakatipu Electoral District aforesaid; including Centre Island, Pig Island, Resolution Island, and adjacent islands.

INVERCARGILL.

This district is bounded towards the north generally by the Waihopai River from the New River Estuary to the northernmost corner of the Borough of Gladstone; thence by part of the eastern boundary and by the northern boundary of that borough to the north-western corner of the Borough of North Invercargill; and thence by the northern boundary of the said Borough of North Invercargill to its north-eastern corner; thence towards the east generally by the eastern and south-eastern boundaries of the Borough of North Invercargill; thence by the eastern and southern boundaries of the said Borough of East Invercargill to its south-western corner; thence by the eastern boundary of the Borough of Invercargill to the north-western corner of the Borough of Invercargill; and thence by the northern and eastern boundaries of the said Borough of South Invercargill to its south-eastern corner; thence towards the south-west generally by the south-western boundary of the said Borough of South Invercargill to New River Estuary; and thence towards the west by the New River Estuary to the place of commencement.

AWARUA.

This district is bounded towards the west and north by the Wallace Electoral District, hereinbefore described; towards the east generally by the Mataura Electoral District, hereinbefore described; and towards the south-west by Foveaux Strait to the Wallace Electoral District aforesaid, the place of commencement; exclusive of the Invercargill Electoral District, hereinbefore described, and including Stewart Island, Ruapuke Island, Dog Island, and all adjacent islands
