ANNUAL REPORTS OF DOMAIN BOARDS.

The Under-Secretary for Lands to the Hon, the Minister of Lands.

SIR,--

Department of Lands, Wellington, 7th August, 1908. I have the honour to transmit herewith a synopsis of the annual reports of Domain Boards for the year ended 31st December, 1907. The reports are furnished in compliance with the provisions of section 7 of "The Domain Boards Act, 1904."

Quite a number of these important reserves have now reached a high state of perfection, and it is evident that the large majority are being steadily improved and made more suitable for public

use and enjoyment.

The whole of the members of the various Domain Boards throughout the Dominion do not, however, as yet quite recognise their responsibilities under the Act in the matter of furnishing reports. Out of 440 Domain Boards 28 have failed to furnish the details required by law. No doubt, as the centres in which the domains are situated become more densely populated, the Boards will be encouraged in their work of popularising the several resorts, and will gladly see the results of their care and sacrifice of time and money embodied in the reports to be laid before Parliament. Par-

ticulars of the domains on which no reports have been received will be found on pages 39 and 40.

It may not be out of place to mention that the Auditor-General has called attention to the fact that a number of the Domain Boards are credited with considerable overdrafts at their banks, and that apparently they are paying interest upon such overdrafts out of current revenue, a practice which the Auditor-General considers is not strictly legal.

The photographs embodied in the report have been kindly furnished by the Domain Boards whose name is entered against them. The Department is glad at all times to receive photographs for reproduction in the annual report.

AUCKLAND LAND DISTRICT.

ARAWA PARK DOMAIN.

Section No. 23, Rotorua Rural Sections. Area, 46 acres 3 roods 17 perches.

Improvements now on domain: Fences, grandstand, and racing-track. An area is being ploughed, levelled, and sown down in grass for football grounds. Used for races and sports. Proposed operations for ensuing year: Renovating grandstand.

AUCKLAND DOMAIN.

Situated in Rangitoto Survey District. Area, 236 acres 1 rood.

Work done during year: General improvements and maintenance. Improvements now on domain: Extensive plantations, boundary-fences, iron fences, and stone wall surrounding the cricket-ground, pavilion, Park Superintendent's house, gardener's cottage, caretaker's lodge, and a propagating-house. Used for grazing, picnics, cricket, athletic purposes, and general recreation.

Avondale Domain.

Section No. 361, Waikomiti Parish. Area, 38 acres 2 roods.

No improvements effected during the year. Improvements now on domain: Boundary-fence (out of repair), plantation, and 6 acres in grass. Used for camping. Proposed operations for ensuing year: Erecting and repairing fences, and forming a track to the beach. The domain has been leased on improvement conditions.

AWHITU DOMAIN.

Section No. 58c, Awhitu Parish. Area, 8 acres 3 roods 30 perches.

Leased on improvement conditions. Improvements now on domain: Thirty-one chains fencing and grassing. Used for sports and picnics.

BIRKENHEAD DOMAIN.

Section No. 122, Takapuna Parish. Area, 112 acres 2 roods.

Six acres leased for grazing. Improvements now on domain: Fences and plantations.

BUFFALO DOMAIN.

Sections Nos. 31 and 32, Village of Buffalo. Area, 20 acres 1 rood 39 perches.

Work done during year: Eleagnus planted on Cemetery Road, and boundary and wire fence altered to give horses access to water. Improvements now on domain: Fences, eleagnus hedge, and gates. Used for general recreation. Proposed operations for ensuing year: Erecting wire and picket fences. The Board also proposes to drain the swamp on the domain.

CAMBRIDGE DOMAIN.

Sections Nos. 576, 359, 360, 361, 361A, 367, 581, 578, 579, 363, 363A, 364, 365, 366, 368, 370, Town of Cambridge East, and the Cambridge East Town Belt. Area, 484 acres 1 rood 7 perches.

Work done during year: Band-stand erected, noxious weeds eradicated, and general maintenance and improvements. A number of English Mallard wild-ducks presented to the Board have been liberated on the lake. Improvements now on domain: Band-stand, bowling-green, tenniscourts, pavilion, fences, trees, flower-beds, and conveniences. Used for bowls, tennis, band concerts, and general recreation; also used as a promenade. Proposed operations for ensuing year: Maintaining tennis-courts, planting native trees, ferns, and shrubs, and providing extra accommodation for the tennis club. Gas is being laid on to the band-stand, and it is the intention of the Board to erect two lamps on the northern and western walks of the Lake Reserve. During the year a fire from adjoining grounds spread into the domain, and a number of trees were destroyed.

CAMBRIDGE WEST DOMAIN.

Cambridge West Town Belt. Area, 333 acres 2 roods.

Work done during year: Trees planted, hedges trimmed, noxious weeds removed, fences repaired, and trees attended to. Improvements now on domain: Fences, ornamental and shelter trees, and 3 acres plantation. Used for sports, tennis, and cricket; a portion is leased for grazing. Proposed operations for ensuing year: Constructing concrete bath, planting trees, and general maintenance.

CASNELL ISLAND DOMAIN.

Section No. 196, Mahurangi Parish. Area, 16 acres 3 roods.

No improvements effected. Used for camping and picnics.

DEVONPORT DOMAIN.

Allotments Nos. 36, 37, and 39 of Section No. 2, and Mount Victoria Reserve, Takapuna Parish.

Area, 41 acres 2 roods 36 perches.

Work done during year: Cricket-pitches weeded, top-dressed, levelled, and rolled; ground cleaned up and rolled; tennis-ground, bowling-green, and croquet-lawns top-dressed and rolled, and novious weeds on Mount Victoria cut down and removed. Improvements now on domain: Fences, drains, sanitary arrangements, plantations, seats, and pavilions. Used for cricket, bowls, football, tennis, croquet, and hockey. From Mount Victoria a beautiful view of Auckland and its surroundings is obtained. The mount is used both as a pleasure and scenic resort. Proposed operations for ensuing year: Top-dressing and levelling cricket-ground, keeping grounds in order, and forming a footpath and dressing it with fine scoria and shell.

DRURY DOMAIN.

Allotment No. 85 of Section 8, Village of Drury. Area, 3 acres and 32 perches. Leased. Improvements now on domain: Fencing, clearing, and ploughing.

EAST TAMARI DOMAIN.

Sections Nos. 140 and 40, Pakuranga Parish. Area, 18 acres 1 rood 35 perches.

Work done during year: Noxious weeds eradicated, fences repaired, and an area ploughed and levelled in readiness for sowing down in grass. Improvements now on domain: Fences, plantations, and dam. Used for picnics; also for grazing. Proposed operations for ensuing year: Eradicating noxious weeds, planting shrubs and trees, ploughing, cultivating, and sowing down an area in grass, and repairing fences.

EASTERN MAHURANGI DOMAIN.

Section No. 176, Parish of Mahurangi. Area, 108 acres and 15 perches.

The domain comprises broken land, covered with tea-tree scrub. No improvements have been effected.

EPSOM AND MOUNT EDEN DOMAIN.

Part of Allotment No. 46, Allotment No. 49, and part of Allotment No. 48, of Section No. 6, Suburbs of Auckland. Area, 29 acres 3 roods 16 perches.

Leased.

GATE PA DOMAIN.

Sections Nos. 41, 41a, and 42, and part 13, Suburbs of Tauranga. Area, 11 acres 1 rood 37 perches.

Leased on improvement conditions. Well fenced. The domain is not used by the public.

Work done during year: Trees and hedges planted, wire fence and entrance-gates erected, and noxious weeds grubbed. Proposed operations for ensuing year: Eradicating noxious weeds and general improvements.

HELENSVILLE DOMAIN.

Section No. 10, Block XIV, Kaipara Survey District. Area, 38 acres 2 roods 21 perches.

Work done during year: New tanks procured and new baths placed in the bath-house and a drive to the bath-house formed. Improvements now on domain: Fences, bath-house, and drive. Used for bathing and as a pleasure resort. Proposed operations for ensuing year: Erecting a sanatorium, with baths, for invalids; constructing a swimming-bath; and generally beautifying the domain.

HOTEO DOMAIN.

Section No. 34B, Block XII, Pakiri Survey District. Area, 16 acres 1 rood 5 perches. No works yet undertaken. Board appointed 9th September, 1907.

HOWICK DOMAIN.

Suburban Sections Nos. 141 to 148, Town of Howick. Area, 8 acres.

Work done during year: Hedges trimmed, pavilion completed, urinal erected, tile drain extended, and small swing gate erected at main entrance in place of the large gate, which was removed to south-western corner. This corner has been fenced off for visitors' horses. Improvements now on domain: Thirty-six chains fencing, 67 chains drains, two pavilions, gates, tenniscourts, and conveniences. Used for picnics and athletic sports; also for sheep-grazing. Proposed operations for ensuing year: Completing tile drains, erecting swings, and levelling and improving the domain.

KAIWAKA DOMAIN.

Section No. 125, Kaiwaka Parish. Area, 6 acres 1 rood 13 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It contains some fine native bush, and is frequented by various kinds of water-birds. Occasionally visited by picnic parties. A grass-fire occurred in the domain during the year.

KATIKATI DOMAIN.

Sections Nos. 25 and 26, Katikati Parish. Area, 185 acres 2 roods.

Work done during year: Two bathing-sheds (one for women and children, the other for men) erected, and an area around the former fenced in as a protection against sharks, &c. Improvements now on domain: Fences, well, pump, gate, horse-trough, and trees. Used for regattas and as a camping-ground for visitors. Proposed operations for ensuing year: Enclosing men's bathing-shed, erecting a small landing-wharf, making a track to connect the main camping-ground with Brown's Bay, and forming a bowling-green.

KAURI DOMAIN.

Part of Lot 23 of Section No. 2, Block XI, Waipoua Survey District. Area, 41 acres 3 roods.

This domain is under the control of the Commissioner of Crown Lands, Auckland. Work done during year: Fences and gates repaired. Improvements now on domain: Fences and gates. Used for the preservation of the kauri-pine. Proposed operations for ensuing year: Sowing grass. A small fire occurred in the domain during the year, but little damage appears to have been done.

KAWAKAWA DOMAIN.

Section No. 47, Ruapekapeka Parish. Area, 14 acres 3 roods.

Leased on improvement conditions. Work done during year: Domain cleared of noxious weeds and laid down in grass. Improvements now on domain: Fences, plantations, and grassing. Used for grazing and sports. Proposed operations for ensuing year: Constructing concrete approach to gate, eradicating noxious weeds, and cultivating half the domain.

KIHIKIHI DOMAIN.

Sections Nos. 220 to 225, 228 to 241, and 359 to 380, Town of Kihikihi. Area, 42 acres.

Work done during year: Fences, gates, and grandstand repaired. Improvements now on domain: Fences, grandstand, and plantations. Used for football, cricket, polo, picnics, and sports. Proposed operations for ensuing year: Painting, repairing, and placing a floor in the grandstand.

KUAOTUNU DOMAIN.

Section No. 6, Block II, Otama Survey District. Area, 11 acres 3 roods 30 perches.

Work done during year: About $2\frac{1}{2}$ acres fenced, ploughed, harrowed, and sown with oats, and the remainder cleared of noxious weeds. Improvements now on domain: Fences, drains, trees, and levelling. Used for sports and football. Proposed operations for ensuing year: Improving the $2\frac{1}{2}$ acres for a sports ground, draining, and general improvements.

Kuirau Domain.

Section No. 3, Block LV, Town of Rotorua. Area, 12 acres 2 roods 37 perches.

This domain is under the control of the Tourist Department, and contains hot springs. Work done during year: Noxious weeds eradicated, and paths maintained.

LICHFIELD DOMAIN.

Section No. 26, Block XV, Patetere North Survey District. Area, 10 acres 3 roods 8 perches.

This area was brought under the provisions of "The Public Domains Act, 1881," on the 9th November, 1907. Steps are now being taken to appoint a Domain Board to have control of the domain.

MACKAYTOWN DOMAIN.

Sections Nos. 1 and 2, Block VII, Town of Mackaytown. Area, 15 acres 1 rood 14 perches.

Improvements now on domain: Fences and building. Used for football and sports. Proposed operations for ensuing year: Levelling and sowing grass.

MAHURANGI DOMAIN.

Section No. 96B, Mahurangi Parish. Area, 63 acres 3 roods 38 perches Used as a rifle range.

MAMAKU DOMAIN.

Sections Nos. 1 to 5, Block XIV; 1, Block XV; 1 to 5, Block XVII; and 3 to 7, Block XVIII, Village of Mamaku. Area, 25 acres 1 rood 18 perches.

Work done during year: Stumps and trees logged up, removed, and burnt, and the ground cleared and sown down in grass; dead trees removed; and the Mountain Rimu Timber Company's tramway fenced on both sides. Improvements now on domain: Fencing and grassing. Used for picnics and general recreation. Proposed operations for ensuing year: Erecting gates and seats, levelling and forming a recreation-ground, planting trees, and general maintenance.

A Domain Board was appointed to have control of this domain on the 7th October, 1907. No new works have yet been undertaken. Improvements now on domain: Forty chains fencing. Used for athletic sports, picnics, football, cricket, and tennis. Proposed operations for ensuing year: Sinking well, erecting pump, and planting trees.

MERCER DOMAIN.

Sections Nos. 136 and 139, Koheroa Parish. Area, 105 acres 2 roods.

Work done during year: Fences repaired. Improvements now on domain: Fences. Used for grazing, picnics, and athletic sports.

MOUNT ALBERT DOMAIN.

Part of Allotment No. 100, Titirangi Parish. Area, 12 acres 2 roods 12 perches.

Improvements now on domain: Fences, inner enclosure fenced, levelled, grassed, and planted with ornamental trees and shrubs and native trees; pavilion, flagstaff, and water-supply, including drinking-trough for cattle. Used for cricket, hockey, and other sports. Eleven acres leased for grazing.

MOUNT EDEN DOMAIN.

Allotments Nos. 1a of Section No. 6 and 68a of Section No. 10, Suburbs of Auckland. Area, 63 acres 2 roods 38 perches.

Work done during year: Fences erected and trees planted. Improvements now on domain: Fences and trees. Used for grazing and a public resort.

MOUNT WELLINGTON DOMAIN.

Part of Section No. 56, Waitemata Parish, and Allotments Nos. 51, 51A, 55, and part of 56 of Section No. 1 of the Small Lots near Panmure Village. Area, 67 acres and 10 perches.

Work done during year: Fences repaired and noxious weeds eradicated. Improvements now on domain: Fences, plantations, carriage-road to top of mountain, well, cistern, windmill, pump, pipes, and trough. Used by sightseers and for picnics and general recreation; also for grazing. Proposed operations for ensuing year: Planting trees and shrubs, eradicating noxious weeds, and general maintenance.

NAUMAI DOMAIN.

Section No. 213, Parish of Tauhoa. Area, 33 acres 1 rood.

Domain Board appointed 9th September, 1907. No works yet undertaken.

NEWMARKET DOMAIN.

Allotments Nos. 32 and 33 of Section No. 4, Suburbs of Auckland. Area, 3 acres 2 roods. Nil report furnished.

NGAROTO DOMAIN.

Section No. 176A, Ngaroto Parish. Area, 6 acres 1 rood.

Leased on improvement conditions.

NGARUAWAHIA DOMAIN.

Sections Nos. 123, Horotiu Parish, 101, Suburbs of Newcastle, and 607 and 663a, Town of Ngaruawahia. Area, 131 acres 1 rood 28 perches.

Work done during year: Fencing on racecourse completed. Used principally for races.

NGATIKOI DOMAIN.

Section No. 15, Block XVI, Ohinemuri Survey District. Area, 133 acres 3 roods.

Work done during year: Scrub burnt, and clover and grass sown. Improvements now on domain: Fences, trees, and clearing. Not used by the public; leased for grazing. Proposed operations for ensuing year: Clearing scrub and sowing grass.

NIKAU DOMAIN.



OTAU DOMAIN.

PLUMER DOMAIN.

Section No. 11, Plumer Hamlet, Parish of Waipareira. Area, 3 acres and 11 perches.

Domain Board appointed 9th November, 1907. A portion has been cleared and grassed. The remainder is in native bush. Used for picnics. Proposed operations for ensuing year: Erecting fences, eradicating noxious weeds, and clearing.

POKENO DOMAIN.

Allotment 138 of Section 1, Pokeno Settlement, Opaheke Survey District, and Section No. 154, Maungatawhiri Parish. Area, 132 acres and 4 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It comprises steep, broken land, without formed road access, and is mostly covered with heavy scrub. Blackberries appear in places. Improvements now on domain: Trees and fencing. Used for grazing. Proposed operations for ensuing year: Eradicating noxious weeds.

PUHOI DOMAIN.

Section No. 130, Parish of Puhoi. Area, 3 acres.

Domain Board appointed 9th September, 1907. No works yet undertaken.

PUKAPUKA DOMAIN.

Section No. 82A, Parish of Mahurangi. Area, 27 acres.

Domain Board appointed 9th September, 1907. No works yet undertaken.

PUNIU DOMAIN (PART OF).

Section No. 54A, and Allotments Nos. 6, and parts of 5, 7, and 8 of Section No. 236, Mangapiko Parish. Area, 15 acres and 20 perches.

Work done during year: Portion of Victoria Park laid down in grass, road frontages ploughed, noxious weeds eradicated, and dead trees replaced. During the year the Board purchased an additional \(\frac{1}{4}\) acre, on which it is proposed to plant ornamental trees. Improvements now on domain: Fences, plantations, and pavilion. Used for athletic sports and general recreation. Eight acres leased for grazing. Proposed operations for ensuing year: Planting trees and shrubs, constructing paths, and altering entrance-gates. Leased on improvement conditions. Improvements now on domain: Fences, gate, 4½ acres grassing, and hedge. Used for cricket and general recreation.

TANGIHUA DOMAIN.

Section No. 33, Block II, Tangihua Survey District. Area, 65 acres. Leased for grazing on improvement conditions.

Allotment No. 73, and Sections Nos. 57, 71, 72, 97, 98 to 100, 109 to 111, 112 to 114, and 116, Town of Tokatoka. Area, 38 acres 2 roods 19 perches.

Work done during year: Draining, ploughing, harrowing, rolling, grading, and sowing down an area in English grass. Improvements now on domain: Fencing, draining, ploughing, and grassing. Used for sports and grazing. Proposed operations for ensuing year: Planting trees and erecting fences.

FEATHERSTON DOMAIN.

Section No. 338, parts of Sections Nos. 152, 116, and 123, and Suburban Section No. 122, Town of Featherston, and the Featherston Town Reserve. Area, 88 acres and 5 perches.

Work done during year: Fences and buildings repaired, paths cleared, and noxious weeds eradicated. Improvements now on domain: Picnic-shed and tables, band-rotunda, seats, grand-stand, tennis-pavilion, plantations, and fences. Used for public recreation. Improvements now on domain: Fences, seats, drains, tennis-court, shed, 4 acres levelling and grassing, football-ground, and conveniences. 

Work done during year: Fences and conveniences erected. Improvements now on domain: Fences, gates, plantation, and conveniences. Used for cricket, tennis, and sports. Proposed operations for ensuing year: Levelling an area for a cricket-ground.

WESTLAND LAND DISTRICT.

AHAURA DOMAIN.

Sections Nos. 12, Block I, Ahaura Survey District, and 30, Block XIII, Mawhera-iti Survey District. Area, 100 acres.

Improvements now on domain: Fences, buildings, and racing-track. Used principally for training horses. Proposed operations for ensuing year: Erecting fences.

Dobson Domain.

Reserves Nos. 258 and 290, Town of Dobson. Area, 8 acres 2 roods.

No new works undertaken. Used for football and cricket.

KUMARA DOMAIN.

Sections Nos. 221 and 824, Town of Kumara. Area, 2 acres 2 roods 27 perches.

Improvements now on domain: Fencing, draining, clearing, and grassing. Used for football, hockey, cricket, and picnics.

MOANA DOMAIN.

Section No. 954, Block IV, Brunner Survey District. Area, 8 acres 1 rood 10 perches.

This area was brought under the provisions of "The Public Domains Act, 1881," on the 18th November, 1907. About 6 acres has been felled, and a small portion fenced. Since the close of the year a Domain Board was appointed to control the domain.

RIMU DOMAIN.

CANTERBURY LAND DISTRICT.

AKAROA DOMAIN.

Reserves Nos. 88 and 1724, Akaroa Survey District, and Section No. 45, Town of Akaroa. Area, 10 acres 2 roods.

Work done during year: Superfluous trees removed and cut into firewood, and walks, paths, and fences kept in order. Improvements now on domain: Substantial fences, macrocarpa hedge, summer-house, block-house, two bridges, fountain, water-supply, gates, garden-seats, asphalt tennis-court, and avenues of native and exotic trees and shrubs. Area, 90 acres, situated in the Town of Ashburton.

Work done during year: Shade-house with fernery erected, rosery laid out, propagating-house enlarged, new works in connection with the drainage and water-supply at the sports-ground pavilion carried out, superfluous trees removed, and general maintenance. Improvements now on domain: About four miles fencing, curator's lodge, propagating-house, pavilion, grandstand, shade-house, tool-house, bathing and other sheds, three asphalt and five grass tennis-courts, meteorological station, tennis and bowling pavilions, water-supply (with tanks, wheel, stand, and pipes), asphalt cycling-track, cricket-ground, croquet and bowling greens, lakes, plantations, rosery, flower-gardens, and wood, stone, and iron gates. No improvements effected during year. Improvements now on domain: Fences, road, retiring-room for ladies, fireplaces, and plantation. Used for picnics.

ATAAHUA DOMAIN.

Reserve No. 3705, Block III, Ellesmere Survey District. Area, 5 acres 3 roods 39 perches.

Work done during year: Fences maintained, trees attended to, and others planted. Improvements now on domain: Fences, plantations, gates, football-ground and goal-posts. Used for athletic sports. Three acres leased as a grazing paddock for school children's horses. Proposed operations for ensuing year: Planting trees and laying on water-supply.

BURKE'S PASS DOMAIN.

Reserve No. 1595, Block VIII, Burke Survey District. Area, 45 acres and 3 perches.

Work done during year: Grass sown. Improvements now on domain: Ring fence, and 2 acres fenced and planted with trees of various kinds. Used for picnics and general recreation: a portion is also used for grazing. Proposed operations for ensuing year: Planting and surface-sowing.

Work done during year: Bridges and gates repaired, house painted, shed erected, electric pump installed to water lawns and flower-beds, paths rearranged, lawns altered, new flower-beds made, new frames and accessories added to the nursery, trees cut down and timber sold, and general maintenance. Work done during year: Fish-pond cleaned out and deepened, embankment widened, fences repaired, and flower-beds kept in order. Improvements now on domain: Fences, gates, trees, shrubs, flower-beds, walks, seats, pond stocked with water-fowl and fish, artesian well, drains, and shed with 12-gallon copper for the use of picnic parties. Used for sports, picnics, and general recreation.

KIMBERLEY DOMAIN.

LITTLE RIVER DOMAIN.

Reserves Nos. 1649 and 3729, Block XIII, Pigeon Bay Survey District. Area, 66 acres and 6 perches.

Leased for grazing. Improvements now on domain: Fences, drains, trees, levelling, and grassing. Proposed operations for ensuing year: Levelling, erecting gates, and forming tenniscourts.

LOBURN DOMAIN.

Reserve No. 3442, Block II, Rangiora Survey District. Area, 25 acres.

Work done during year: Bottom of lake cleaned and embankment repaired. Improvements now on domain: Sixty-five chains boundary-fences, plantations, small lake, iron entrance-gate, and conveniences. Used for athletic sports, football, races, and picnics. Proposed operations for ensuing year: Planting trees and erecting fences.

MORVEN DOMAIN.

Reserve No. 3596, Block VII, Waitaki Survey District. Area, 60 acres.

Work done during year: Fences and gates painted, and general maintenance. Improvements now on domain: Fences, gates, plantations, and conveniences. Used for sports and picnics. Proposed operations for ensuing year: General improvements.

MOUNT SOMERS DOMAIN.

Reserves Nos. 2639 and 2028, Alford Survey District. Area, 119 acres 2 roods.

Work done during year: Earthenware pipes in channel across racecourse partly replaced by concrete ones, railing on racecourse extended, and football-ground improved. A cloak-room is in course of construction. Improvements now on domain: Fences, plantations, swimming - pool, tennis and football grounds, racecourse, and buildings. Used for races, football, tennis, cricket, swimming, and picnics.

PLEASANT POINT DOMAIN.

Reserve No. 1580, Pareora Survey District. Area, 66 acres 3 roods 34 perches. Improvements now on domain: Fences and gates. Used for sports, picnics, and races.

No scheme for improvement undertaken or decided on.

PURAKI DOMAIN.

Reserves Nos. 3701, Block XIII, Pukaki Survey District, and 3702, Block XV, Pukaki Survey District, and Block III, Strachey Survey District. Area, 356 acres.

This domain is under the control of the Tourist Department. Work done during year: Automatic swing gate erected, vegetable-garden fenced with rabbit-proof material, and general maintenance and repairs. Used by tourists travelling between Fairlie and Mount Cook.

RANGIORA DOMAIN.

Reserves Nos. 132 and 1563, Rangiora Survey District. Area, 95 acres.

Work done during year: Grandstand and other buildings renovated. Improvements now on domain: Boundary-fences, plantation, grandstand, cycle-track, and conveniences. Used for sports, cricket, football, hockey, golf, and picnics.

RANGIORA AND WAIKUKU BEACH DOMAIN.

Sections Nos. 3224, 3710, and 3718, Blocks VIII and XII, Rangiora Survey District. Area, 305 acres.

Work done during year: Shelter-sheds and fences erected and marram-grass planted. Improvements now on domain: Fences, plantations, artesian well, and shelter-shed. Used for picnics. Proposed operations for ensuing year: Erecting horse-rail and conveniences, planting marram-grass, and ploughing and laying down an area in grass for recreation purposes.

RAWHITI DOMAIN.

Reserve No. 1616, and part of Reserve No. 1579, Christchurch Survey District. Area, 156 acres.

Work done during year: Scrub cleared, trees thinned and cut into firewood, about 6 chains clay footpath formed, and four wells sunk. Improvements now on domain: Fences, plantation, footpaths, and wells. Used for picnics. Proposed operations for ensuing year: Clearing undergrowth and lupin from around trees, continuing clay footpaths, and planting trees.

RICHMOND DOMAIN.

Part of Rural Section No. 182, Christchurch Survey District. Area, 7 acres.

Improvements now on domain: Fences, plantation, pavilion, two artesian wells, and conveniences. Used for cricket, football, picnics, and general recreation. Proposed operations for ensuing year: Repairing fences and draining.

· RUAPUNA DOMAIN.

Reserve No. 3034, Block X, Shepherd's Bush Survey District. Area, 27 acres.

Work done during year: Domain laid down in English grass. Improvements now on domain: Fences, plantation, and grassing. Not used by the public; 25 acres leased.

RESERVE No. 3139.

Situated in Block IX, Cheviot Survey District. Area, 5 acres 1 rood.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It comprises a strip of land between the Buxton and Jed Rivers, and consists principally of sandhills. Some trees have been planted and the area improved by drainage. Improvements now on domain: Small hut and fences. Used for gardening and grazing.

RESERVE No. 3145.

Situated in Block V, Cheviot Survey District. Area, 5 acres.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It comprises a gully of native bush, and is leased to the owner of the adjoining property, who is required to protect it. He is doing so effectively. Used for picnics and grazing.

RESERVE No. 3150.

Situated in Block IX, Cheviot Survey District. Area, 6 acres.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It is used for scenic purposes, and leased for grazing to an owner of adjoining land, who is required to protect it.

RESERVE No. 3158.

Situated in Block XVI, Lowry Peaks Survey District. Area, 10 acres 2 roods 7 perches.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It comprises low-lying and wet land, is fenced, and used for grazing.

RESERVES Nos. 3148 AND 3149.

Situated in Block XI, Cheviot Survey District. Area, 35 acres 2 roods.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It is in its natural state, and contains a few native trees. Used by fishing and picnic parties.

SCOTSBURN DOMAIN.

Reserve No. 1554, Orari Survey District. Area, 50 acres.

No improvements effected during the year. Improvements now on domain: Fencing, plantation, and grassing. Used for grazing. Proposed operations for ensuing year: Forming waterrace.

SEFTON DOMAIN.

Parts of Sections Nos. 3135 and 6675, Block IV, Rangiora Survey District. Area, 14 acres 2 roods 16 perches.

Improvements now on domain: Wire boundary-fences and belt of trees, tennis-courts, grand-stand, seats, flag-pole, pump, and conveniences. Used for cricket, tennis, and picnics. Proposed operations for ensuing year: Erecting pavilion and painting seats, gates, and buildings.

SHEFFIELD DOMAIN.

Reserve No. 2377, Block XIII, Oxford Survey District. Area, 20 acres.

Work done during year: Hedges trimmed and gorse grubbed. Improvements now on domain: Fences, hedges, pavilion (with fireplace, table, and seats), half-mile trotting-track, judge's box, seats, and plantation. Used for sports, football, hockey, picnics, trotting, shows, and Volunteer encampments. Proposed operations for ensuing year: Removing superfluous trees, topping others, erecting gate and conveniences, and repairing pavilion.

Reserves Nos. 2442 and 2986, Town of South Rakaia, and 2537, Block XIII, Rakaia Survey District. Area, 155 acres 2 roods.

Work done during year: Fences erected and altered, shrubs planted, and general maintenance. Improvements now on domain: Fences, well and pump, horse-yards, saddling-paddock, swimming-pond, two dressing-sheds, building, concrete cricket-pitch, racecourse, running-track, rustic seats, water-race, and about 130 acres plantations. Used for sports, picnics, races, swimming, cricket, hockey, football, and general recreation. Proposed operations for ensuing year: General maintenance.

Work done during year: Fences erected and trees planted. Improvements now on domain: Forty chains standard and wire fences, plantations, drains, and sports-track. Used for sports and grazing. Proposed operations for ensuing year: Further planting and fencing plantations.

SPRINGSTON DOMAIN.

Reserve No. 2362, Leeston Survey District. Area, 10 acres.

Work done during year: Superfluous trees cut down and sold for firewood. Improvements now on domain: Fences, trees, shrubs, and asphalt tennis-court. Used for cricket, tennis, and general recreation.

ST. ANDREW'S DOMAIN.

Reserve No. 634, Otaio and Patiti Survey Districts. Area, 24 acres and 12 perches.

Work done during year: Fences trimmed and general maintenance. Improvements now on domain: Eighty chains gorse and wire fences, 5 chains open drain, 7 acres plantation, 17 acres grassing, asphalt cricket-pitch, grass tennis-court, and pavilion. Used for picnics, cricket, sports, and trotting. Proposed operations for ensuing year: Erecting fences, trimming and removing trees, and general maintenance.

TEMUKA DOMAIN.

Reserves Nos. 307, Town of Arowhenua, and 1561, Opihi Survey District. Area, 183 acres.

Work done during year: Trees felled and cut into firewood and posts, dressing-shed and pavilion erected, and general maintenance. Improvements now on domain: Post-and-wire boundary-fences, gorse hedges, six iron wicket gates for foot-traffic and four double gates for vehicles (one of wood and three of iron), caretaker's house, grandstand, dressing-room, tennis-shed and cloak-room, bowling-pavilion, offices, three tennis-courts, asphalt cycling-track, bowling-green, and croquet-lawn. Work done during year: Old fence removed and new one erected, and bathing-pond repaired. Improvements now on domain: Fences, 10 acres plantation, bathing pond and shed, and building. Used for cricket and picnics. Proposed operations for ensuing year: Clearing gorse and trimming hedges.

WEST MELTON DOMAIN.

Reserve No. 1564, Rolleston Survey District. Area, 20 acres.

Work done during year: Small pavilion and stiles erected, and 24 acres sown down in grass and clover. Improvements now on domain: Fences, windmill, small shed, pavilion, and plantations. Used for picnics, tennis, croquet, and general recreation.

WOODBURY DOMAIN.

Reserve No. 1544, Orari and Geraldine Survey Districts. Area, 126 acres 2 roods 33 perches.

Work done during year: Old gorse and wire fence removed and new standard and wire fence erected, grass mowed, fences and bath repaired, and gate erected. Improvements now on domain: Two hundred and sixty-eight chains fences, 5 acres drain-ploughed, two pavilions, dressing-room, lavatory, asphalt tennis-court, concrete cricket-pitch, concrete bath, and 8 acres plantation. Improvements now on domain: Fences, plantations, and embankment. Used for sports, picnics, and grazing.

CLINTON DOMAIN (PART OF).

Situated in Town of Hawksbury. Area, 459 acres 1 rood 36 perches.

Work done during year: Low-lying flat filled in, bowling-green formed, space provided for tennis-courts, new fences erected on the recently surveyed boundaries, and trees planted in place of those that failed. Improvements now on domain: Fences, canal and connecting drains, reclaimed area, plantations, embankments, bridges, pavilion, and bowling-green. Work done during year: Race-track improved. Improvements now on domain: Grandstand, offices, racing-track, and fences. Used for racing.

OCEAN BEACH DOMAIN.

Sections Nos. part 28 and 31, Block VII, Otago Peninsula Survey District, and 4 and 6, Block XII, Dunedin and East Taieri Survey District. Area, 221 acres 2 roods 11 perches.

During the year the baths have been kept in good order, and the sanitary arrangements carried out satisfactorily, with the result that enormous yields of marram-grass have been obtained. Repairs to concrete walls and platform have been effected, and a fence erected on the sea-wall from Beach Street to the baths, thus affording protection to cyclists and pedestrians. The pile groins at St. Clair continue to do good work, and no portion of the foreshore has been washed away for at least seven years. Fencing has been continued from Tahuna Park to the Tomahawk Road boundary to protect the grass and lupin plantations, and 40 chains of scrub fencing has been erected for the purpose of arresting drift sand, with a view to filling in the low-lying parts of the lagoon off St. Kilda. Lupins continue to spread, and are rapidly covering the whole of the sandhills. Patches burnt off in 1907 were renewed with seedlings, and are now covered with vegetation from 3 ft. to 6 ft. high. The track opposite Moreau Street has been improved, and the one opposite the Queen's Drive is being raised and covered with rock for a further distance of about 3 chains. The band-rotunda has been completed, enclosed with a fence, and the enclosure turfed.

OTOKIA DOMAIN.

Section No. 47, Block I, Otokia Survey District. Area, 12 acres 2 roods.

Work done during year: Approach to domain formed and shingled. Improvements now on domain: Nine chains fences, and post and chain horse-stand. Used for picnics and sports. Proposed operations for ensuing year: Erecting fences.

OUTRAM DOMAIN.

Sections Nos. 31 and 32, Block VII, Maungatua Survey District, and 14 to 20 and 22, Block I, and 7, Block XV, Town of Outram. Area, 402 acres 1 rood 5 perches.

Work done during year: Fences renewed, hedges trimmed, and noxious weeds eradicated. Improvements now on domain: Fences, hedges, buildings, plantations, cycle-track, swings, seats, and water-supply. Used for bowls, cricket, tennis, picnics, sports, cycling, and races. Proposed operations for ensuing year: Electing seats and conveniences, providing further water-supply, and general maintenance.

OWAKA DOMAIN.

Sections Nos. 31, 53, 54, 55, 58, 59, 60, and 61, Block VI, Glenomaru Survey District. Area, 12 acres 1 rood 32 perches.

Work done during year: Thirteen chains fences erected, 6 acres partly cleared of scrub, timber logged up and burnt, and a portion stumped and sown down in grass, but, owing to the dry season, this will probably have to be resown. Improvements now on domain: Fences, native bush, clearing, and grassing. Used for picnics and sports. Proposed operations for ensuing year: Erecting fences and gate, and stumping, clearing, and cultivating.

OWAKA TOWNSHIP DOMAIN.

Section No. 111 (formerly part of Section No. 3), Block VIII, Glenomaru Survey District. Area, 3 acres 3 roods 0.8 perches.

This area was brought under the provisions of "The Public Domains Act, 1881," on the 18th November, 1907. Since the close of the year a Domain Board was appointed to manage the domain.

PALMERSTON DOMAIN.

Sections Nos. 5 to 18, Block XVI, Town of Palmerston. Area, 3 acres 2 roods.

Work done during year: Fences repaired. Improvements now on domain: Boundary-fences. Used for cricket and football.

RANFURLY DOMAIN.

Sections Nos. 1 to 15, Block XIII, Town of Ranfurly. Area, 10 acres 2 roods 36 perches. No improvements effected. It is proposed to fence the domain during the ensuing year.

RANFURLY PARK DOMAIN.

Suburban Sections Nos. 7 and 8, Block I, Town of Ranfurly. Area, 52 acres and 31 perches.

Improvements now on domain: Racecourse. Used for races. Proposed operations for

ensuing year: Fencing.

RECORD REIGN DOMAIN.

Work done during year: General improvements. Improvements now on domain: Twenty-five chains fences, hedges, and plantations. Used for sports, Volunteer encampments, band parades, picnics, and general recreation. Proposed operations for ensuing year: Removing fence and recreeting it on correct boundary, and planting trees.

ROSLYN DOMAIN.

Section No. 7, Block X, Dunedin and East Taieri Survey District. Area, 12 acres 2 roods 28 perches.

Leased for grazing.

ST. BATHAN'S DOMAIN.

Section No. 25, Block II, St. Bathan's Survey District. Area, 23 acres 1 rood 5 perches.

Work done during year: General maintenance. Improvements now on domain: Forty-five chains fences, four gates, trees, hedges, curling and skating pond, football and cricket grounds, and two running-tracks. Used for sports, picnics, and general recreation. Proposed operations for ensuing year: Removing broom.

TAIERI LAKE DOMAIN.

Sections Nos. 12 and 18, Block XI, and 2, Block XII, Maniototo Survey District. Area, 430 acres 3 roods.

Work done during year: Fence erected, drain cut, and fence removed to give stock access to river. Improvements now on domain: Fences, drain, and plantation. Leased. Proposed operations for ensuing year: Erecting fences and planting trees.

TOKOMAIRIRO DOMAIN.

Parts of Sections Nos. 103 and 104, Block XII, Tokomairiro Survey District. Area, 59 acres 2 roods 30 perches.

Work done during year: Unsightly trees removed, a large portion of the area laid off and planted, footpaths formed, swimming-pond constructed, planted portions surrounded by wire-netting, and flower-beds and pots stocked. Improvements now on domain: Fences, plantations, pavilion, drains, ponds, and paths. Used for football and cricket. Proposed operations for ensuing year: Planting shrubs and flowers, attending to plots, completing swimming-pond, and general maintenance.

Section No. 36, Block XI, Moeraki Survey District. Area, 183 acres and 11 perches.

Work done during year: Tracks repaired and rustic seats provided. Improvements now on domain: Tracks, bridge, and seats. Used for picnics and camping parties.

TUAPEKA DOMAIN.

Blocks XV, XVI, XVIII, XIX, XXXV, Sections Nos. 1 to 8, 10 and 13 to 16, Block XIV, 1 to 7 and 20, Block XVII, 1 to 6 and 17 and 18, Block XXXIV, 6, Block LIII, 3, 4, and 5, Block LIV, and three areas, containing 1 rood, 2 roods 35 perches, and 3 roods 24 perches respectively, Town of Lawrence, and Sections Nos. 20 and 30, Block XIX, Tuapeka East Survey District. Area, 128 agree and 26 perches Survey District. Area, 128 acres and 26 perches.

Work done during year: Fences repaired and in some places renewed, gorse and broom removed, bulbs and flowering-plants planted on the Reservoir Hill, two stiles erected, grass cut, and paths attended to. Used for cricket, football, picnics, shows, Volunteer parades, and races.

Used for sports, picnics, sanctuary for birds, and generally for the gratification of the lovers of the beautiful in nature. The Wanaka Steam Shipping Company runs steamers to the islands in Lake Wanaka almost daily during the tourist season. Proposed operations for ensuing year: Planting trees, forming roads and tracks, and general improvements.

WANGALOA DOMAIN.

Part of Section No. 8, Block VII, Coast Survey District. Area, 32 acres 3 roods 13 perches. Improvements now on domain: Fences, drains, and plantations. Used for picnics and sports.

WILLSHER DOMAIN.

Sections Nos. 1, 3, and 4 of 16, and an intersecting road-line, Block VII, South Molyneux Survey District. Area, 14 acres and 39 perches.

Work done during year: Fences and seats erected, drains made, and an area ploughed and sown down in grass. Improvements now on domain: Fences, seats, drains, and conveniences. Sections Nos. 1 to 7 and 9 to 17, Block IV, Town of Limehills. Area, 4 acres 1 rood 6 perches.

Work done during year: One and a quarter acres ploughed and sown down in grass. Improvements now on domain: Fences, 7 chains drains, trees, and shed. Used for sports, cricket, and football. Proposed operations for ensuing year: Erecting 10 chains fencing.

LUMSDEN DOMAIN.
