POLICE PROVIDENT FUND:

FINAL REPORT OF BOARD OF ADMINISTRATION, YEAR ENDED 31st MARCH, 1910.

Laid before Parliament in pursuance of Section 38, Subsection (e), of the Police Force Act, 1908.

THE Board has to report that under the legislation of last session its functions cease to-day, and hereafter the members of the Police Force will become contributors to the Public Service Superannuation Fund, and be subject to the provisions of the Public Service Superannuation Acts.

During the year ended 31st March, 1910, one sergeant-major, one detective, two sergeants, and eleven constables were retired with annual allowances under the Act and placed on the Fund. The particulars are as follows:—

The balance-sheet and statement of receipts and disbursements are hereto annexed, as required by section 38 of the Police Force Act. It will be seen that on the 31st March there was a balance to the credit of the Fund of £32,204 7s. 1d., being an increase of £490 19s. 3d. on the amount at the corresponding date of the preceding year. Under the provisions of section 23 of the Public Service Classification and Superannuation Amendment Act, 1909, the Police Provident Fund is merged in the Public Service Superannuation Fund, and the balance has accordingly been transferred to the last-named fund.
