TE PURE DOMAIN.

Work done during year: Twelve acres ploughed and sown in grass and clover, and noxious weeds kept down. Improvements now on domain: Fences, hedge, and three tennis-courts. Used for military camps and sports.

This domain is under the control of the Commissioner of Crown Lands, Auckland. Proposed operations for ensuing year: Clearing noxious weeds.

Steps are being taken to protect the standing bush on the domain. The Board proposes to negotiate for the purchase of an area to give access to the domain.

TOKATOKA DOMAIN.

Sections Nos. 57, 71, 72, 73, 90 to 97, 98 to 100, 109 to 111, 112 to 114, and 116, Town of Tokatoka. Area, 38 acres 2 roods 19 perches.

Work done during year: Scrub felled. Improvements now on domain: Fencing and felling. Used for picnics, sports, and grazing. Proposed operations for ensuing year: Sowing 10 acres in grass.

TOTARA DOMAIN.

Section No. 15, Totara Parish. Area, 4 acres 1 rood 5 perches.

Improvements now on domain: Embankment and drains. Used for sports.

TUAKAU DOMAIN.

Section No. 45, Tuakau Parish. Area, 36 acres 3 roods.

Work done during year: Hedges trimmed, flowers and shrubs attended to, entrance-gates and approaches improved, new wicket gate and picket fence erected, and tennis-court formed. Improvements now on domain: Fencing, planting, trees, shrubs, tennis-court, and grassing. Used for picnics and military reviews. Proposed operations for ensuing year: Procuring garden-seats, and generally improving the domain.

TUI PARK DOMAIN.

Section No. 14A, Block IX, Aroha Survey District. Area, 52 acres 1 rood 10 perches. Some survey-work was done during the year. Used for picnics.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It contains some fine native bush, and is leased to a person who also acts as caretaker. Proposed operations for ensuing year: Clearing noxious weeds.

URITAWA DOMAIN.

Sections Nos. 15 to 29 and 38 to 42, and portions of closed streets, Town of Waterford. Area, 5 acres 1 rood 24 perches.

Work done during year: Fences made sheep-proof, failures in shelter-trees replaced and protected with stakes and wire netting, and tennis-court topdressed with tar and sand. The last-named work was done without expense to the Board, and the labour in connection with the

fencing was supplied gratis. Improvements now on domain: Fencing, gates, shelter and ornamental trees, asphalt tennis-court, football and cricket grounds, shelter-shed, flagstaff, and dressing-room. Used for sports and military parades. Proposed operations for ensuing year: General maintenance.

Leased. Improvements now on domain: Fences, drains, and plantations. Used for agricultural and pastoral shows, football, and cricket. Proposed operations for ensuing year. Draining.

Section No. 49, Waikiekie Parish. Area, 60 acres.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It comprises undulating land covered with mixed bush; no level land suitable for games. Improvements now on domain: Ring-fencing. Proposed operations for ensuing year: Clearing noxious weeds.

WAIKINO DOMAIN.

Section No. 51, Waikino Township. Area, 12 acres and 30 perches.

Work done during year: Two and a half acres filled in, manured, and grassed for cricket and football: fences, hedges, and plantations maintained and repaired. Improvements now on domain: Grassing, concrete cricket-pitch, dressing-room, pavilion, fences, hedges, plantations, and gates. Used for sports, cricket, football, hockey, and band concerts. This domain is under the control of the Commissioner of Crown Lands, Auckland. Used There is a beautiful waterfall on the domain.

WAITAKEREI DOMAIN.

Sections Nos. 16, 18, 19, E. 64, 65, S. 68, S.E. 75, S. 78, S. 79, 110, 111, and S. 112, Karangahape Parish; N. 54, Block V. Waitakerei Survey District; and 163 and 193, Waipareira Parish. Area, 4,732 acres.

Work done during year: Tracks cut, and grounds generally maintained. Used for picnics and general scenic purposes; also as a catchment-area for water.

WAIUKU DOMAIN.

Section No. 73, Waiuku Village. Area, 10 acres.

Work done during year: General maintenance. Improvements now on domain: Fences, drains, gates, plantations, asphalt cricket-pitch, buildings, and grassing. Used for cricket, football, hockey, and sports. Proposed operations for ensuing year: General maintenance and improving entrance.

WAIWERA DOMAIN.

Sections Nos. 168, 169, 170, and 171, Waiwera Parish. Area, 12 acres 2 roods 9 perches.

Improvements now on domain: Fencing and ploughing. Used for general recreation. It is proposed to lease the area.

WHAINGAROA DOMAIN.

Sections Nos. 86 and 86a, Waipa Parish, and 139, Whaingaroa Parish. Area, 364 acres and 21 perches.

Improvements now on domain: House of twenty rooms, outbuildings, fences, orchard, plantations, ladies' and men's baths (concrete), and buildings. Used as a health resort.

Work done during year: Stone fence completed, gates erected, others removed and re-erected, cottages repaired and bath installed, and conveniences on domain connected with sewage scheme. No improvements effected during the year. The domain is of rough formation, without means of access, and is used for grazing purposes. The fencing is the property of the lessee.

OMAKA DOMAIN.

Sections Nos. 31 and part 2 of 33, Block III, Taylor Pass Survey District. Area, 242 acres.

Work done during year: Grounds maintained and plantations attended to. Improvements now on domain: Fencing, drains, and plantations. Used for cricket, football, and sports. An area is leased. Proposed operations for ensuing year: Maintaining and improving grounds, and extending drainage system.

PELORUS DOMAIN.

Sections Nos. 25, Block VIII, Heringa Survey District, and 66 (Te Hau Island), Block XI, Wakamarina Survey District. Area, 22 acres.

Nine acres of the domain is an island in the Pelorus River, subject to floods. The remaining 13 acres is in native bush.

PICTON DOMAIN.

Part of Section No. 1147, Town of Picton. Area, 9 acres 2 roods.

Work done during year: Noxious weeds kept down. This domain is steep and rocky. It contains some native bush and an area of about 2 acres suitable for picnics. Proposed operations for ensuing year: Keeping down noxious weeds.

Reserve No. 1061, Block XVI, Greymouth Survey District. Area, 3 acres and 6 perches. Domain Board appointed 30th December, 1909.

RIMU DOMAIN.

Section No. 356, Block V, Kanieri Survey District. Area, 5 acres and 19 perches.

Work done during year: Trees planted and protected with fences. Improvements now on domain: Fences, trees, and an area cleared for football and cricket, for which the domain is chiefly used. Proposed operations for ensuing year: Carting soil, and levelling, ploughing, and harrowing an area.

Situated in Town of Ross. Area, 3 acres 3 roods 16 perches.

Work done during year: Racecourse buildings and railings painted, picket fence erected, running-track topdressed and improved, $\bar{\iota}$ chains new boundary-fence erected, hedges trimmed, and gorse grubbed. Improvements now on domain: Fences, plantations, grassing, tennis-courts, football-ground, running-track, swimming-pool, and racecourse, with buildings and railings. Used for races, football, sports, picnics. A Volunteer encampment was also held in the domain during the year.

NEW BRIGHTON DOMAIN.

Reserve No. 3061, Christchurch Survey District. Area, 8 acres and 17 perches. Nil report furnished.

OHOKA AND EYRETON DOMAIN.

Reserves Nos. 1567 and part 1500, Rangiora Survey District. Area, 215 acres 1 rood.

During the year the Board purchased an area of about 15 acres, which will be used for recreation purposes. It is at present leased. Improvements now on domain: Fencing, grand-stand, stables, cloak-room, offices, horse-yards, and plantations. Used for races, grazing, and cropping. Proposed operations for ensuing year: Improving the recently acquired area by levelling, planting, and sowing down in grass, to make it suitable for purposes of recreation.

ORARI PARK DOMAIN.

Reserves Nos. 3028, 3081, and 3082, parts of Barker and MacDonald Streets, and Sections Nos. 11, Block V, and 16, Block VI, Town of Orari: Area, 14 acres and 28 perches.

Work done during year: Fences repaired, hedges trimmed, and two new gate-posts erected. Improvements now on domain: Trees, asphalt tennis-court, garden-seats, fences, and hedges. Used for tennis and football. Eleven acres leased for grazing.

OXFORD DOMAIN.

Reserve No. 1651, and part of Rural Section No. 1889, Block VIII, Oxford Survey District. Area, 224 acres 2 roods 26 perches.

Work done during year: Wire netting 10 ft. high erected at tennis-courts; library, reading-room, grandstand, and fencing repaired and painted; well sunk and pump erected; flower-borders maintained; new gate and posts erected; and pavilion and entrance-gates on View Hill painted. Improvements now on domain: Plantations, fencing, entrances, cycle-track, two concrete cricket-pitches, three asphalt tennis-courts, two grandstands, tea and dressing rooms, ladies' retiring-room, library, concrete swimming-bath and dressing-room, pump, flower-borders, race-course, plantations, saddling-paddocks, conveniences, and pavilion. Used for cricket, football, tennis, swimming, sports, picnics, and races; in addition to the library and reading-room. Proposed operations for ensuing year: Building hall and some smaller rooms; laying down a bowling-green; redecking, repairing, and painting grandstand; and repairing fencing.

PAPANUI DOMAIN.

Part of Rural Section No. 5, Block VII, Christchurch Survey District. Area, 6 acres 2 roods 25 perches.

Improvements now on domain: Pavilion, outbuildings, boundary-fence, gates, ornamental trees, artesian well, and drain. Used for cricket, football, and picnics. Proposed operations for ensuing year: Repairing gates, painting buildings, trimming hedges, and cleaning drains.

PORT ROBINSON DOMAIN.

Reserves Nos. 3151, 3159, and 3160, Block XI, Cheviot Survey District. Area, 113 acres 1 rood.

Work done during year: Sixty-three chains fencing erected to protect native bush. Improvements now on domain: One hundred and ninety-eight chains fences and 3 acres plantations. Used for grazing and picnics. Proposed operations for ensuing year: Planting trees.

PREBBLETON DOMAIN.

Reserve No. 2419, Christchurch Survey District. Area, 3 acres 2 roods 15 perches.

Work done during year: Hedges trimmed. Improvements now on domain: Fences, plantation, and seats. Used for cricket and football.

PUDDING HILL DOMAIN.

Formerly part of Reserve No. 3315, Block VIII, Hutt Survey District. Area, 87 acres 1 rood 28 perches.

Improvements now on domain: Cookhouse and conveniences. Used for picnics. Proposed operations for ensuing year: Fencing domain.

RANGIORA DOMAIN.

Reserves Nos. 132 and 1563, Rangiora Survey District. Area, 95 acres.

Work done during year: General maintenance. During the year the lease of the race-course reserve expired, and the area was again leased. Improvements now on domain: Fences, plantations, grandstand, windmill and water-service, cycling-track, golf-links, and conveniences. Used for sports, cricket, football, hockey, golf, and picnics. Proposed operations for ensuing year: General improvements.

RANGIORA AND WAIKUKU BEACH DOMAIN.

Sections Nos. 3224, 3710, and 3718, Blocks VIII and XII, Rangiora Survey District. Area, 305 acres.

Work done during year: Marram-grass planted and concrete trough constructed. Improvements now on domain: Plantations, fences, artesian well, shelter-shed, and conveniences. Used for picnics and camping. Proposed operations for ensuing year: Erecting two dressing-sheds and planting marram-grass.

RAWHITI DOMAIN.

Reserve No. 1616, and part of Reserve No. 1579, Christchurch Survey District. Area, 156 acres.

Work done during year: Scrub cleared, preparation of sports-ground commenced, trees thinned, and undergrowth cleared. Improvements now on domain: Fences, 89 acres plantation, footpaths, and four artesian wells. Used as promenade and for picnics. Proposed operations for ensuing year: Repairing fences, clearing undergrowth, thinning trees, and forming sportsground.

RICHMOND DOMAIN.

Part of Rural Section No. 182, Christchurch Survey District. Area, 7 acres.

Work done during year: Trees topped, others removed, and drainage improvements effected. Improvements now on domain: Pavilion, conveniences, two wells, fencing, and plantation. Used for cricket, football, picnics, and general recreation.

RUAPUNA DOMAIN.

Reserve No. 3034, Block X, Shepherd's Bush Survey District. Area, 27 acres.

During the year 24 acres was leased, for a crop of oats and sowing down in grass. Three acres was ploughed and resown in grass, new gate and posts erected, and trees topped. Improvements now on domain: Plantation, fencing, and grassing. Twenty-four acres leased. It is proposed to lease the area for grazing.

RESERVE No. 3139.

Situated in Block IX, Cheviot Survey District. Area, 5 acres 1 rood.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It comprises a strip of land between the Buxton and Jed Rivers, and consists principally of sandhills. Some trees have been planted and the area improved by drainage. Improvements now on domain: Small hut and fences. Used for gardening and grazing.

RESERVE No. 3145.

Situated in Block V, Cheviot Survey District. Area, 5 acres.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It comprises a gully of native bush, and is leased to the owner of the adjoining property, who is required to protect it. Used for picnics and grazing.

RESERVE No. 3149.

Situated in Block XI, Cheviot Survey District. Area, 23 acres.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It is situated at the mouth of the Hurunui River, and contains a few native trees. Used for fishing and picnic parties.

RESERVE No. 3150.

Situated in Block IX, Cheviot Survey District. Area, 6 acres.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It is used for scenic purposes, and leased for grazing to an owner of adjoining land, who is required to protect it.

RESERVE No. 3158.

Situated in Block XVI, Lowry Peaks Survey District. Area, 10 acres 2 roods 7 perches.

This domain is under the control of the Commissioner of Crown Lands, Christchurch. It comprises low-lying and wet land, is fenced, and used for grazing.

SCOTSBURN DOMAIN.

Reserve No. 1554, Orari Survey District. Area, 50 acres.

Improvements now on domain: Fencing, plantation, and grassing. Used for grazing and cropping.

SEFTON DOMAIN.

Parts of Sections Nos. 3135 and 6675, Block IV, Rangiora Survey District. Area, 14 acres 2 roods 16 perches.

Work done during year: Timber sawn and used in the erection of a pavilion. The pavilion is divided into three parts—one portion is used as an office and meeting-room, another is fitted with a copper and double brick chimney, and the other part as a shelter-shed. Improvements now on domain: Fences, trees, pump, conveniences, flag-pole, twelve garden-seats, and pavilion. Used for cricket, football, sports, and picnics. Proposed operations for ensuing year: Placing concrete floor in portion of pavilion used as a shelter-shed, and repairing and painting gates.

SHEFFIELD DOMAIN.

Reserve No. 2377, Block XIII, Oxford Survey District. Area, 20 acres.

Improvements now on domain: Fences, pavilion, with fireplace, table, and seats, trotting-track, judge's box, ticket-box, seats, plantations, and conveniences. Used for sports, cricket, football, hockey, picnics, trotting, shows, and military encampments. Proposed operations for ensuing year: Thinning out trees and topping others.

SOUTH RAKAIA DOMAIN.

Reserves Nos. 2442 and 2986, Town of South Rakaia, and 2537, Block XIII, Rakaia Survey District. Area, 155 acres 2 roods.

Work done during year: General maintenance. Improvements now on domain: Fences, well and pump, horse-yards, saddling-paddock, swimming-pond, two dressing-sheds, office, concrete cricket-pitch, racecourse, running-track, rustic seats, water-race, and about 130 acres plantations. Used for sports, picnics, races, and general recreation. Proposed operations for ensuing year: General maintenance.

SPOTSWOOD DOMAIN.

Reserves Nos. 3714 and 3157, Block IV, Cheviot Survey District. Area, 9 acres 1 rood 10 perches.

Work done during year: Iron gates, with concrete posts, erected, and 150 trees planted. Improvements now on domain: Fencing, plantation, and iron gates and concrete posts. Used for football, cricket, and general recreation. Proposed operations for ensuing year: Erecting wings and posts to gate, and replacing old fencing.

SPREYDON AND HALSWELL DOMAIN.

Reserve No. 110, Christchurch Survey District. Area, 20 acres.

Work done during year: Fencing erected, drains cleaned, and tennis-court laid down. Improvements now on domain: Forty chains fencing, plantations, 50 chains drains, sports-track, tennis-court, and two artesian wells. Used for sports, tennis, and grazing. Proposed operations for ensuing year: Planting, draining, fencing, and general improvements.

SPRINGSTON DOMAIN.

Reserve No. 2362, Leeston Survey District. Area, 10 acres.

Work done during year: Hedges trimmed, fences repaired, and shrubs attended to. Improvements now on domain: Fences, hedges, trees, shrubs, concrete cricket-pitch, tennis-court, and small building. Used for general recreation. Proposed operations for ensuing year: Planting trees.

ST. ANDREW'S DOMAIN.

Reserve No. 634, Otaio and Patiti Survey Districts. Area, 24 acres and 12 perches.

Work done during year: Hedges trimmed, dead trees removed, pavilion and entrance-gates painted, and new ring for sports formed. The Board provided the timber, and the work was done by the Sports Committee. Improvements now on domain: Eighty-four chains fences, hedges, 5 chains open drain, 7 acres mixed plantation, 17 acres grassing, pavilion, and sportsring. Used for picnics, cricket, and sports. Proposed operations for ensuing year: General maintenance.

TEMPLETON DOMAIN.

Reserves Nos. 2351 and 2418, and part Rural Section 1807, Block IX, and part Rural Section 1680, Block XIII, Christchurch Survey District; and part Rural Section 2737, Block XVI, Rolleston Survey District. Area, 245 acres.

This domain comprises the principal area of 229 acres, and three smaller areas at Templeton, Yaldhurst, and Hornby. Work done during year: Tree-planting done in the Templeton and Yaldhurst grounds, fences to protect trees erected at Yaldhurst and Hornby, the latter area cultivated and laid down in grass; entrance-gates erected, cricket-pitch made, and gates repaired and painted at Templeton, and other improvements and repairs effected to the three areas. Improvements now on domain: Fences, avenue of trees, pavilions, tennis-courts, croquet-lawns, cricket-pitch, entrance-gates, seating accommodation, conveniences, and shelter and ornamental trees. Used for grazing, and for picnics, sports, military manœuvres, cricket, tennis, croquet, bowls, and general recreation. Proposed operations for ensuing year: Erecting conveniences and possibly a small pavilion at Hornby, erecting and repairing fences, stubbing gorse, broom, and noxious weeds, providing seating accommodation, planting ornamental trees and shrubs, clearing weeds, and replacing failures amongst trees.

TEMUKA DOMAIN.

Reserves Nos. 307, Town of Arowhenua, and 1561, Opihi Survey District. Area, 183 acres.

Work done during year: General maintenance, and 135½ cords of firewood cut, of which the greater portion has been sold. Improvements now on domain: Post-and-wire fences with gorse hedges, six iron wicket gates for foot traffic, five double gates for vehicles, caretaker's house, bowling-pavilion, tennis-shed, dressing-shed, grandstand and necessary offices, three asphalt tennis-courts, asphalt cycling-track, cricket-ground, bowling-green, and croquet-court. Used for sports and picnics. It is proposed to extend the recreation-ground by taking in about 12 acres of the area at present leased. The several clubs using the domain continue to add considerably to its attractiveness by expending large sums out of their own funds in improving and maintaining those portions allotted to them for their particular sports.

TINWALD DOMAIN.

Part of Reserves Nos. 2378 and 2275, Block XVI, Westerfield Survey District. Area, 230 acres.

Work done during year: Two miles of iron fencing erected, 10 acres of trees and shrubs planted in place of pines, new tennis-courts laid down, well sunk and pump erected, hollows filled in, new gates and posts erected, and Californian thistle eradicated. Improvements now on domain: Gorse, wire, and macrocarpa fences, pipe and open drains, grandstand and booth, three rooms for offices, pavilion, plantation, shrubs, tennis-courts, and lakelet with boat and boatshed. Used for cricket, tennis, sports, boating, bathing, and general recreation. Proposed operations for ensuing year: Re-forming drives, removing a number of trees and replacing them with trees and shrubs, painting buildings and gates, and generally maintaining the area.

WAHI TAKARO DOMAIN.

Reserve No. 3716, Block VIII, Teviotdale Survey District. Area, 55 acres.

Work done during year: Pipe driven and pump erected, 200 trees planted, and a square fenced off and planted. Improvements now on domain: Water-supply, enclosures, and trees. Used for picnics, bathing, camping, and as a rifle range. Proposed operations for ensuing year: Erecting shelter-shed and fencing, and planting trees. The Board proposes to hold a local concert to raise funds for these works.

WAIAU DOMAIN.

Section No. 1, Block XIII, Waiau Survey District. Area, 40 acres.

Work done during year: Five hundred trees planted: asphalt tennis-court laid down; additions made to pavilion; conveniences erected; briar, blackberry, and gorse grubbed; and fences repaired. Improvements now on domain: Fences, sports-ground, tennis-court, dressing-room, pavilion, and plantations. Used for football, sports, tennis, and picnics. Proposed operations for ensuing year: Clearing gorse, briar, and blackberry, erecting fences, planting trees, and painting buildings.

WAIHORA PARK DOMAIN.

Reserve No. 2585, Block XIV, Halswell Survey District. Area, 200 acres.

Work done during year: New artesian well sunk, tanks to hold 5,000 gallons procured, pond maintained, and conveniences and an addition to caretaker's house erected. Improvements now on domain: Fencing, planting, sports-ground, pavilions, water-supply, gates, walks, flower-garden, and caretaker's cottage. Used for general recreation. Proposed operations for ensuing year: General maintenance.

WAIKAKAHI DOMAIN.

Reserve No. 3459, Morven Township. Area, 4 acres 1 rood 15 perches Domain Board appointed 22nd December, 1909.

WAINUI DOMAIN.

Section No. 727, Block VII, Akaroa Survey District. Area, 2 acres.

Work done during year: Two sides of domain fenced off and planted with trees. Improvements now on domain: Fencing, drains, trees, and grassing. Used as a children's playground and for picnics.

WAITAKI NORTH DOMAIN.

Reserve No. 2915, Block XIV, Waitaki Survey District. Area, 57 acres.

Work done during year: Two thousand trees planted and fenced in, sports-ground fenced in, and track made. Improvements now on domain: Fencing, windmill, pump, tank, trees, sports-ground, and track. Used for grazing and sports. Proposed operations for ensuing year: Tree-planting and fencing.

WEEDON DOMAIN.

Reserve No. 1596, Block XV, Rolleston Survey District. Area, 48 acres 2 roods 17 perches.

Work done during year: Grass sown. Improvements now on domain: Fences, 10 acres plantation, bathing pond and shed, and building. Used for cricket and picnics. Proposed operations for ensuing year: Trimming hedges and repairing fences.

WEST MELTON DOMAIN.

Reserve No. 3789, Block XI, Rolleston Survey District. Area, 10 acres.

The Board exchanged the old domain for an area of 10 acres. Work done during year: New area ploughed and sown in grass. Improvements now on domain: Fences and hedges. Used for sports and picnics. Proposed operations for ensuing year: Planting trees, and erecting 10 chains fencing.

WINCHESTER DOMAIN.

Reserves Nos. 2402 and 2449, Block XIV, Geraldine Survey District. Area, 42 acres 1 rood.

Work done during year: Trees topped and cut down, others planted and fenced off, wind-mill and two tanks erected, and thistles removed. Improvements now on domain: Cricket and tennis pavilions, tennis and croquet lawns, $8\frac{1}{2}$ acres plantations, hedges, fences, windmills, and tanks. Used for cricket, hockey, football, tennis, croquet, picnics, and general recreation. Twenty-four acres leased. Proposed operations for ensuing year: General maintenance.

WOODBURY DOMAIN.

Reserve No. 1544, Orari and Geraldine Survey Districts. Area, 126 acres 2 roods 33 perches.

Work done during year: Tennis-pavilion removed to a more suitable position, enclosure improved, forty flowering-shrubs planted, and grass inside running-track cut with mower purchased by Board. The old pavilion and bath are being repainted. Improvements now on domain: Two hundred and sixty-eight chains fences, draining, two pavilions, dressing-room, conveniences, two tennis-courts, concrete cricket-pitch, concrete bath, plantations, and flowering-shrubs. Used for sports, picnics, cricket, tennis, bathing, and general recreation. Proposed operations for ensuing year: Replacing gorse hedge, trenching around bath to prevent damage by the roots of trees, topdressing tennis-court, repairing building, draining, and general maintenance.

WOODEND DOMAIN.

Reserves Nos. 2134, 2539, and 3728, Rangiora Survey District. Area, 268 acres 2 roods 3 perches.

Work done during year: Marram-grass and trees planted, and hedges and trees trimmed. Improvements now on domain: Fencing, levelling, trees, pavilion, asphalt tennis-courts, pump, artesian well and tank and pipes. Used for picnics, football, cricket, tennis, and general recreation. Proposed operations for ensuing year: Planting marram-grass and trees, trimming hedges and trees, filling in gully, and general improvements.

OTAGO LAND DISTRICT.

ALBERT TOWN DOMAIN.

Section No. 5, Block IV. Lower Wanaka Survey District. Area, 81 acres.

This domain is under the control of the Commissioner of Crown Lands, Dunedin. No work has been undertaken.

ALLANTON DOMAIN.

Block XIII, Town of Allanton. Area, 7 acres and 33 perches.

Improvements now on domain: Fences and plantation. Leased for grazing.

ARROWTOWN DOMAIN.

Section No. 38, Block VII, Shotover Survey District. Area, 6 acres.

Improvements now on domain: Tennis-court and wood and iron shed. Used as tourist resort, and for cricket, tennis, football, athletic sports, picnics, and military encampments.

BALCLUTHA DOMAIN.

Reserve No. 5, Town of Balclutha. Area, 1 acre.

A pavilion has been erected by the bowling and tennis clubs. A rotunda is also being erected by public subscription. Improvements now on domain: Fences, pavilion, band-rotunda in course of erection, shrubs, windmill, bowling-green, and levelling. Used for bowls, tennis, and general recreation. Proposed operations for ensuing year: Completing erection of rotunda, and levelling grounds.

BASTINGS DOMAIN.

Sections Nos. 1, 2, 48, 49, and 50, Block I, Town of Bastings. Area, 1 acre 1 rood 14 perches. Work done during year: Noxious weeds eradicated. The Board paid half cost of boundary-fence erected. Improvements now on domain: Five chains boundary-fence.

BERWICK DOMAIN.

Section No. 10, Block IX, Town of Berwick. Area, 4 acres.

Improvements now on domain: Plantation and fencing. Used for sports, picnics, and grazing. Proposed operations for ensuing year: Erecting a shelter-shed.

CLINTON DOMAIN (PART OF).

Section No. 82, Block XI, Pomahaka Survey District. Area, 132 acres.

This portion of Clinton Domain is under the control of the Commissioner of Crown Lands, Dunedin, and is leased for grazing.

CLINTON DOMAIN (PART OF).

Section No. 1, Block XXVI, Town of Clinton. Area, 18 acres and 36 perches.

This portion of the Clinton Domain is administered by the Clinton Town Board as a Domain Board. Work done during year: Eight acres sown in turnips. Improvements now on domain: Grandstand, fences, and hedge. Used for cricket, football, and general recreation. Seven acres leased.

CLYDE DOMAIN.

Sections Nos. 38, 39, and 48, Block XI, and Blocks IV, V, VI, VII, LVI, and LVII, Town of Clyde. Area, 63 acres 3 roods 21.5 perches.

Work done during year: Plantation extended. Improvements now on domain: Fencing, plantation, and water-service. Used for tennis, sports, cricket, golf, football, and general recreation. Proposed operations for ensuing year: Improving water-service and extending plantation.

CROMWELL DOMAIN.

Section No. 1, Block XV, Town of Cromwell, and the Cromwell Town Belt Area, 231 acres.

Work done during year: Trees planted, sand-barriers extended, and a new and larger recreation-ground formed. The latter work was carried out in conjunction with the various sports bodies. Improvements now on domain: Trees and sand-barriers. Used for military manœuvres and general recreation. Proposed operations for ensuing year: Planting trees, extending sand-barriers, and sowing binding-grass. A committee has been formed to make arrangements for the holding of a bazaar to raise funds for the works.

DUNEDIN DOMAIN.

Part of Dunedin Town Belt. Area, 52 acres and 6 perches.

Work done during year: Hardy fernery altered, extended, and roofed with manuka scrub, new flower beds and borders trenched and stocked, trees and shrubs planted out, iris and rose gardens extended, new bamboo and flax garden formed, water-service extended, and a row of frames placed in nursery. Improvements now on domain: Winter garden, Superintendent's and watchman's house, two propagating-houses with frames, nursery, potting-shed, tool-shed, ladies' cloak-room, fernery, iron gates, three bridges, aviary, water-lily tank, three ponds, fences, rock garden, flower beds and borders, plantations, seats, and band-rotunda. Used as a botanic garden and for picnics, football, cricket, and band concerts. Proposed operations for ensuing year: Clearing away trees and hedges and planting a maze with holly, erecting new bridge, extending rock garden, extending rose and herbaceous gardens, clearing gorse, broom, and elderberry, and extending water-supply to fernery. The gardens are still a great attraction, and the attendance of visitors has been well maintained. A display of 275 chrysanthemums grown in pots was greatly appreciated. The number of trees, shrubs, and plants in the nursery is 29,248. 52,717 seeds, bulbs, and plants have been sent out, and 5,752 received.

DUNROBIN DOMAIN.

Section No. 31, Block VIII, Crookston Survey District. Area, 12 acres.

Work done during year: Fences renewed, and domain sown down in grass. Proposed operations for ensuing year: Draining.

DUNSTAN DOMAIN.

Section No. 72, Block I, Leaning Rock Survey District. Area, 135 acres 3 roods 21 perches. Used for races.

DUNTROON DOMAIN.

Section No. 23, Block IV, Maruwenua Survey District. Area, 80 acres.

Work done during year: Gorse cleared, rabbits kept down, fencing erected, trees planted, grass sown, and road formed through domain: Improvements now on domain: Rabbit-proof fencing, fence enclosing sports-ring, 700 trees, and conveniences. Used as a rifle range and for grazing and picnics. Proposed operations for ensuing year: Keeping down rabbits and clearing gorse.

GREEN ISLAND DOMAIN.

Section No. 1, Block XIV, East Taieri Survey District. Area, 372 acres 2 roods 4 perches.

Work done during year: Marram-grass and lupins and 200 trees planted, the latter being protected with posts and wire netting. Leased.

GREENWICH SQUARE DOMAIN.

Section No. 18, Block VI, Town of Waihola. Area, 1 acre 1 rood 11 perches.

Work done during year: Whole domain, with the exception of portion used for school garden, cultivated and laid down in grass, hedges trimmed, noxious weeds kept down, and fences, gates, and walks kept in repair. Improvements now on domain: Fencing, gates, macrocarpa hedge, gravel walks, and grassing. Used for general recreation. A portion is used for a school garden Proposed operations for ensuing year: Planting trees and shrubs, and general maintenance and repairs.

HAVELOCK (WAITAHUNA) DOMAIN.

Section No. 21, Block XXXII, Town of Havelock. Area, 5 acres 1 rood 32 perches
Improvements now on domain: Fences and belt of macrocarpa trees. Used for sports, football, cricket, tennis, and general recreation.

HAWEA DOMAIN.

Section No. 19, Block IV, Lower Hawea Survey District. Area, 107 acres 1 rood 8 perches.

Timber has been purchased for seating accommodation. Improvements now on domain: Fences, gates, plantation, horse-yard, booth, racing-track, and grassing. Used for races, sports, and picnics. Proposed operations for ensuing year: Tree-planting.

HERIOT DOMAIN.

Section No. 2, Block I, Town of Heriot. Area, 9 acres 3 roods 9 perches.

Work done during year: Pavilion altered and repaired, and fences attended to. Improvements now on domain: Fences and building. Used for general recreation.

HYDE DOMAIN.

Sections Nos. 51, 52, 54, 55, 57, and 58, Block VII, Rock and Pillar Survey District. Area, 79 acres 2 roods 29 perches.

Work done during year: Racecourse improved. Improvements now on domain: Fencing and racecourse. Used for races and as a rifle range. Proposed operations for ensuing year: Ploughing and sowing down in grass about 30 acres, erecting netting fence, laying pipes to bring water to the domain, and, if the season is favourable, planting trees.

KAITANGATA DOMAIN.

Sections Nos. 1 to 15, Block XXVI, and 5, Block XLVI, Town of Kaitangata. Area, 68 acres 1 rood 38 perches.

Work done during year: General maintenance. Improvements now on domain: Fences, hedges, gates, drains, plantations, lawns, walks, tennis-court, grandstand, and pavilion. Used for sports, picnics, football, and cricket. Sixty acres leased.

KARITANE DOMAIN.

Sections Nos. 7, 8, 10, 11, 12, 13, 14, and 15, Block IX, and 2, Block XXIV, Town of Waikouaiti, and 24, Block VI, Hawksbury Survey District. Area, 37 acres 1 rood 4 perches.

Work done during year: Well sunk, and surrounded with a fence. Improvements now on domain: Plantations, fences, protective works, marram-grass, and well. Used for picnics and general recreation. Proposed operations for ensuing year: Erecting flood-gates.

KUROW DOMAIN.

Allotment No. 2A of Subdivision of parts of Sections Nos. 5 and 14, Block I, and 10 and 11, Block IV, Kurow Survey District. Area, 12 acres 1 rood 13.8 perches.

Work done during year: Fencing erected. The domain has been leased, and is to be sown in grass at the termination of the lease.

LAUDER DOMAIN.

Section No. 2, Block III, Lauder Survey District. Area, 200 acres.

Work done during year: Ten acres sown in grass, and grandstand repaired. Improvements now on domain: Fences, gates, grandstand, stewards' stand, totalisator-house, judge's box, paddocks fenced off, enclosure for Plumpton, water-race, pond, boat, and plantation. Used for races and coursing. Proposed operations for ensuing year: Erecting new grandstand.

MAHENO DOMAIN.

Part of Section No. 2 of 22, Block VII, Oamaru Survey District. Area, 47 acres 3 roods 19 perches.

During the year advice was obtained as to the obtaining of a supply of water by a ram; but it was found that there was not sufficient pressure. Tenders were then called and accepted for the erection of a windmill. Improvements now on domain: Fencing, plantations, creamery, and dwelling. Used for grazing, football, and picnics. Proposed operations for ensuing year: Erecting windmill, with water-trough and overflow-pipe.

MANUHERIKIA DOMAIN.

Section No. 1, Block XXXVII, Town of Alexandra. Area, 96 acres 3 roods 5 perches.

Work done during year: Trees planted and water-supply improved. Improvements now on domain: Fences and trees. Used for races, golf, and football. Proposed operations for ensuing year: Planting trees and erecting pavilion.

MAUNGATUA DOMAIN.

Section No. 22, Block XI, Maungatua Survey District. Area, 566 acres. Used for picnics and grazing.

MID-WAKATIPU DOMAIN.

Section No. 39, Block IV, Mid-Wakatipu Survey District. Area, 400 acres.

This domain is under the control of the Commissioner of Crown Lands, Dunedin. No works have been undertaken.

MOA FLAT AND ETTRICK DOMAIN.

Section No. 44, Block I, Benger Survey District. Area, 420 acres.

This domain is administered by the Commissioner of Crown Lands, Dunedin, and is held under pastoral license.

MOERAKI DOMAIN.

Sections Nos. 15, Block II, 13, Block III, and 4, 5, 6, and 7, Block XIV, Town of Moeraki. Area, 23 acres 3 roods 34 perches.

Work done during year: Trees planted and fenced in. Improvements now on domain: Fences, gates, and trees. Leased. Proposed operations for ensuing year: Planting trees, and making entrance to bath-paddock.

NASEBY DOMAIN.

Section No. 23, Block I, Naseby Survey District. Area, 120 acres.

Improvements now on domain: Grandstand, offices, racing-track, and fences. Used for racing.

OCEAN BEACH DOMAIN.

Sections Nos. part 28 and 31, Block VII, Otago Peninsula Survey District, and 4 and 6, Block XII, Dunedin and East Taieri Survey Districts. Area, 221 acres 2 roods 11 perches.

Steady progress has been made in connection with this domain during the year. The road to the beach at St. Kilda has been extended and widened, the new portion being covered with rotten rock. The entrance from Beach Street, St. Clair, to the beach has been improved by the erection of steps, the material and expert labour being provided by the Dunedin City Council. A septic tank and conveniences have been erected at the baths. Scrub and wire fencing and planting grass have also been done. A new track, about 30 chains in length, has been cut, and a pathway made through the lupins on the old lagoon-site, the formation being of sand, covered with rotten rock. To the right and left of this path are hollows and dunes. The latter will in due course be levelled, and will form part of the Marine Park, which will be sheltered in all weathers. The Board has made inquiries regarding hot salt-water baths, and will proceed with the erection of two forthwith, increasing the number later on if found to work satisfactorily and the public requires them. Fencing and grass-planting will be carried on during the ensuing year, and the matter of tree-planting will also receive attention.

Otokia Domain.

Section No. 47, Block I, Otokia Survey District. Area, 12 acres 2 roods.

Work done during year: Notice-board erected to warn bathers, and life-buoy and line procured. Improvements now on domain: Fencing, post-and-chain horse-stand, notice-board, life-buoy and line. Used for grazing and picnics and sports.

OTUREHUA DOMAIN.

Section No. 289, Block I, Blackstone Survey District. Area, 7 acres and 20 perches.

Work done during year: Domain ploughed and sown in grass, and 200 willow-trees planted. Improvements now on domain: Ploughing, grassing, and willow-trees. Used for general recreation. Proposed operations for ensuing year: Protecting trees with wire netting, and further planting.

OUTRAM DOMAIN.

Sections Nos. 31 and 32, Block VII, Maungatua Survey District, and 14 to 20, and 22, Block I, and 7, Block XV, Town of Outram. Area, 402 acres 1 rood 5 perches.

Work done during year: Fences repaired and maintained, and hedges trimmed. Improvements now on domain: Buildings, plantations, hedges, fences, swings, seats, water-supply, bowling-green, and tennis-court. Used for bowls, cricket, tennis, picnics, sports, cycling, football, general recreation, and grazing. Proposed operations for ensuing year: General maintenance, and asphalting tennis-court.

OWAKA TOWNSHIP DOMAIN.

Section No. 111 (formerly part of Section No. 3), Block VIII, Glenomaru Survey District. Area, 3 acres 3 roods 0.8 perches.

During the year a crossing was formed over the railway-line at the nearest point of the domain to the township, and a gate and turnstile erected. This work was carried out by the Owaka Rifle Corps. Improvements now on domain: Tennis-court, swings, fences, gates, and turnstile. Used for football, sports, shows, picnics, and military manœuvres. Proposed operations for ensuing year: Ploughing and grassing.

PALMERSTON DOMAIN.

Sections Nos. 5 to 18, Block XVI, Town of Palmerston. Area, 3 acres 2 roods.

Work done during year: Fences repaired. Improvements now on domain: Boundary-fence. Used for cricket, football, and general recreation.

POUNAWEA DOMAIN.

Sections Nos. 31, 53, 54, 55, 58, 59, 60, and 61, and a closed road, Block VI, Glenomaru Survey District. Area, 13 acres 1 rood 16 perches.

Work done during year: Two acres cleared, stumped, burned, and prepared for cultivating, and 5 chains fencing erected. Improvements now on domain: Eighteen chains fencing, of which 5 chains is wire netting, 4 acres cleared and sown in grass, trees, and gate. Used for camping and picnics, also by tourists. Proposed operations for ensuing year: Removing and re-erecting about 5 chains fencing, erecting rails around trees, and stumping, clearing, and burning an area, and sowing it down in grass.

QUEENSTOWN DOMAIN.

Blocks LIV, LV, and LVI, Town of Queenstown. Area, 7 acres and 19 perches.

During the year about half the area was fenced, and planted with trees and shrubs. Improvements now on domain: Fences and trees. Used for forestry purposes. Proposed operations for ensuing year: Fencing remainder of domain and planting trees.

RANFURLY DOMAIN.

Sections Nos. 1 to 15, Block XIII, Town of Ranfurly. Area, 10 acres 2 roods 36 perches.

Work done during year: Domain ploughed, harrowed, levelled, and sown in grass, and two tennis-courts formed. Proposed operations for ensuing year: Planting trees and sowing grass.

RANFURLY PARK DOMAIN.

Suburban Sections Nos. 7 and 8, Block I, Town of Ranfurly. Area, 52 acres and 31 perches.

Improvements now on domain: Racecourse. Used chiefly for races. Proposed operations for ensuing year: Fencing domain. It is then proposed to lease it for grazing.

RECORD REIGN DOMAIN.

Section No. 1, Block LXXXIX, Town of Cromwell. Area, 4 acres.

Work done during year: General maintenance. Permission was granted to the local tennis club to use portion of the domain for tennis. During the year the Caledonian Society removed its pavilion to other grounds. Improvements now on domain: Twenty-five chains fencing, trees, and conveniences. Used for tennis, picnics, and general recreation. Proposed operations for ensuing year: Planting trees and improving seating accommodation.

ROSLYN DOMAIN.

Section No. 7, Block X, Dunedin and East Taieri Survey District. Area, 12 acres 2 roods 28 perches.

Work done during year: Tracks repaired, drains opened, and weeds cut. Leased for grazing.

ST. BATHAN'S DOMAIN.

Section No. 25, Block II, St. Bathan's Survey District. Area, 23 acres 1 rood 5 perches.

Improvements now on domain: Forty-five chains fences, four gates, trees, hedges, curling and skating pond, football and cricket grounds, and two running-tracks. Used for sports, picnics, and general recreation. Proposed operations for ensuing year: Removing broom as soon as funds permit.

TAIERI LAKE DOMAIN.

Sections Nos. 12 and 18, Block XI, and 2, Block XII, Manitoto Survey District, and 67 to 81, Town of Komako. Area, 436 acres and 39 perches.

Improvements now on domain: Fencing, plantations, and embankments. Proposed operations for ensuing year: Fencing and tree-planting

TOKOMAIRIRO DOMAIN.

Parts of Sections Nos. 103 and 104, Block XII, Tokomairino Survey District. Area, 59 acres 2 roods 30 perches.

Work done during year: Flower-beds and paths maintained, hedges trimmed, flowers, shrubs, and trees planted, and grounds generally maintained. Improvements now on domain: Pavilion, plantations, fences, drains, ponds, and paths. Used for football, cricket, and picnics. Proposed operations for ensuing year: Planting trees, shrubs, and flowers, improving swimming-pond, and general maintenance.

TROTTER'S CREEK DOMAIN.

Section No. 36, Block XI, Moeraki Survey District. Area, 183 acres and 11 perches.

Work done during year: Additional area cleared for recreation purposes, and entrance to domain improved. Improvements now on domain: Footbridge, seats, and tracks. Used for picnics. Proposed operations for ensuing year: Clearing undergrowth.

TUAPEKA DOMAIN.

Blocks XV, XVI, XVIII, XIX, XXXV, Sections Nos. 1 to 8, 10 and 13 to 16, Block XIV, 1 to 7 and 20, Block XVII, 1 to 6 and 17 and 18, Block XXXIV, 6, Block LIII, 3, 4, and 5, Block LIV, and three areas containing 1 rood, 2 roods 35 perches, and 3 roods 24 perches respectively, Town of Lawrence, and Sections Nos. 20 and 30, Block XIX, Tuapeka East Survey District. Area, 128 acres and 26 perches.

Work done during year: Trees, ornamental shrubs, and flowers planted, young trees and flower-plants staked, fences renewed and repaired, paths and walks maintained, and gorse and broom eradicated. The erection of a protection hedge with a view to enlarging the cricket-ground has been commenced. Used for cricket, football, shows, military encampments, and band concerts. Proposed operations for ensuing year: Planting trees, and generally improving the domain.

WAIHEMO DOMAIN.

Section No. 74, Block IV, and parts of Sections No. 56 and 58, Block X, Moeraki Survey District. Area, 139 acres 1 rood 5 perches.

Work done during year: Planting, and sowing and cutting grass. Improvements now on domain: Boundary-fence and plantation. Used for general recreation and grazing. Proposed operations for ensuing year: Planting.

WAIKOUAITI DOMAIN.

Situated in Town of Hawksbury. Area, 448 acres 2 roods 26 perches.

Work done during year: Old cricket-pavilion raised 18 in., and wooden floor put in, and exterior of building painted; verandah added to new pavilion, and outside walls and roof painted; conveniences erected; and some seats placed on the recreation-ground. Improvements now on domain: Canal and connecting drains, fencing, large reclaimed area, plantations, embankments, bridges, pavilions, bowling-greens, and tennis-courts. Used for sports, races, picnics, bowls, tennis, cricket, football, hockey, and grazing. Proposed operations for ensuing year: Further reclamation and tree-planting.

WAIPAHI DOMAIN.

Section No. 14, Block VII, Town of Waipahi. Area, 5 acres 2 roods 16 perches.

Work done during year: Trees planted, and fence erected to protect them. Improvements now on domain: Fencing and trees. Used for picnics and general recreation.

WANAKA ISLANDS DOMAIN.

Manuka or Pigeon Island, Crescent or Rabbit Island, the island in Stevenson's Arm, and Merino or Roy's Island, all in Lake Wanaka; Sections Nos. 1, Block XIII, and 29, Block XIV, Lower Wanaka Survey District, and 1 to 4, Block XIV, 1 to 3, Block XV, I to 6 and 8 to 14, Block XVI, and 1 to 16, Block XVII, Town of Pembroke. Area, 1,007 acres 2 roods 30 perches.

Work done during year: Tracks repaired and extended, seating accommodation provided, and domain generally rendered more attractive. Improvements now on domain: Fencing, hut, wharves, marram-grass, and planting. Used for picnics, sports, as a sanctuary for flightless birds, and by the lovers of nature's grandeur. Proposed operations for ensuing year: Maintaining existing roads and tracks, extending others, attending to shrubbery and wharves, and generally adding to the facilities contributing to the gratification of visitors.

WANGALOA DOMAIN.

Part of Section No. 8, Block VII, Coast Survey District. Area, 32 acres 3 roods 13 perches. Improvements now on domain: Fences, drains, and plantations. Used for picnics and sports.

WILLSHER DOMAIN.

Sections Nos. 1, 3, and 4 of 16, and an intersecting road-line, Block VII, South Molyneux Survey District. Area, 14 acres and 39 perches.

Work done during year: Tennis-court completed. Improvements now on domain: Draining, seats, tennis-court, fences, and trees. Used for sports and picnics.

SOUTHLAND LAND DISTRICT.

BRYDONE DOMAIN.

Section No. 152E, Block II, Brydone Village. Area, 4 acres 3 roods.

Work done during year: Domain sown in oats and grass, gorse hedge on southern boundary removed and replaced by post-and-wire fence, and gate erected. Improvements now on domain: Fencing and grassing. Proposed operations for ensuing year: Preparing the domain for recreation, and planting trees.

CALCIUM DOMAIN.

Sections Nos. 16 and 17, Block I, Town of Calcium. Area, 3 roods 36 perches.

Improvements now on domain: Fences and gate. The domain provides access to the public hall, and is also used as a grazing-ground for school-children's horses. Improvements are effected voluntarily. Proposed operations for ensuing year: Repairing fences and grubbing gorse.

CLIFDEN DOMAIN.

Section No. 5, Block I, Lillburn Survey District. Area, 73 acres 3 roods 3 perches.

Work done during year: Fencing erected and grass sown. Improvements now on domain: Racecourse, draining, grassing, fencing, and clearing. Used for sports, picnics, and races. Proposed operations for ensuing year: Resoiling 26 chains of the racecourse.

CROYDON BUSH DOMAIN.

Sections Nos. 819 and 885, Block LXIX, Hokonui Survey District. Area, 430 acres and 30 perches.

Work done during year: Rabbits destroyed. Improvements now on domain: Fencing. Used by picnic parties from the surrounding districts.

DIPTON DOMAIN.

Section No. 3, Block X, Town of Dipton. Area, 5 acres.

Improvements now on domain: Fences, trees, shelter-shed and outhouses, concrete well, and seats. Used for sports and picnics.

FORTROSE DOMAIN.

Section No. 42, Block IV, Town of Fortrose. Area, 10 acres.

Work done during year: Fence made sheep-proof. Improvements now on domain: Three acres plantation, fencing, hedge, and hut. Used for sports and picnics. Proposed operations for ensuing year: Forming a running-track.

GORE DOMAIN.

Situated in Towns of Gore and East Gore. Area, 92 acres 3 roods 32 perches.

Work done during year: General maintenance, and 1½ acres laid down in grass. Improvements now on domain: Fences, plantations, gardens, two bowling and two tennis pavilions, two bowling-greens, and four tennis-courts. Used for tennis, bowls, cricket, football, and military camps. Proposed operations for ensuing year: General maintenance.

HIRSTFIELD DOMAIN.

Sections Nos. 1, Block X, 4, Block XI, and 1, Block XVII, Town of Hirstfield. Area, 23 acres and 24 perches.

Work done during year: Football and cricket ground cleared and chipped. Improvements now on domain: Fences, hedges, and plantation. Used for sports, cricket, football, picnics, general recreation, and grazing. Proposed operations for ensuing year: General improvements.

HOWELL'S POINT DOMAIN.

Portions of Sections Nos. 22 to 28, Block II, and Sections Nos. 46 to 48, Block I, and 20, Block II, Jacob's River Hundred. Area, 105 acres 3 roods 30 perches

Work done during year: Marram-grass planted. Improvements now on domain: Thirty-nine chains fencing. Used for picnics.

LIMEHILLS DOMAIN.

Sections Nos. 1 to 7 and 9 to 17, Block IV, Town of Limehills. Area, 4 acres 1 rood 6 perches.

Work done during year: Asphalt tennis-courts laid down, and fences and gates erected.

This was done by the tennis and cricket clubs. Improvements now on domain: Fences, drains,

trees, sheds cricket-pitch, tennis-court, and gates. Used for cricket, tennis, and sports. Proposed operations: Cutting gorse, trimming trees, and repairing fences.

LUMSDEN DOMAIN.

Sections Nos. 1 to 6, Block XXIII, Town of Lumsden. Area, 19 acres 1 rood 4 perches.

Improvements now on domain: Fences, pavilion, quarter-mile running track, and plantation. Used for sports and picnics.

MARAREWA DOMAIN.

Section No. 1, Block VIII, Town of Makarewa. Area, 13 acres and 18 perches.

Improvements now on domain: Ploughing, grassing, and fencing. Used for general recreation. Proposed operations for ensuing year: Cutting drains and watercourses.

MATAURA DOMAIN.

Sections Nos. 39, 40, and 41, Block XVII, Town of Mataura Bridge, and 13, Block XII, Town of Mataura. Area, 18 acres 1 rood 18 perches.

Work done during year: Belt of trees removed and replaced by young trees, and an area ploughed and sown in grass. Improvements now on domain: Fences and trees. Thirteen acres leased on improvement conditions.

OMAUI DOMAIN.

Section No. 69, Block V, Campbelltown Hundred. Area, 158 acres 2 roods 29 perches. Not used by the public. Covered with native bush, which is being protected.

OTAUTAU DOMAIN.

Section No. 5, Block II, Aparima Hundred. Area, 63 acres 2 roods.

Work done during year: Road formed. Improvements now on domain: Roads, fencing, grassing, and trees. Leased for grazing. Proposed operations for ensuing year: Completing formation of road.

PUKERAU DOMAIN.

Sections Nos. 8, 9, 10, and 11, Block V, Town of Pukerau. Area, 4 acres.

Work done during year: Domain ploughed and sown in grass. Improvements now on domain: Fences and plantations. Used for cricket and picnics.

RIVERTON DOMAIN.

Sections Nos. 18, 19, 21, 22, 23, and part 24, Block XXV, Jacob's River Hundred. Area, 10 acres 1 rood 34 perches.

Improvements now on domain: Twenty-six chains close weatherboard fence, plantations, cottage, caretaker's hut, and ticket office. Used for sports, picnics, football, and cricket.

SOUTH INVERCARGILL DOMAIN.

Section No. 33A, Town of Seaward Bush. Area, 2 acres 2 roods 35 perches.

Improvements now on domain: Fences, stumping, and levelling. Used principally as a children's playground.

TE ANA DOMAIN.

Section No. 48, Block VII, Waiau Survey District. Area, 2 acres and 29 perches. This domain is under the control of the Tourist Department. Used as a scenic reserve.

TOKANUI DOMAIN.

Sections Nos. 9 to 15, Block II, Town of Tokanui. Area, 4 acres 3 roods 19 perches.

Work done during year: Rabbits trapped and noxious weeds cut. Improvements now on domain: Fencing and cultivating. Used for sports. Proposed operations for ensuing year: Planting shelter-trees.

WINTON DOMAIN.

Sections Nos. 1 to 5, 7 to 12, 17 to 22, and 24 to 28, Block IX, 1 to 5, 7 to 13, 17 to 23, and 25 to 29, Block X, 1 and 32, Block XI, 1 and 27, Block XII, 1 and 23, Block XVI, 1 and 24, Block XVII, and 1 and 24, Block XVIII, Town of Winton. Area, 14 acres.

An area has been resumed for plantation purposes. Improvements now on domain: Fences, trees, buildings, tennis-courts, pavilion, and cultivation. Used for general recreation and grazing.

WYNDHAM DOMAIN.

Section No. 66, and a lagoon of 12 acres in Block VI, Town of Wyndham. Area, 25 acres.

Work done during year: Weeds cleared from shrubs and trees, noxious weeds eradicated, and fencing erected. Improvements now on domain: Trees, shrubs, flowers, fencing, and drains. Used as a public resort. Proposed operations for ensuing year: Planting trees, keeping plantation in order, and fencing.
