## SCHEDULE No. 3A.

## TROTTING CLUBS.—RECOMMENDATIONS.

*Auckland T.C.*—We recommend reducing its autumn meeting by one day, railing the inside of trotting-track, and carrying out necessary improvements, including all requisite equipments for the sport and proper sanitary arrangements.

*Otahuhu T.C.*—We recommend reducing its summer meeting by one day, railing the inside of trotting-track, and carrying out necessary improvements, including all requisite equipment for the sport and proper sanitary arrangements.

*Wanganui T.C.*—

*Hutt Valley T.C.*—We recommend acquisition of a permanent right to race at a fixed rental, and railing the inside of trotting-track, and proper sanitary and other arrangements.

*South Wairarapa T.C.*—We recommend acquisition of a permanent right to race at a fixed rental, and railing the inside of trotting-track, and proper sanitary and other arrangements.

*Nelson T.C.*—We recommend railing the inside of trotting-track, and suggest that tenure of course from Agricultural and Pastoral Association should be permanently fixed.

*Wairau Valley T.C.*—We recommend railing inside of trotting-track, and securing freehold tenure or permanent right to race at a fixed rental.

*New Zealand Metropolitan T.C.*—We recommend reducing the August and Easter meetings to two days each. Tenure not satisfactory: should be altered by obtaining freehold or permanent right to race at a fixed rental.
