

**GATE PA DOMAIN.**

Sections Nos. 41, 41A, 42, and part 13, Suburbs of Tauranga. Area, 12 acres 1 rood 37 perches.

During the year both portions of the domain have been cleared of gorse, and are now in good pasture or under cultivation, and the fences have been improved. Improvements now on domain: Fencing and grassing. Leased. Proposed operations for ensuing year: Laying down a tennis-court, croquet-lawn, and bowling-green, and planting shelter-trees.

**GRAHAMTOWN DOMAIN.**

Allotment No. 391, Village of Grahamtown. Area, 8 acres 1 rood 21 perches.

Work done during year: Bush felled and burned and tennis-court partially formed. Proposed operations for ensuing year: Cutting a drain, grubbing tea-tree, levelling, ploughing, and grassing the domain.

Work done during year: Lake Reserve laid down in grass, part of Seddon Park prepared for sowing down with grass in the autumn, cycle-track tarred and sanded, and general maintenance. It is proposed to complete laying down Seddon Park in grass, and to generally improve the recreation-grounds. Improvements on domain: Portion of Lake Reserve planted with trees and shrubs, banked asphalt cycle-track, conveniences, ladies' dressing-shed, grass cricket-pitch, fencing, and grassing. The domain is used for sports, football, cricket, hockey, and picnics.

**HELENSVILLE DOMAIN.**

Section No. 10, Block XIV, Kaipara Survey District. Area, 38 acres 2 roods 21 perches.

Work done during year: Tile drains laid down, and bowling-green, tennis-court, croquet-lawn, sports-paddock, flower-beds and borders formed. Used for bathing, sports, and as a pleasure-ground. Proposed operations for ensuing year: Completing tile draining, and forming ladies' swimming-bath and additional private baths.

**HOTEU DOMAIN.**

Section No. 34B, Block XII, Pakiri Survey District. Area, 16 acres 1 rood 5 perches.

**HOWICK DOMAIN.**

Suburban Sections Nos. 141 to 148, Town of Howick, and Allotment No. 15 of Section No. 7, Small Farms, near Howick. Area, 9 acres 2 roods 6 perches.

Work done during year: Two acres levelled and grassed, line of main drain refilled, and cricket-pitches top-dressed. A corner of the domain has been fenced off and planted with native trees. Improvements now on domain: Three tennis-courts, two small pavilions, 8 chains of 24 in.-pipe drain, and a small plantation of native trees. Used for cricket, tennis, and general recreation.

**HUKERENUI DOMAIN.**

Section No. 51, Block VI, Hukerenui Survey District. Area, 14 acres.

This domain is in its natural state.

**HUNUA DOMAIN.**

Section No. 89, Hunua Parish. Area, 40 acres 1 rood 6 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It contains a strip of bush along the stream.

**KAIWAKA DOMAIN.**

Section No. 125, Kaiwaka Parish. Area, 6 acres 1 rood 13 perches

This domain is under the control of the Commissioner of Crown Lands, Auckland. It contains some fine native bush.

**KATIKATI DOMAIN.**

Sections Nos. 25 and 26, Katikati Parish. Area, 185 acres 2 roods.

Work done during year: Erecting and repairing fences, pump erected, and pipes laid on. Improvements now on domain: Fencing, wells, pump and pipes, road, camping-ground, and tracks. Used for sports, picnics, camping, and regattas. Proposed operations for ensuing year: Constructing a road to give access to the domain, planting ornamental trees, and erecting a stone wharf.
