

PARNELL DOMAIN.

Allotments Nos. 89 of Section No. 1, 34 of Section No. 4, 5A of Section No. 14, and part of Lot 23 of Section No. 2, Suburbs of Auckland. Area, 10 acres 2 roods 25 perches.

Work done during year : Shrubs planted and grounds kept clear of gorse. Proposed operations for ensuing year : Forming paths, providing seats, and planting ornamental shrubs in the Point Resolution Reserve. Portion of the domain is leased.

PATUMAHOE DOMAIN.

Section No. S.W. 13, Waiau Parish. Area, 22 acres and 20 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It is situated on the Drury-Waiuku Road, and covered with fern and scrub.

PIRONGIA DOMAIN.

Allotments Nos. 510, 511, 512, and 513, Town of Pirongia East, the Town Belt of Pirongia East, and the Town Belt of Pirongia West. Area, 450 acres 3 roods 8 perches.

Portions of the domain have been cultivated and others partly cleared, ploughed, and grassed. Noxious weeds have been kept down. Used for grazing. Proposed operations for ensuing year : Keeping down noxious weeds on grassed land.

PLUMER DOMAIN.

Sections Nos. 11, 12, and 20, Plumer Hamlet, Parish of Waipareira. Area, 10 acres and 38 perches.

Work done during year : Gorse grubbed and ploughed, and ornamental trees planted. Improvements now on domain : Fencing, seats, and conveniences. Used for picnics. The Board has let the right to cater for picnics for a period of three years. Proposed operations for ensuing year : Grassing.

POKENO DOMAIN.

Allotment No. 138 of Section No. 1, Pokeno Settlement, Opaheke Survey District, and Section No. 154, Maungatawhiri Parish. Area, 132 acres and 4 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland. It consists of steep and broken land. Used for grazing. Leased on a year-to-year tenancy, the lessee being required to eradicate noxious weeds.

PUHOI DOMAIN.

Section No. 130, Parish of Puhoi. Area, 3 acres.

PUKAPUKA DOMAIN.

Section No. 82A, Parish of Mahurangi. Area, 27 acres.

Nil report furnished.

PUKEKARORO DOMAIN.

Section No. S. 79, Kaiwaka Parish. Area, 73 acres and 32 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland.

PUKEKOHE DOMAIN.

Allotment 5A of Suburban Section No. 2, Parish of Pukekohe. Area, 3 acres 3 roods 34 perches.

Report not furnished. Board appointed to control domain on the 7th August, 1911.

PUNIU DOMAIN (PART OF).

Section No. 54A, and Allotments Nos. 6 and parts of 5, 7, and 8 of Section No. 236, Mangapiko Parish. Area, 15 acres and 20 perches.

Work done during year : General maintenance, boundary-fences repaired, gates and fencing around bowling-greens and tennis-courts painted, dead shrubs replaced, hedges trimmed, and flower-beds attended to. A Coronation band-rotunda has been erected on the domain. Improvements consist of fencing, plantations, pavilion, band-rotunda, cast-iron seats, summer and winter bowling-greens, tennis-courts, croquet-lawns, and athletic track. Used for general recreation. Proposed operations for ensuing year : Erecting concrete tanks and windmill for the permanent water-supply; other works include the replacement of dead trees and painting the pavilion.

PUNIU DOMAIN (PART OF).

Part of Section No. 223, Parish of Puniu. Area, 7 acres and 32 perches.

This domain is under the control of the Commissioner of Crown Lands, Auckland. Improvements now on domain : Fencing, ploughing, clearing, and grassing.

RAGLAN DOMAIN.

Lots 6, 8, and 9 of Section No. 14, Town of Raglan. Area, 1 acre 1 rood 5 perches.

A Domain Board was appointed to have control of the domain on the 8th February, 1911. The Board proposes to lease the domain on improvement-conditions.
