Praying to have the Hospitals and Charitable Aid Act amended, and to have the Okarito and Okuru Ridings excluded from the operation of the Act; and that a special Act be passed enabling the Westland County Council to hand over to a Board of Trustees that portion of the rates from Okarito and Okuru Ridings which that body formerly paid into the funds of the Hospital and Charitable Aid Board at Hokitika.

The Committee recognizes that the shortening of the hours for the retail sale of liquor during the war period would undoubtedly lessen drinking, and so contribute to the financial strength of the Dominion and the physical and moral good and efficiency of the people. The Committee therefore recommends the prayer of the petition to the favourable consideration of the Government.
