The total funds of the societies and branches as on the 31st December, 1924, amounted to £2,955,340, made up as follows: Sick and Funeral Funds (inclusive of amounts transferred to special funds out of surplus, £2,753,971; Medical and Management Funds, goods, &c., £201,369. Dividing the total funds by the number of members at the end of the year it is found the average capital per member is now £33 16s.
