McC. Dickson, Mr. Edie, Mr. Girling, Mr. Holland, Mr. Hudson, Mr. Macmillan, Mr. O'Brien, Mr. Parry, Mr. Poland, Mr. T. W. Rhodes, Mr. Smith, and the mover."—(Hon. Mr. ANDERSON.)
