Ordered, "That a Select Committee be appointed, consisting of ten members, to consider all matters relating to public health, infectious diseases, contagious diseases, hospitals, and to local authorities having charge of these matters, and to such other matters affecting public health as may be referred to it; to have power to call for persons and papers; three to be a quorum: the Committee to consist of Mr. Clinkard, Mr. Hawke, Mr. Healy, Sir George Hunter, Mr. Jenkins, Mr. Munro, Mr. Parry, Mr. Sykes, Mr. Young, and the mover."—(Hon.
