ORDERS OF REFERENCE.

Extracts from the Journals of the House of Representatives.

TUESDAY, THE 21ST DAY OF JULY, 1931.

Ordered, "That a Native Affairs Committee, consisting, by leave, of fifteen members, be appointed to consider all petitions, reports, returns, and other documents relating to affairs especially affecting the Native race that may be brought before the House this session, and from time to time to report thereon to the House; with power to call for persons and papers; three to be a quorum: the Committee to consist of Mr. Broadfoot, Mr. Clinkard, the Right Hon. Mr. Coates, Mr. Healy, Mr. Henare, Mr. Howard, Mr. Langstone, Mr. Makitanara, Mr. Martin, Mr. O'Brien, Captain Rushworth, Mr. Taite te Tomo, Mr. Waite, Mr. Williams, and the mover."—(Hon. Mr. VEITCH for Hon. Sir APIRANA NGATA.)

TUESDAY, THE 28TH DAY OF JULY, 1931.

Ordered, "That all petitions not finally dealt with during the session of 1930 be again referred to the same Committees as they were referred to during the said session, and that all petitions received during the first session of 1931 be dealt with as if they had been received this session."—(Right Hon. Mr. FORBES.)
