ORDER OF REFERENCE.

*Extract from the Journals of the House of Representatives.*

FRIDAY, THE 6TH DAY OF OCTOBER, 1933.

*Ordered*, "That a Select Committee be appointed, consisting of ten members, to whom all Local Bills shall stand referred after the first reading; the Committee to report whether the Standing Orders have been complied with, whether the rights or prerogatives of the Crown are in any way affected by the provisions of the Bills, and to recommend such amendments as it may think proper, and to report, when necessary, on the merits of the Bills; the Committee to have power to confer with any Committee appointed for a similar object by the Legislative Council; the Committee to consist of Mr. Ansell, Mr. Armstrong, Mr. Hawke, Mr. Jull, Mrs. McCombs, Mr. W. Nash, Mr. Smith, Mr. Veitch, Mr. Wright, and the mover."—(Hon. Mr. HAMILTON for the Hon. Mr. YOUNG.)
