The Duke of Newcastle has communicated to me a copy of a Despatch which he has addressed to the officer commanding the troops in New Zealand on the same subject, under date of the 12th of June, 1854, of which I enclose a copy. It will there be seen that it is not within the contemplation of her Majesty's Government that any portion of the charge to be incurred for the defence of New Zealand should be defrayed by the Imparial Treasury.
