Verdict—Accidental death.

An inquest was held at Lincoln, Christchurch district, on the 9th instant, before J. W. S. Coward, Esq., Coroner, on the body of Betsy Rollo, aged six years, who died of congestion of the lungs. Verdict—Natural causes.

An inquest was held at the Lunatic Asylum, Christchurch, on the 14th instant, before J. W. S. Coward, Esq., Coroner, on the body of Robert Jones, aged thirty-eight years, who died of exhaustion. Verdict— Natural causes.
