JAMES MORIARTY *alias* "TROTTERS," arrested by Detective Brown, Hokitika Police, charged on warrant with using threatening language, has been ordered to find sureties to keep the peace for one month, in default one month's imprisonment.

LUCY JACKSON, arrested by Constable Hams, Hokitika Police, charged with larceny of women's wearing apparel, value £1, has been sentenced to fourteen days' imprisonment.

CATHERINE MARTIN and BRIDGET MARTIN, arrested by Detective Hams, Hokitika Police, charged on warrant with disobeying a summons to a witness, have been cautioned and discharged.

WILLIAM DUGGAN and GEORGE JAMES REID, arrested by Constable Brennan, Hokitika Police, charged with wilful destruction of property, have each been sentenced to pay a fine of £1, and 10s. damages for property destroyed or to be imprisoned for 72 hours.

THOMAS BAILEY, arrested by Detective Dyer, Hokitika Police, charged with vagrancy, sec. 4, clause 3, has been sentenced to be imprisoned for 14 days.

PETER PRICE, arrested by Detective Dyer, Hokitika Police, charged with using obscene language in a public place, assaulting the police whilst in the execution of their duty and wilful destruction of Government property, has been sentenced for the first offence to pay a fine of £2, or to be imprisoned for four days, second offence fourteen days' imprisonment, third charge dismissed.

ROBERT MILLER STEWART, arrested by Detective Dyer, Hokitika Police, charged on warrant with violent assault, has been sentenced to pay a fine of £5 or to be imprisoned for one month.

EMILE HUSKENSEN, *alias* CHARLES ALBERT, *alias* "GERMAN CHARLEY," arrested by Detective Dyer, Hokitika Police, charged with suspicion of larceny of two deposit receipts has been discharged.

PETER McGRATH, arrested by Constable Boyle, of the Greymouth Police, charged on warrant with horsetealing, has been discharged by the Hokitika Bench.

JOSEPH TAYLOR, arrested by Constable Burtenshaw,

Christchurch Police, charged on warrant with obtaining money upon false pretences at Hokitika, (*vide* "Police Gazette," Dec. 66, page 150) has been committed for trial by the Hokitika Bench, and sentenced to 12 month's imprisonment at Supreme Court.

DANIEL HAGARTY, arrested by Constable Boyle, Greymouth Police, charged with being drunk and disorderly, has been sentenced to fourteen days' imprisonment under the Vagrant Act.

JOHN WOODS, arrested by Constable Waters, Greymouth Police, charged with larceny, has been sentenced to four months' imprisonment.

JAMES BOWLES, arrested by Constable Grey, Greymouth Police, charged with larceny, has been sentenced to six months' imprisonment.

JOHN BUCKLEY, arrested by Constable Boyle, Greymouth Police, charged with vagrancy, has been sentenced to three months' imprisonment in default of finding sureties to be of good behaviour.

JAMES DRISCOLL, arrested by Constable Waters, Greymouth Police, charged with violently resisting and threatening a constable in the execution of his duty, has been fined £2, or 48 hours' imprisonment.

JOHN HALL, arrested by Sergeant McEnnis, Okarita Police, charged with assaulting one Janet McIntosh, has been fined 40s. and costs, in default fourteen days' imprisonment.

JOHN HALL, arrested by Sergeant McEnnis, Okarita Police, charged with assaulting one Robert McCanley, has been fined £5 and costs, in default fourteen days' imprisonment, to compute from the expiration of former sentence.

Inquests.

AN Inquest was held at Kaiapoi, on the 4th Feb. 1867, before C. Dudley, Esq., Coroner, on the body of Peter McKinlay, aged 60, labourer, who died from suffocation from hanging. Verdict—Suicide by hanging during temporary insanity.

AN Inquest was held at Timaru, on the 12th Feb., before Belfield Woolcombe, Esq., Coroner, on the body of Michael Garity, aged 31, a publican, who was killed through falling from his horse. Verdict—Accidentally killed.

A POLICE enquiry was held at Maori Gully, Greymouth, on the 9th Dec., 1866, on the body of Margaret McDonald, who died from the effects of intemperance. Result—Died from the effects of intemperate habits.
