Na reira, ka inoi ahau ki nga rangatira Maori katoa me te iwi nui kia tahuri kia awhina i tenei mahi tino nui. Kua e waiho kia eke rawa mai te hoa riri ki runga ki te pae ka korikori ai. I tawhiti ano ia e haere ana mai e hopu ana to ringa ki te patu. To patu ki to ringa mau ai inaianei.
