Kia 6s. i te eka i te tau mo te 21 tau tuatahi kia 5 paihenoti o te wariu whakapainga kore Kawanatanga i te timatanga o te 21 tau tuarua engari kaua e hokiho i te 6s. i te eka	That the block be leased to Te Pakitua Wharewera for a term of 21 years, with right of renewal for 21 years. Rental for the first 21 years to be 6s. per acre per annum and for the second 21 years 5 per cent. of unimproved Government valuation at commencement of that term, but not less than 6s. per acre.

Ko nga ritenga me penei: (1) Ko te reti kia £5 mo ia tau o te 15 tau tuatahi kia £10 mo ia tau o nga tau whakahounga; (2) kia wha tau o te reti e uti i te whakamananga; (3) me whakatakoto e Oliver Smith ki te Poari te utu e whakaritea e nga Maori me ia kia tac te wai kite whare nui i mua o te whakamananga; (4) ina mutu te rihi ko nga whakapainga katoa ka mahue ake ma nga Maori	That portion of the above block containing 3 roods 20 perches, situated between the Te Whaiti-Ruatahuna Road and the Whirinaki River, be leased to Oliver Smith for a term of 15 years, with right of renewal for a further 10 years, on the following conditions: (1) Rent to be £5 per annum for first term and £10 per annum renewed term; (2) four years' rent to be paid in advance on confirmation; (3) that the said Oliver Smith lodge with the Board an amount estimated by owners together with Mr. Smith as sufficient for the purpose of laying on water as far as the meeting-house, such sum to be lodged before confirmation is granted; (4) on expiry of lease all improvements to become the property of the owners.
