Mr. Clifford moved—"That the constitution of the N.Z. Jockey Club, as drafted at the Wellington Conference, be adopted."

Mr. O. H. Williams seconded.

The Hon. G. McLean moved as an amendment—"That the constitution of the N.Z. Jockey Club be postponed for further consideration at a conference to be held during the next session of Parliament."

This was seconded, and Messrs. Pearce, Donnelly, Williams, Stead, Hammond, Dr. Cleghorn and the chairman opposed the amendment, speaking very strongly in favour of Mr.

Clifford's motion.

Mr. Adams said, personally he was in favour of a N.Z. Jockey Club, but, as instructed by his club, the Nelson J.C., he had to vote against

The Hon. G. McLean and Mr. Driver said they were instructed by the Dunedin and Taranaki Jockey Clubs to oppose the proposal of Mr. Clifford.

Mr. Clifford eventually withdrew his motion in favour of Mr. McLean's amendment, which was carried.

It was resolved that the following words be inserted between the 1st and 2nd clauses of Racing Rule 22, viz.—"That if more than one Racing Rule 22, viz.—"That if more than one Selling Race appear on the programme of any day's racing, the added money to one of such races shall be computed as part of the added money for the purposes of this rule."

The question of the right of certain registered colours between Mr. S. H. Gollan and the Hon.

W. Reeves was, at the request of the Hawke's Ray I.C. reconsidered when it was received.

Bay J.C., reconsidered, when it was resolved—"That this Conference having considered the question, see no reason to alter their previous decision."

It was resolved that a sub-committeee consisting of Messrs. Clifford, Driver, Hammond and the secretary be appointed to consider the question of registration of colours generally,

and to draw up rules for submisssion to the next Conference.

We extract the following from the London Sportsman:—Two members of the sporting press were called before Lord Penrhyn, Lord Durham, Mr. Fitzwiiliam and Mr. Vyner at Doncaster, in reference to several paragraphs which had appeared with regard to the exclusion of the members of the press from the weighingroom. The above-named gentlemen, whilst pointing out that Mr. Edward Weatherby acted in accordance with Rule 130-which says that no person shall, without special leave from the Stewards, be admitted to the weighing-room, except the owner, trainer, jockey or other person having the care of a horse engaged in the race—denied that the order came from them. Moreover, Mr. Vyner wished it to be known that he was not present at Doncaster during the afternoon. Mr. Weatherby then stated that his instructions were received from a Steward of the Jockey Club. Members of the press are, of course, compelled to obey the law as enforced. At the same time we cannot help thinking that the closing of a channel of information against the legitimate use of the public is a step that might have been avoided.
