Amending Notification respecting Game in the Auckland District.

#### ARTHUR GORDON, Governor.

WHEREAS by a notification under "The Animals Protection Act, 1880," dated the thirteenth day of April, one thousand eight hundred and eighty-one, and published in the New Zealand Gazette of the fourteenth day of April, one thousand eight hundred and eighty-one, cock-pheasants and Californian and Australian quail were declared to be open to be taken or killed within the Auckland District during the period mentioned in the said notification : And whereas it is expedient to amend the said notification with respect to the game which may be taken or killed in the said district :

Now, therefore, I, Arthur Hamilton Gordon, the Governor of the Colony of New Zealand, in exercise of the powers vested in me by the said Act, do hereby amend the said notification, and declare that, in addition to the game described therein, henpheasants may be taken or killed within the said Auckland District, excepting in the Counties of Tauranga and Whakatane, during the period and under the conditions in the said notification mentioned.
