N pursuance and exercise of the power and authority in this behalf enabling me, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, do hereby fix and appoint that sittings of the District Courts of Nelson and Westland, for civil and criminal business, shall be held as follows, from and after the first day of January next, in lieu of those previously fixed and appointed:-
