Certain Provisions of "The Arms Act, 1880," suspended in the North Island.

## WM. F. DRUMMOND JERVOIS, Governor.

IN pursuance and exercise of the powers and authorities vested in him by "The Arms Act, 1880," His Excellency the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said Colony, doth hereby suspend, as from the date of the publication hereof in the New Zealand Gazette, the operation of all the provisions of the said Act in so far as they relate to all the provisions of the said Act in so far as they relate to the sale or purchase by any European or Europeans of arms, ammunition, gunpowder, lead, caps, or shot, for mining, sporting, or any useful or harmless purpose, in the district contained within the North Island and the adjacent smaller islands; and doth hereby further declare that from and after the date aforesaid the fee of one pound, payable in respect of a dealer's license in the Form B in the First Schedule to the said Act shall no longer be chargeable; and in exercise of the like powers, and with the like advice And in exercise of the like powers, and with the like advice and consent as aforesaid, His Excellency doth hereby make and prescribe the regulations set forth in the Schedule hereto as those upon which ammunition for the purposes aforesaid may henceforth be obtained by aboriginal natives within the district aforesaid.

REGULATIONS.

In these regulations the following terms and expressions shall, if not inconsistent with the context, have the meanings hereby attached to them, viz. :-
