#### Incendiarism.

ABOUT 4 a.m. on the 26th ultimo, at Kaiwaiwai, near Featherston, an old shed, of little value, the property of Wil-liam Bicknell, was maliciously destroyed by fire, as was also a stack of hay, value £30, the property of James Belcher. The property was not insured.

BREWEEN 5 p.m. on the 1st and 6 a.m. on the 2nd ultimo a bridge at Maungakaramea, Bay of Islands District, the property of George Kerr, was maliciously set on fire and damaged to the extent of about £7.

ABOUT 6.30 p.m. on the 24th ultimo, at Warahoe, Thames, a cow-shed, a shay-shed, a fowlhouse, a chaff-cutter, and about 4 tons of hay, the property of Naoma and Herbert Cooper, value £100, were destroyed by fire. At an inquest held on the 28th ultimo as to the cause of the origin of the fire the following verdict was returned: "That the cow-shed and contents were wilfully set on fire by some person or per-sons unknown, but there is no evidence to show by whom."

BETWEEN 9 p.m. on the 14th and 6 a.m. on the 15th ultimo, at Kahutara Road, Featherston, a threshing-machine, value £300, the property of Thomas George Bean and Hugh McPhee, was maliciously destroyed by fire. It was insured in the New Zealand Office for £200.

## Offences Not Otherwise Described.

Offences Not Otherwise Described. THOMAS ROONEY is charged, on warrant issued by the Oamaru Bench, with forging and uttering an order to William Smyth, at Oamaru, on the 2nd April last. Descrip-tion : A native of the County Kerry, a labourer, thirty-one years of age, 5ft. 7Åin. high, medium build, dark complexion, blue eyes, brown hair, darkish shaggy beard whiskers and moustache, scar on left temple, mark of cut on nose and near right eye; dressed in old grey-tweed paget-coat, dark-ish-tweed trousers, and black soft-felt hat. He was sen-tenced at Timaru, on the 29th October last, to three months' labour for larceny. (See *Police Gazette*, 1889, page 35.) He obtained goods from Mr. Smyth by means of the forged order.

JOHN JOHNSTONE is charged on warrant (Bench by whom issued not stated) with having, on the 8th November last, at Kaikohe, Bay of Islands, obtained a bank cheque for £4 from George W. S. Patterson by false protences. Descrip-tion: Supposed a native of the colony, a gum-digger, twenty-four years of age, 5ft. 7in. or 8in. high, medium build, darkish sallow complexion, thin and rather long features, light-brown or sandy hair, and small sandy mous-tache only; when last seen wore dark suit and soft-black hat; larrikin appearance. He was seen on the 23rd February last riding a horse from his parents' residence at Helensville, in the direction of Kaukapakapa. He obtained the cheque by falsely representing that he had about a ton of kauri gum for sale.

MATTHEW LAWRIE is charged, on warrant issued by the Warkworth Bench, with having, on the 18th March last, at Omaha, Auckland District, obtained 225 puriri posts, value £5 18s. 6d., from Thomas Felix Ashton by means of a value-less order for £5 15s. 6d., drawn on Messrs. Henderson and Spraggon, Auckland. Description: Supposed Irish, about thirty-eight years of age, 5ft. 7m. high, medium build, dark-brown hair, whiskers and moustache inclined to be sandy; when last seen wore dark coat, dark-check plaid trousers, and white-straw hat with a red-and-blue-ribbon band. At the time he committed this offence he was master of the cutter "Mahurangi."

PETER BIRRELL is charged, on two warrants issued by the Timaru Bench, with having, on the 7th June last, at Timaru, while acting as accountant to the Deputy Official Assigned, forged two receipts and acquittances for £385 and £12 11s. 3d. respectively, with intent to defraud the Govern-ment. Description: Scotch, an accountant, about sixty years of age, 5ft. 9in. or 10in. high, medium build, slightly stooped, fresh complexion, very grey hair beard whiskers and moustache, all worn short; may be dressed in a grey or greyish-brown tweed sac-suit. He was formerly in the Nelson Police. He was seen in Timaru on the morning of the 5th ultimo. He will endeavour to leave the colony.

JOHN W. WATSON is charged, on warrant issued by the Wellington Bench, with having, on the 4th ultimo, at Wel-lington, obtained £2 from George W. Smart by false pre-tences. Description : English, a clerk, about thirty years of age, 5ft. 5in. high, fair hair and complexion, sandy beard whiskers and moustache ; dressed in dark clothes and hard black-felt hat. Offender obtained the money on the dupli-cate of an order on the New Yorlead Shimir Commenter cate of an order on the New Zealand Shipping Company for £10, the original of which had been previously cashed by him. He is supposed to have gone to Foxton, and is said to be known to a man named Rogers, who owns a flax-mill there. there.

THOMAS EASTON WAUGH is charged, on warrant issued by the Dunedin Bench, with having, on the 21st day of July last, at Dunedin, embezzled the sum of £54, the property of the Government. Description: A native of Victoria, a clerk, twenty-six years of age, 5ft. 7in. high, slight build, sallow complexion, thin features, sharp prominent nose, dark-brown hair, and small light-brown moustache and side whiskers; generally wears blue-serge sac-suit and hard black-felt hat with low crown. While teller in the Post Office Savings Bank, Dunedin, he forged a depositor's application for a new bank-book, which he obtained, and then forged the depositor's signature to a receipt for the sum of £54, and converted the money to his own use. His defalcations amount to about £300. He left Dunedin on the 10th ultimo as a steerage passenger by the steamer "Wairarapa" for Melbourne, under the name of Easton, and expressed his intention of going thence to Sydney. He is known to Albert Price, of the New Zealand Insurance Office, Melbourne. He may try to leave for San Francisco.

ABOUT 1.15 a.m. on the 2nd ultimo, at Maungakaramea, Bay of Islands District, a draught gelding, value £5, the property of Frederick J. Snell, was maliciously fired at and wounded with a bullet, from the effects of which the animal died.

On the 4th ultimo a letter was received by a Mr. Tennet, who lives with his uncle, George Kerr, at Maungakaramea, Bay of Islands District, warning him to leave Kerr's house, as the latter had not long to live on account of his misdeeds in impounding his neighbours' cattle, and it was not wished to murder him (Tennet) in mistake for Kerr.

BETWEEN 5 p.m. on the 13th and 8 a.m. on the 14th ultimo a red-and-white heifor, about seven months old, which was impounded on the 10th ultimo in the pound of Frederick Cowern, at Manaia, was rescued from the pound.

LEONARD WILSON is charged, on warrant issued by the Danevirke Bench, with having, on the 14th ultimo, at Danevirke, obtained £10 from James Buck by means of a valueless cheque. Description: English, a lawyers' clerk, thirty - three or thirty - four years of age, 5ft. 9in. or 10in. high, slight build, very round shoulders, sallow complexion, top of nose very red, light-brown hair; may be wearing a brown-tweed suit and hard black-felt hat; addicted to drink and gambling. He acted as agent at Danevirke for Mr. Loughnan, solicitor, Waipawa. He left Danevirke on the 16th altimo for Wellington, and is supposed to have gone to Melbourne or Sydney. Mr. Sandilands, solicitor, Melbourne, is his father-in-law. There are other charges pending against him.

After having been checked they will be forwarded by this office to the respective post offices for payment. To prevent multiplication of vouchers, the instruction con-tained in Circular No. 19 of the 1st October, 1887, as to rendering claims for mileages once a month must be strictly adhered to.

I take this opportunity of pointing out that in criminal cases, where processes are served by constables, such con-stables are entitled only to a refund of the actual and necessary expenses incurred by them, as laid down in the Police

Regulations for Fishing for Trout, &c., Waitaki and Wai-mate Acclimatisation District.

#### ONSLOW, Governor.

ORDER IN COUNCIL.

At the Government House, at Wellington, this twenty-first day of May, 1889.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL. IN pursuance of the powers and authorities vested in him by "The Fisheries Conservation Act, 1884," His Excel-lency the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of the said colony, doth hereby make the following regulations for the Waitaki and Waimate Acclimatisation District, which comprises the Counties of Waitaki and Waimate, and the Boroughs of Hampden, Oamaru, and Waimate, and the waters thereof; and also the waters of the sea inside a line commencing from a point in the southern boundary-line of the County of Waitaki extended a quarter of a mile to the east-ward from low-water mark ordinary spring tides; thence fol-lowing the coast-line northerly at the same distance from low-water mark ordinary spring tides until it meets with the line of the northern boundary of the County of Waimate extended a quarter of a mile to the eastward beyond low-water mark ordinary spring tides: and doth hereby declare that these regulations shall, as from the date of the publication thereof in the New Zealand Gazette, supersede all regulations at variance therewith.

#### REGULATIONS.

1. LICENSES to fish for trout, perch, and tench in all the waters of the Waitaki and Waimate Acclimatisation District shall be issued under the hand of the Secretary of the United Council of the Counties of Waitaki and Waimate Acclima-tisation Society (hereinafter termed "the said Acclimatisation Society "), at Oamaru, and for every such license a fee of one pound will be charged: Provided, however, that licenses may be issued to youths under fifteen years of age on payment of a fee of ten shillings: Provided also that it shall not be obligatory upon the said Acclimatisation Society to issue a license. to issue a license :

2. Every such license shall entitle the person named therein to fish in any of the said waters from the first day of October in the year in which the license is issued to the Saturday after Easter Day in the year following, inclusive; but no such license shall confer any right of entry upon the

land of any person without his consert. 3. Every such license shall entitle the person named therein to fish with one rod and line only, and with the fol-lowing baits, namely: natural and artificial fly, natural and artificial minnow, silveries, bullies (*Electris gobioides*), grass-hompers, heatlog, middre, externiller, externation hoppers, beetles, spiders, caterpillars, creepers, grubs, and worms.

4. No person shall use any other bait, or any method, device, or contrivance of any sort (except a rod and line, and landing-net or gaff for fish taken with rod and line) whatever, for the purpose of fishing for, catching, killing, or taking

trout, perch, or tench. 5. No cross-line fishing, stroke-hauling, or any other un-sportsmanlike device shall be used for the purpose of catching, killing, or taking trout; nor shall any of the baits above mentioned be used with any medicated or chemical preparation whatever.

6. No person shall fish without a license, and every person fishing shall, on demand of any ranger, constable, member of the said Acclimatisation Society, or other person pro-ducing a license from such society, produce and show to such ranger, constable, member, or person his license, or the contents of his creel or bag, and the baits used by him for catching, killing, or taking trout, perch, or tench, as the case may be.

7. Every trout not exceeding eight inches in length from nose to tip of tail, taken or caught by any person, shall be immediately returned alive into the water from which the same is taken.

8. No person shall fish for, take, eatch, or kill, or attempt to fish for, take, catch, or kill, in any manner whatsoever, or have in his possession, any trout, perch, or tench, except under the authority of and during the currency of a license hereunder.

9. No person shall buy, sell, or expose or offer for sale, within the district to which these regulations relate, any of the salmonidæ or trout, or take, fish for, catch, or kill any of the salmonidæ or trout in order to make sale of the same, without permission in writing under the hand of the Secretary of the said Acclimatisation Society.

10. No person shall take, fish for, catch, or kill in any manner whatever, or have in his possession, any salmon, salmon-parr, or smolts, or the ova, young, or fry of any salmon in any stage whatever; and any of the above-named taken by accident or otherwise shall be immediately returned to the water from whence they were taken. 11. No person shall have in his possession any of the

salmonidæ, trout, or tench between the period from the Saturday after Easter Day and the thirtieth day of September in each year, which period is hereby appointed a close season for any such fish.

12. No person shall take, catch, or kill any perch under eight inches in length, nor shall perch be taken, caught, or killed at all, or had in possession of any person, between the thirty-first day of August and the thirty-first day of

December in any year. 13. No person shall put, throw, or place, or allow to be put, thrown, or placed, in any of the waters hereinbefore mentioned, any sawdust or sawmill refuse, dynamite, or anything of any kind or description whatever poisonous, deleterious, or noxious to fish.

14. No person shall net for salmon, salmonidæ, or trout in any of the lakes, rivers, streams, or creeks in the Waitaki and Waimate Acclimatisation District, or in the sea in the vicinity of any river, stream, or creek which is within the said district, except for scientific or piscicultural purposes, and then only by direction or permission of the Secretary to the said Acclimatisation Society.

15. No person shall use any net for the purpose of taking fish in the Waitaki River or its tributaries, or within a radius of one mile from the middle of such river, at the place where it flows into the sea at low-water ordinary spring-tides: Provided that this regulation shall not prohibit the use of a landing-net by a person duly licensed to take trout, perch, or tench with rod and line.

16. Any person netting for indigenous fish in any bay or harbour, or near the mouth of any river, stream, or creck, which is within the said acclimatisation district, shall immediately return into the water alive any salmon, salmonidæ, or trout which may be caught in their nets. This regulation shall not authorise the use of any net where prohibited by the foregoing regulation number fifteen.

17. No person shall use stake-nets in or near the mouth of any lake, river, stream, or creek in the said acclimatisation district.

18. Any person committing a breach of either or any of these regulations shall be liable to a penalty of not less than one pound and not exceeding fifty pounds.
