Revoking Order in Council prohibiting Export of Oysters.

GLASGOW, Governor.

ORDER IN COUNCIL.

At the Government House, at Wellington, this ninth day of August, 1892.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS an Order in Council prohibiting the exportation from the colony of all oysters known as *Ostrea purpurea*, *Ostrea glomerata*, *Ostrea mordax*, or rock oysters, shore oysters, drift or mangrove oysters, or by whatever name they may be locally known respectively, taken or produced in the waters of the colony, was made under the powers conferred by "The Fisheries Encouragement Act, 1885" (hereinafter termed "the said Act"), on the twenty-eighth day of June, one thousand eight hundred and ninety-two, and published in the *New Zealand Gazette* No. 52, of the thirtieth day of the same month:

And whereas it is desirable to revoke the said recited Order in Council:

Now, therefore, His Excellency the Earl of Glasgow, the Governor of the Colony of New Zealand, in exercise of the powers conferred by the said Act, and of all other powers enabling him in this behalf, and acting by and with the advice and consent of the Executive Council of the said colony, doth hereby revoke the said Order in Council of the twenty-eighth day of June, one thousand eight hundred and ninety-two, as from the date of the publication hereof in the *New Zealand Gazette*.
