GLASGOW, Governor.

I N exercise of the powers vested in me by "The Animals Protection Act, 1880," and the Acts amending the same, I, David, Earl of Glasgow, the Governor of the Colony of I, David, Earl of Glasgow, the Governor of the Colony of New Zealand, do hereby notify that cock pheasants and quail may be taken or killed within the Hawera District, consisting of the Counties of Hawera and Patea, from the first day of May, one thousand eight hundred and ninety-four, to the thirty-first day of July, one thousand eight hundred and ninety-four, both inclusive (subject nevertheless to the restrictions in the said Acts mentioned). And I do further notify that licenses to take or kill such game within further notify that licenses to take or kill such game within the said district shall be issued on payment of the sum of twenty shillings each, and that licenses to sell game and native game shall be issued on payment of the sum of five pounds each; and the Postmasters at Hawera and Patea are hereby appointed to sign and issue the said licenses.

REGULATIONS, additional to those of 3rd March, 1890, To respecting the employment of counsel and solicitors on behalf of the Government, &c., which have been approved by His Excellency the Governor in Council :-

Costs of Trials.

1. Nos. 38, 39, 41, and 51 of the said regulations are hereby revoked, and the following regulations are made in lieu thereof :-

In proceedings on trials of indictable offences, fees and costs to Crown Solicitors will be allowed as follows :-
