SCHEDULE.

FEILDING AND DISTRICT ACCLIMATISATION DISTRICT. ALL that area in the Wellington Land District bounded towards the north by the Kawhatau and Pourangaki Streams from the Rangitikei River to the summit of the Ruahine Range: thence towards the east generally by the summit of that range to the Manawatu Gorge, and by the
