REGULATIONS.

Any holder of a license as hereinater mentioned hay here for trout with one rod and line, and may use a landing-net to secure any trout caught with such rod and line, in the Feilding and District Acclimatisation District, and the waters thereof, from the first day of October in any one year to the last day of April in the following year, both inclusive. Such licenses will be issued under the hand of the Secretary of the Feilding and District Acclimatisation Society, and for every such license a fee of five shillings shall be charged: Provided that it shall not be obligatory upon the said Secre-tary to issue a license: Provided, further, that it shall be
