## SPECIAL NOTICE.

### Air Force Officer's Identity-card Stolen.

WELLINGTON.—On or about the 2nd instant, a Royal New Zealand Air Force Officer's identity-card, No. 1, was stolen from the headquarters of the Civil Aviation Department, Wellington. The card was in the name "Group Captain Wilkes," and dated "19th December, 1939." It is possible that some unauthorized person may use the card in an attempt to obtain privileges on trains or steamers, &c., and members of the Police Force are to be on the alert to recover it. ## PERSONS WANTED.

WHANGAREI.—5th instant, on **warrant** to apprehend for failing to comply with the terms of a maintenance order for the support of his children, **Henry Brady**, referred to in Police Gazette, 1939, page 763. Arrears to 1st ultimo, £91 5s. 6d. He usually works for the Public Works Department, and he is fond of drink.

WHARF (WELLINGTON).—27th ultimo, on **warrant** for deserting from the ship "Ruahine"—(1) **J. Doyle**, cook and baker. (2) **A. Moore**, fireman, height 5 ft. 5 in., freckled complexion, auburn hair, strong build.

AUCKLAND.—8th ultimo, on **warrant** for theft of a one-hundred franc gold piece and an engagement ring (recovered), total value £10, the property of Samuel Octavis Dixon, 66 Vincent Street, **Thomas George Patoman**, referred to in Police Gazette, 1938, page 835. Accused stayed at No. 66 Vincent Street from the 5th to the 8th ultimo. He was interviewed at Papakura Military Camp and admitted the offence, but before being brought before the Magistrates' Court by the Military Authorities he disappeared from the camp. His photograph is filed.

OTAHUHU.—22nd ultimo, on **warrant** of commitment to Auckland Prison for three months in default of paying £10 fine for theft, **Kenneth William Mailman**, alias **William Kenneth Mailman**, age twenty-six, height 5 ft. 1½ in., labourer, native of New Zealand, good build, fair complexion and hair, grey eyes. He was dressed in a blue suit, brown hat, and brown check overcoat. Accused advertised in the "New Zealand Herald" (Auckland), for a housekeeper for his sheep-station in Hawke's Bay. Josephine Florence Logan replied to the advertisement and accepted the position. Accused then borrowed £6 from her at Frankton to pay their train fares. At Hastings she disappeared, leaving complainant and her two young children destitute.
