QUEEN STREET WHARF (AUCKLAND).—22nd January last, on warrant for unlawfully landing in New Zealand being prohibited immigrants—(1) **Karl Bertil Johansson**, age twenty-five, height 5 ft. 8 in., ship's motorman, native of Sweden, medium build, pale complexion, fair hair, blue eyes, full face; dressed in a suit of very light material; speaks very little English; he has venereal disease. (2) **Johan Edvard Eriksson**, age fifty-four, height 5 ft. 8 in., ship's motorman, native of Sweden, thin build, medium complexion, grey hair; dressed in a grey suit; speaks good English. Both men have passports. They deserted from the Swedish ship "Pan Gothia."

Another similar theft was committed on Patrick Henehan, Onehunga, and it is considered that the same man committed all the offences. **No warrant.**
