Service of Jury Summonses

In order to obviate the necessity for the attendance at the opening of Supreme Court sessions of all members of the Force who have served jury summonses, it has been arranged with the approval of the Chief Justice, after consultation with the other Judges, that the following practice shall be adopted:—

"Serving officers (of jury summonses) need not attend at the opening of the sitting unless any of them have to be present as witnesses or orderlies; and, if any person summoned as a juror fails to attend when called in the morning at the opening of the sitting, the Court will postpone dealing with him till the afternoon, when the serving officer will be required to attend and prove service, and the Court can then proceed to deal with the missing juror as it thinks proper. It must of course be distinctly understood that an Inspector, or Sergeant, or some other responsible police officer is present in Court at the opening of the sitting, as is the practice at present, with a list of jurors summoned and of the constables who served them, and the onus will be on the police and not on the officers of the Court to see that any serving officer whose attendance is required is present in Court at the beginning of the afternoon sitting."
