MELBOURNE (VICTORIA).—**Leslie Eugene Francis Xavier Brown** and **Cecil Bobbs** (see Police Gazette, 1943, page 770): On 26th October last, a **warrant** of apprehension and commitment was issued for **Leslie Brown** by Arthur Coyte Tingate, Police Magistrate and Coroner, charging him with the murder of Pearl Lillian Oliver. Brown is not likely to live alone, but may seek the company of any prostitute. It is believed that Bobbs drove Brown and another man to the scene of the crime, and kept the car ready for them to make a getaway. A car formerly owned by Brown has been recovered.
