PERSONS WANTED

AUCKLAND.—5th October last, on **warrant** for a breach of his probation (Offenders Probation Act, 1920), **Alfred William Mullins**, referred to in Police Gazette, 1943, page 401, and Photographs, 1936, page 25. He has failed to report to a Probation Officer.

AUCKLAND.—17th ultimo, on **warrant** of commitment to Auckland Prison for three months in default of paying £8 10s. arrears on a maintenance order for the support of his child, **Mervyn James Roland Valliley**, referred to in Police Gazette, 1944, page 195, and Photographs, 1939, page 66.
