## NEW ZEALAND POLICE GAZETTE.

#### Offences not otherwise Described.

AUCKLAND .- George Edgecombe and Co., shipping agents, Queen Street, report that on the 24th ultimo the cabin of the soow "Herald" was broken into, a tin of kerosene upset on the bunks, and some of the blankets, the property of the crew, set on fire and destroyed.

WAIHI.—John Delaney and Thomas Radford are charged on warrant with false pretences on J. E. Taylor, storekeeper, on or about the 8th ultimo. Description: First, a native of New Zealand, a jockey, twenty-two years of age, 5 ft. 23 in. high, fair complexion, light-brown hair, hazel eyes, thick-set build, mole on left nostril, rather bow-legged (see *Police Gazette*, 1898, page 125). Second, a painter, twenty-one years of age, 5 ft. 6 in. high, dark com-plexion and hair, small dark moustache only; dressed in dark soft-felt hat.
