

NEW PLYMOUTH.—17th December last, on warrant of commitment to New Plymouth Prison for forty-eight hours in default of paying 18s. medical costs for drunkenness, **James Bailey**, age thirty-four, height 5 ft. 6 in., labourer, native of New Zealand, medium build, fresh complexion, light-brown hair, brown eyes, medium nose.
