(From Gazette, 1910, page 780.) Extending the Close Season for Seals.

### PLUNKET, Governor.

### ORDER IN COUNCIL.

At the Government House, at Wellington, this fifth day of March, 1910.

Present :

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

W HEREAS by "The Fisheries Act, 1908" (herein-after termed "the said Act"), it is, among other things, enacted that the Governor in Council may from time to time make regulations (which shall have general force and effect throughout the Dominion, or particular force and effect only in any waters and places specified therein) for prescribing, among other things, a close season for seals, and for extending any close season so prescribed :

And whereas it is further provided by the said Act that every person who, during any close season for seals, takes any seals is liable for every such offence to a penalty not exceeding five hundred pounds, and in addition thereto is liable to a further penalty not exceeding twenty pounds in respect of every seal so taken : And whereas by Order in Council dated the twenty-first

day of December, one thousand eight hundred and ninety-lour, the months of January, February, March, April, May, and June, one thousand eight hundred and ninety-five, were prescribed a close season for seals :

And whereas by Order in Council dated the tenth day of May, one thousand nine hundred and nine, the said close season for seals was extended to the thirtieth day of June, one thousand nine hundred and ten :

And whereas it is desirable to further extend such close season :

season: Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers conferred by the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the regulation set forth in the Schedule hereto; and, with the like advice and consent, doth order that such regulation shall have force and effect throughout the Dominion of New Zealand, and in all salt, fresh, and brackish waters of the Dominion, and on all shores of such waters or any part thereof. and on all shores of such waters or any part thereof.

## SCHEDULE.

### REGULATION.

THE close season for seals prescribed by regulations made by Order in Council dated the 21st day of December, 1894, and published in the *New Zealand Gazette* No. 1, of the 4th day of January, 1895, and which was extended as hereinbefore recited, is hereby further extended up to the 30th day of June, 1911.
