PERSONS WANTED.

AUCKLAND.—February last, that she may be compelled to support her son at Weraroa Training Farm, **Maggie Wade Campbell**, *alias* **Martin**, age thirty-five, height 5 ft. 7 in., half-caste Maori, slight build, dark complexion and hair, brown eyes, good teeth; has a good knowledge of the English language. She was last heard of at Raglan, in February last, at which time she was living with a half-caste Maori named Martin. Inquiry is at the instance of the Education Department.
