When notifying the arrest of persons charged with theft or suspected of theft, it should be stated whether the property stolen, or any portion of it, has been recovered.

A description of property supposed to be stolen, found in the possession of offenders, for which owners cannot be found, shall be furnished for insertion in the *Gazette*.

PERSONS WANTED.

AUCKLAND.—3rd July last, on **warrant** of commitment to Auckland Prison for seven days in default of paying £1 5s. costs for a breach of the City By-laws, **Charles Fitzpatrick Lindsay**, age thirty-nine, height 5 ft. 9½ in., labourer, native of New Zealand, medium build, fresh complexion, light brown curly hair, blue eyes. He was fined £1 19s., and paid £1, which, with costs added now leaves a balance due of £1 5s.

AUCKLAND.—3rd ultimo, on **warrant** of commitment to Auckland Prison for seven days in default of paying £2 8s. fine and costs for a breach of his prohibition order, **Michael Martin**, age thirty-one, height 5 ft. 6 in., tailor, native of New Zealand, medium build, fresh complexion, brown eyes, dark curly hair.
