

The arrest of offenders described in the *Police Gazette*, or respecting whom crime reports have been forwarded for insertion in the *Gazette*, should be promptly notified by the member of the Force effecting the arrest.

When notifying the arrest of persons charged with theft or suspected of theft, it should be stated whether the property stolen, or any portion of it, has been recovered.

A description of property supposed to be stolen, found in the possession of offenders, for which owners cannot be found, shall be furnished for insertion in the *Gazette*.

AUCKLAND.—20th Joly last, on warrant for failing to provide for the maintenance of his illegitimate child, **Robert McPherson**, age thirty, height 5 ft. 6 in. or 7 in., strong build, fresh complexion, dark hair, brown eyes, fair moustache, prominent features, good set of teeth. He recently resided at Queenstown.
