

DANNEVIRKE.—16th instant, that she may be compelled to pay £23 16s. arrears due for maintenance of her child in the industrial school, **Mary Taylor**, age thirty-seven, height 5 ft. 4 in., domestic, native of New Zealand, dark complexion and hair, blue eyes, straight nose, weak eyes (wears blue glasses), small scar on right little finger and right shin.
