## LAW REPORTS.

[K.B. DIV. — (RIDLEY, AVORY, AND LUSH, JJ.) — 24TH NOVEMBER, 1914.]

BRISTOW v. PIPER.

Licensing—Purchase of Liquor—Arrangement to leave in Yard—Liquor fetched away in Prohibited Hours—Licensing (Consolidation) Act, 1910 (10 Edw. VII and 1 Geo. V, c. 24), s. 61 (1).

The respondent was a licensed publican, and on a certain evening, at an hour when the respondent's premises were lawfully open, one B left with him a bottle, asking him to fill it with beer and to place it in the yard where B could get it the next morning before the house was opened. At the same time B paid for the beer. The respondent filled the bottle with beer and left it in the yard, and B took it away in the morning during prohibited hours. The yard was within the curtilage of the licensed premises. The respondent was summoned under section 61 (1) of the Licensing (Consolidation) Act, 1910, for opening his premises for the sale of liquor during prohibited hours, and the Justices dismissed the summons.

Held (Avory, J., dissenting), That as it was an express term of the contract that the bottle was to be put in the yard overnight at the buyer's risk, delivery was made overnight and no part of the transaction was left to be completed later, and therefore the Justices' decision must be affirmed.

This was a special case stated by Magistrates of Sussex.

Mr. George Elliott, K.C., and Mr. Flowers appeared for
the appellant, and Mr. du Parcq appeared for the respondent.

The respondent was the licensee of a publichouse at Midthe respondent was the heenses of a publichouse at Mid-hurst. On the evening of 24th May, 1914, at a time when the premises were lawfully open, a man named Brider called at the publichouse with a quart bottle, which he left with the respondent, asking him to fill it with beer and to place it in the stable-yard in a position where he, Brider, could call for it on his way to work early in the morning before the house was opened. The respondent accordingly filled the bottle with beer and left it in the stable-yard as requested, and Brider took it away in the morning.

The stable-yard was within the curtilage of the licensed

Mr. George Elliott said that the appellant was the chief constable of the district, and had summoned the respondent under section 61 (1) of the Licensing (Consolidation) Act, 1910, for opening his premises for the sale of beer during prohibited hours. The Justices were of opinion that it was doubtful whether the sale and delivery was not complete on the night of 24th May, and they dismissed the information.
